# **ELECTION DAY 2022**

### PRIMARY INFORMATION

On Tuesday, August 2, 2022, a State Primary has been scheduled in Michigan for the purpose of nominating candidates to federal, state and local offices. Precinct Delegates to the Wayne County Convention and a Wayne County proposal will also appear on the ballot. Please use the Sample Ballot inside this newsletter to familiarize yourself with who and what you will be voting for.

#### **REDISTRICTING AND YOU**

The 2020 Census reported that Detroit now has 639,111 residents residing within its borders. Consequently, all legislative offices representing Detroit district boundary lines were adjusted to reflect the change in population. Prior to redistricting, Detroit had 503 voting precincts. Beginning with the August 2nd Primary, there will be 450 voting precincts in Detroit.

By now, every Detroit elector should have received a new voter identification card to reflect all legislative changes. Also, some voters may experience precinct and polling location changes. As such, please pay close attention to all of the information on your new voter identification card.

Finally, your new voter identification card includes the following legislative districts: US Congress, State Senate, State House of Representatives, Wayne County Commissioners, Wayne County Community College Trustees, Detroit City Council and Detroit Board of Police Commissioners.

As a reminder, please refer to the back page of this newsletter to review your legislative districts that you will be voting in for the Primary.

### **ELECTION UPDATE**

During last year's Municipal Election cycle, the Detroit Department of Elections made tremendous strides in improving Election Day operations. During the canvassing of election returns, the Wayne County Board of Canvassers reported that all of Detroit's 120 absentee counting boards balanced and nearly 95% of the precincts balanced.

"I... want to thank you guys for all the huge, huge improvements," said Monica Palmer, the Republican chair of the board. "Hats off to all."

This year the Department will continue to work to improve our efforts to ensure that the democratic process is an operation all Detroiters can be proud of.
