3 About 6:40 p.m.

4 CHAIRPERSON TAYLOR: Good evening, ladies and
5 gentlemen, and welcome to the Board of Police
6 Commissioners Meeting. My name is Jessica Taylor. And
7 my colleague, Commissioner Warfield, will be joining me
8 shortly, and I believe that Commissioner White will not
9 be here tonight. But we will proceed.

10 I would like to ask George, would you
11 introduce -- oh, this is the Chief. I want to
12 introduce the Chief of Police, Chief James Craig is
13 here with us, and he is doing a fine job.

14 CHIEF OF POLICE CRAIG: Thank you.

15 CHAIRPERSON TAYLOR: And we want to let you
16 know we are behind you 100 percent.

17 CHIEF OF POLICE CRAIG: Thank you.
18 Appreciate it.

19 SECRETARY ANTHONY: For the record, George
20 Anthony, Secretary to the Board. We have present
21 Ms. Pamela Davis-Drake, our Chief Investigator seated
22 in the front. Seated next to her is Ms. Lolitha
23 Porter-Coleman, our Director of Police Personnel. Our
24 recorders today include Officer Kent Cooper, Sergeant
25 Alan Quinn, and Ms. Rhonda Foster from Hanson Court

1 Reporting Service. And that completes the
2 introductions.

3 CHAIRPERSON TAYLOR: Can we have Chaplain
4 Powell here today, come up and give us a word of
5 prayer?

6 CHAPLAIN POWELL: All right, everyone. Let's
7 look to the Lord.

8 Lord God of Grace, in the name of Jesus, we
9 thank you, Lord, for your keeping power and your
10 blessing power. How you have blessed us, Lord God,
11 throughout this great day.

12 Lord, as we draw our minds together, we ask
13 you, oh God, to help us to come with one mind, and that
14 is to make your city safe and great again.

15 Lord, I ask you just to bless and strengthen
16 us. Give us that that we need. Teach us to love one
17 another, Lord God, and protect us, Lord.

18 Lord, rebuke the powers of darkness and let
19 your blessings be upon us.

20 Bless each and every one of us. Help us,
21 Lord God, to love one another and help us to serve one
22 another. Help us to do your blessed will.

23 Look down upon, Lord God, this Commission.
24 Look down upon our Chief. Look down upon our officers.
25 Protect them, Lord, as they protect us. Let your

1 blessings be upon them, Lord God, and strengthen them.

2 In Jesus' name. Amen.

3 AUDIENCE: Amen.

4 CHAIRPERSON TAYLOR: We are happy to be here
5 at Focus: HOPE this evening. Is there anyone here, a
6 representative from Focus: HOPE? If you would like
7 to -- can you come up, sir, and say a few words?

8 I am sorry, before we do that, I would like
9 to say Commissioner Warfield has joined us here.

10 Go ahead, sir.

11 MR. JONES: Excuse me, I wasn't planning to
12 speak, but Commissioners, and Police Chief Craig,
13 delighted to have you here. The Commission has been
14 here before. Chief Craig, this is your first time.

15 CHIEF OF POLICE CRAIG: Yes.

16 MR. JONES: We at Focus: HOPE are committed
17 to this community. We love it. We embrace it. We
18 endorse all of your efforts to make our citizens safe,
19 to help us in the restoration of this city to what it
20 once was and what it will be in the future. So thank
21 you very much for having this meeting, and I will get
22 out of your way.

23 CHAIRPERSON TAYLOR: And your name, sir?

24 MR. JONES: My name is William Jones. I am
25 the CEO of Focus: HOPE.

1 CHAIRPERSON TAYLOR: Thank you.

2 Commissioner Warfield, can you read the
3 duties and responsibilities of the Board?

4 COMMISSIONER WARFIELD: Sure. Thank you,
5 Madam Chair.

6 The Board of Police Commissioners was created
7 by the Charter on July the 1st, 1974.

8 We are a five-member Board, soon to be an
9 11-member Board. All five of us now are appointed by
10 the Mayor. In the new iteration of the Board, four
11 will be appointed by the Mayor, and seven will be
12 elected by districts.

13 Commissioners that are appointed by the Mayor
14 serve a five-year term, while those that are elected
15 will serve a four-year elected term. We might not
16 serve more than five years consecutively, those who are
17 appointed.

18 We meet once a week throughout the course of
19 the year, with the exception of the week of
20 Thanksgiving, Christmas, and the New Year's holiday.

21 All of our meetings are open to the public.

22 Our duty primarily is to establish policy and
23 regulations in consultation with the Mayor, in addition
24 with the Chief of Police.

25 We review and we approve the Department's

1 budget. We review and approve the Department's
2 promotions. We receive and resolve complaints
3 concerning the operations of the Police Department. We
4 also act as the final authority to impose and review
5 discipline of Police Department employees. We also
6 appoint a civilian Personnel Director who prepares an
7 annual report of the Department activities for the
8 public, for the Mayor, and for the City Council.

9 Our staff, as you have already been
10 introduced to, includes our Executive Secretary who
11 serves as Secretary to the Board and attends all Board
12 meetings, our Chief Investigator, and additional
13 investigators, other staff as necessary to provide
14 support for the Board.

15 The Police Commission considers itself as a
16 liaison between the citizens of the City of Detroit and
17 the Detroit Police Department.

18 Thank you, ma'am.

19 CHAIRPERSON TAYLOR: Thank you. I am going
20 to forego my report this evening.

21 And I would like Chief, do you have a report.

22 CHIEF OF POLICE CRAIG: Yes, ma'am, Madam
23 Chair.

24 First of all, I just want to start out by
25 saying how excited I am to be home in the city of

1 Detroit doing what I most passionate about, policing.
2 Now I am in my 36th year.

3 But what I wanted to do, we have some
4 officers here present who work number 10 who are in the
5 field working. But we wanted to make a special
6 presentation so they can go back to work. So I ask
7 before I make some comments, we have got to handle the
8 business. Right. We have got shootings, and certainly
9 they want to get back out in the field. So with that,
10 I would ask Lieutenant Mahone to come up so we can make
11 the presentation.

12 LIEUTENANT MAHONE: Thank you, Chief, Board.

13 The officers we are about to recognize were
14 instrumental in identifying and arresting a group of
15 young males and females that went on a short crime
16 spree here in the city of Detroit. And trust me, a lot
17 of us are a lot safer today because of the work of the
18 men and women we are about to recognize.

19 Hey, officers, can you come up here, please?
20 Chief, if you could, could you stand over here?

21 CHIEF OF POLICE CRAIG: Okay. Are we going
22 to talk about what the event was? Because I think you
23 will be quite interested to know about the crime spree
24 that we are acknowledging these officers for.

25 (Applause).

1 CHIEF OF POLICE CRAIG: The event was a
2 series of carjackings that actually started here in the
3 10th Precinct, so it was through their diligence and
4 commitment to duty that arrests were made.

5 LIEUTENANT MAHONE: Yes, this was a week-long
6 crime spree. And again, it went all over the city of
7 Detroit. So far, we have identified approximately 35
8 people from the I.D.s that were found in the location
9 that the men and women here identified. What these
10 officers did was they stood out in the rain for like
11 three hours until we were able to get in that house and
12 make those arrests. We ended up locking up seven
13 individuals. And I can say that the week previous to
14 this, we had about ten robberies in number 10. Last
15 week, we had a total of five. And four of those were
16 unarmed robberies. And the one armed robbery, the
17 officers in number 10 actually got that custody also.
18 So they are doing a great job and I just want to see
19 them acknowledged.

20 (Applause).

21 LIEUTENANT MAHONE: This is Officer Aaron
22 Earl (phonetic). Officer Kenneth Johnson. That's a
23 good officer there, sir. Officer Sara Johnson.
24 Officer Daryl Barlow (phonetic). Officer Alexander
25 Ross. Officer Mark Stablink (phonetic). Officer

1 Christopher Townsend. Officer Marcus Wayes (phonetic).
2 And Officer Jonathan Williams.

3 (Applause).

4 CHIEF OF POLICE CRAIG: Now recognize this
5 was on my first evening, actually it was my first
6 evening, I had a chance to visit number 10, certainly a
7 precinct that I started and finished my very brief
8 career here in Detroit. And then I got out in the
9 field and the officers were engaged in this great
10 police work.

11 One thing you will hear me continue to say,
12 that cops count and leadership matters. And they count
13 because these are the heroes that need the credit. And
14 so I will continue to beat that drum about the work
15 that they do every day.

16 And so with that, I will talk a little bit
17 about crime because one of the things you will hear me
18 talk about first and foremost, violence in our city.
19 Two of my goals is to, one, reduce violence in the
20 city of Detroit. But also raise officer morale.

21 So the little things we can do is at least
22 acknowledge them for a job well done. And so I feel
23 good about doing that today, especially to a group of
24 fine officers who work at a precinct that I call home.

25 We look at our homicides year-to-date 2013,

1 we are sitting at 163 homicides, which compared to last
2 year, we were at 175, we are down 12, which is a 6.8
3 reduction.

4 In terms of nonfatal shootings, year-to-date,
5 we are sitting at 595, as compared to last year, 601,
6 which we are just down just shy of a percent. That's
7 still too many.

8 I will tell you that my commitment and
9 expectation as we roll out some of our crime fighting
10 strategies, particularly the Compstat process, that we
11 will reduce that number even more. This is too much
12 for any city, too much for Detroit. And certainly,
13 when we talk about a crime like carjacking, that's the
14 kind of crime that, you know, even before I got here,
15 and I started reviewing the notifications that came in,
16 it shocked me there were so many incidents involving
17 carjackings. But not just carjackings, taking the
18 vehicle, but the shootings that accompany this violent
19 crime.

20 So we are going to work real hard to make
21 this a safer city, at least one of the safest major
22 cities in America, it is going to happen. But we can't
23 do it alone. So we are going to ask for your help.
24 And evidence of that is by you being here tonight and
25 participating is important.

1 So that concludes my brief remarks. I just
2 wanted to make sure that we acknowledged the officers
3 for a job well done.

4 CHAIRPERSON TAYLOR: Yes, sir.

5 At this time, we will do new business.

6 (Discussion off the record).

7 CHIEF OF POLICE CRAIG: Lieutenant Mahone,
8 are you going to make the presentation on the --

9 (Discussion off the record).

10 LIEUTENANT MAHONE: Chief Craig, honorable
11 Board members, I am Lieutenant Charles Mahone, and I am
12 Commanding Officer of the 10th precinct.

13 (Applause).

14 LIEUTENANT MAHONE: I work for James
15 Suchoski. James Suchoski is commander of both the 10th
16 and 12th precinct. The 10th precinct, located at
17 12000 Livernois, encompasses approximately 12 square
18 miles. Our borders for 10th precinct on the north is
19 Lyndon; on the south, you have West Warren; on the East
20 you have the Lodge Freeway; and on the west you have
21 the Jeffries Expressway. We have about 12 community
22 groups that we work with on a daily basis, myself and
23 Officers Tabb and Brown who put this together tonight.
24 And I don't know where they are at, but thank you.

25 (Applause).

1 LIEUTENANT MAHONE: So far this year, with
2 our community groups, we have held a candlelight vigil,
3 we have conducted clothing drives, we had a spring
4 cleanup where we cleaned up at and around the precinct,
5 planted flowers, and we also have our most popular
6 event, which is Senior Movie Days. Every second
7 Wednesday of the month, Officers Tabb and Brown, they
8 shuttle our senior citizens who do not have
9 transportation from the 10th Precinct to the Bel-Air
10 Shopping Center. We are allowed to have fun and
11 fellowship and just watch first run movies. It is a
12 great time held by all.

13 Future events for number 10, on July 19th, we
14 have a crime walk scheduled. On August 6th, we have
15 our National Night Out. I hope to see everyone there.
16 Last year we had about 500 participants. It was a
17 great time. We close the street down and we just have
18 a party. We do everything that is family-related for
19 the neighborhood. It is just a great time.

20 And number 10, we are also crime fighters,
21 and when we are not answering approximately 400 police
22 runs a week, we use a B and E task force. We conduct
23 warrant sweeps. We conduct ticket and tow operations.
24 And we also have prostitute stings that we run. And I
25 am happy to report that the last prostitute sting which

1 took place last night, we arrested nine individuals,
2 and forfeited eight vehicles. And I really believe in
3 the prostitute stings because it helps keep down crime,
4 as well as the ticket and tow operations.

5 I hope that you find this report concise and
6 informative.

7 Any questions from the Board?

8 COMMISSIONER WARFIELD: Thank you,
9 Lieutenant. And thank you for being here tonight.
10 Thank you for the hard work certainly that you do in
11 the 10th precinct.

12 As it relates to the prostitution stings --

13 LIEUTENANT MAHONE: Yes.

14 COMMISSIONER WARFIELD: -- are you working
15 with the drug court and Judge Leonia Lloyd, in
16 conjunction with her? Because as you may or may not
17 know, she has a very aggressive way of trying to help
18 those, especially young ladies, who are caught up in
19 that line of, I guess you would say work, in order to
20 get their lives back on track again. Not only do we
21 pick them up from the street, but she gives them the
22 option of being able to either get clean or do a very
23 long jail time. So are you working with her?

24 LIEUTENANT MAHONE: I am aware of that
25 program, but I am not working with her. We are not

1 targeting the prostitutes. We actually target the
2 johns.

3 COMMISSIONER WARFIELD: So when you are
4 targeting the johns, are you also arresting the ladies,
5 or is it a sting operation where it is not -- where
6 they are undercover cops that's doing it?

7 LIEUTENANT MAHONE: Exactly.

8 COMMISSIONER WARFIELD: Okay.

9 LIEUTENANT MAHONE: There's undercover cops
10 involved. We are not targeting the prostitutes. We
11 are just not, sir.

12 COMMISSIONER WARFIELD: Okay. No problem. I
13 understand.

14 Then the other question is, from a
15 statistical standpoint, if you have any just rough
16 statistics about those individuals who are caught up in
17 these stings that are from the city of Detroit versus
18 those who are outside of the city?

19 LIEUTENANT MAHONE: No, I don't.

20 COMMISSIONER WARFIELD: Okay. If you can go
21 back and give that -- give us that information, it
22 would be very helpful to us.

23 LIEUTENANT MAHONE: Yes, I can get that and
24 supply it to you.

25 COMMISSIONER WARFIELD: Great. Thank you,

1 sir. I appreciate it.

2 LIEUTENANT MAHONE: You are welcome.

3 CHAIRPERSON TAYLOR: This is our highlight of
4 our meeting. We have come to this part where we are
5 going to honor one of the people that works here in the
6 city, one of the community people here.

7 And Commissioner Warfield, will you please
8 read this resolution for Mr. -- I don't want to kill
9 his name, but N-r-e-c, is that any Nrec?

10 MRS. MERDITAJ: Yes.

11 CHAIRPERSON TAYLOR: Nrec Merditaj.

12 MRS. MERDITAJ: Yes.

13 COMMISSIONER WARFIELD: Will you come up if
14 you are here?

15 MRS. MERDITAJ: Well, I am here in his place.
16 I am his wife.

17 COMMISSIONER WARFIELD: Give her a hand.

18 (Applause).

19 COMMISSIONER WARFIELD: This is
20 Mr. Merditaj's wife Gina.

21 MRS. MERDITAJ: Yes.

22 COMMISSIONER WARFIELD: And this is a
23 resolution honoring Nrec Merditaj, owner and operator
24 of A-Eagles Coney Island.

25 Mr. Nrec Merditaj, affectionately known

1 throughout the community as Nick, has successfully
2 owned and operated A-Eagles Coney Island at 9122 Dexter
3 Avenue in the 10th Precinct since 1989; and

4 Whereas, Mr. Merditaj is an experienced
5 businessman and devoted husband and father, he has been
6 married to his wife Gina for 23 years, and together,
7 they have three children, two boys, and one girl, and
8 two grandchildren.

9 MRS. MERDITAJ: No grandchildren.

10 COMMISSIONER WARFIELD: And no grandchildren.

11 I am either reading the record or
12 prophesying, one of the two.

13 MRS. MERDITAJ: No, no. My oldest is 19. It
14 is not happening. We have college plans.

15 COMMISSIONER WARFIELD: All right. We will
16 fix that one.

17 Whereas, Mr. Merditaj was not born in the
18 United States, but his story of personal struggle to
19 overcome adversity adds to the resilience and strength
20 of this community.

21 Unable to survive in Kosovo with his family
22 at the age of 16, Mr. Merditaj traveled for several
23 weeks and through seven countries until he finally
24 settled in Detroit, Michigan, securing his freedom from
25 the war torn country of his homeland; and

1 Whereas, A-Eagles Coney Island has been a
2 tremendous asset to the 10th Precinct, and the entire
3 city of Detroit, since its opening, Mr. Merditaj has
4 taken steps to ensure that his business remained
5 committed to assisting citizens of the 10th Precinct
6 and other neighboring communities.

7 A-Eagles Coney Island has been instrumental
8 in donating over 800 turkeys, bikes, toys, and clothing
9 to numerous families and community organizations; and

10 Whereas, Mr. Merditaj has shown great pride
11 and ownership within the 10th Precinct by providing
12 leadership and employment opportunities for citizens
13 residing in the neighborhood; and

14 Whereas, A-Eagles Coney Island has
15 participated in various community activities, not only
16 in the Eastern District, but also in other communities.
17 To remain abreast of city issues, Mr. Merditaj
18 faithfully attends the 10th Precinct's Community
19 Relations Council Meetings, and takes pride in the
20 beautification of the 10th Precinct, and actively
21 participates in National Night Out, Motor City
22 Makeover, Angels Night, and National Police Week
23 community cleanup efforts; and

24 Whereas, Mr. Merditaj and A-Eagles Coney
25 Island have exemplified true spirit, selfless giving to

1 the citizens of Detroit, Mr. Merditaj's commitment to
2 business ownership in the city of Detroit,
3 volunteerism, and bringing wholeness to the community
4 has been a rock that has benefited many. The
5 establishment of his company indicates Mr. Merditaj's
6 dedication to improving the quality for all citizens
7 and commitment to the continued growth and
8 revitalization of Detroit. Mr. Merditaj's life motto
9 is simple. If you can do something to change the
10 world, you should.

11 Now, therefore, be it resolved that the
12 Detroit Board of Police Commissioners, speaking for the
13 citizens of the City of Detroit and the Detroit Police
14 Department recognizes and acknowledges the dedication
15 and generosity of Mr. Nrec Merditaj and A-Eagles Coney
16 Island. Mr. Merditaj's commitment to serving the
17 citizens of Detroit, we thank you and congratulate you.

18 This is going -- this is from the Detroit
19 Board of Police Commissioners and is signed by all four
20 members.

21 (Applause).

22 COMMISSIONER WARFIELD: We have something
23 from the Chief.

24 CHIEF OF POLICE CRAIG: On behalf of the City
25 Council, dated July 11th, we present you the Spirit of

1 Detroit Award.

2 MRS. MERDITAJ: Thank you so much.

3 CHAIRPERSON TAYLOR: We have got one more.

4 CHIEF OF POLICE CRAIG: And on behalf of the
5 Detroit Police Department.

6 MRS. MERDITAJ: No grandchildren.

7 CHIEF OF POLICE CRAIG: No grandchildren.

8 Certificate of recognition on behalf of the
9 Detroit Police Department.

10 MRS. MERDITAJ: Thank you so much. Thank
11 you. I appreciate it. Thank you. Thank you.

12 I am sorry he couldn't be here. I want to
13 thank you all for everything on his behalf. He wasn't
14 feeling well. But -- so my son Junior, Nick, Junior
15 and I came on his behalf.

16 Nick didn't -- you know, he wasn't born
17 in Detroit, but he did -- he was raised here, and I was
18 raised here. And it is a part of our family. And we
19 want it to be a part of our children's lives and have,
20 you know, pass it on to them. Like Nick says, if you
21 think you can do it, then you can do it. You can. It
22 doesn't matter what obstacles or what is thrown in your
23 way. If there is a will, there is a way. There is a
24 way. And we as a community have to stand together, you
25 know, for the citizens. I remember growing up in

1 Detroit, this is the best. I mean, it was the best.
2 And I feel like it can be that again. It is the best
3 and it can be the best.

4 Thank you.

5 (Applause).

6 MR. STOKES: My name is Alvin Stokes. I am
7 the Chairman of the 10th Precinct Community Relations,
8 and this coney island here has been very instrumental
9 in the 10th Precinct. I will tell you how I ran across
10 it. Before Williams left, we went by there planning
11 for a cleanup. They had already done it. They had
12 already planned for the cleanup to go from Linwood to
13 Joy Road, down Joy Road from Linwood to Grand River,
14 and from -- down Dexter from Joy Road all the way down
15 to St. Paul. They were very instrumental. And we
16 didn't ask them for anything. They give away the
17 turkeys. We didn't ask for it. We went to them for a
18 donation. They had already started an organization
19 with the business owners, within their community,
20 within their boundaries. And they are very
21 instrumental in the 10th. We need more businesses like
22 it. And I want to thank you personally.

23 MRS. MERDITAJ: Thank you.

24 CHAIRPERSON TAYLOR: Thank you. And we will
25 get this corrected and give it to you.

1 MRS. MERDITAJ: Just take grandchildren off.

2 CHAIRPERSON TAYLOR: Did you say where they
3 are located?

4 MRS. MERDITAJ: On Joy Road and Dexter.

5 CHAIRPERSON TAYLOR: We will vote on these
6 next week, Commissioner.

7 Well, our next meeting will be Thursday,
8 July 18, 2013, at 3:00. And that will be at the
9 Detroit Public Safety Headquarters, at 1301 Third
10 Avenue in the Media Room, and that's, of course, in
11 Detroit, our new Headquarters.

12 And at this time now I will have the oral
13 communications from the audience.

14 Is there anyone that would like to address
15 the Board?

16 MS. MCCANTS: Good afternoon. My name is
17 Yolanda McCants. And I am here from the Northeastern
18 District. I am here because I have some great
19 concerns.

20 My son's car has been destroyed twice. Once
21 it was parked on the street, they took all four tires.
22 He put it in the shop, got it back, had it three days,
23 they took the car from the driveway this time.

24 This vehicle he drives, it is a company's
25 car. And when he called 911, like he did the previous

1 time, they refused to take his report over the phone,
2 the 267 number.

3 Now, I have been here long enough to know we
4 done went from 911, to going into precincts, to how we
5 handle our business. I want to know that -- what are
6 we, as citizens, going to do if the people that we are
7 told to call will not answer the -- or do the
8 information that they are supposed to? He is supposed
9 to make a report over the phone. She refused to make
10 the report. She told him to go to the precinct. We go
11 to the precinct, they say call 267. There has to be
12 some way somehow for us to have some type of
13 uniformity. We are either going to use that 267
14 number, or we are not going to use that 267 number. We
15 are either going to use 911 or we are not going to use
16 911. Now, this is a company's car, they are
17 complaining now because in a month's time, this vehicle
18 has been destroyed, and he is having problems making a
19 police report.

20 CHAIRPERSON TAYLOR: Okay. Chief, would you
21 like to comment on that?

22 CHIEF OF POLICE CRAIG: I am going to have
23 Commander Bettison who works our communications
24 section.

25 CHAIRPERSON TAYLOR: And Ms. McCants, we will

1 also have the Chief Investigator, our Chief
2 investigator look into that.

3 MS. MCCANTS: Okay.

4 COMMANDER BETTISON: What she said is
5 correct.

6 Commander Todd Bettison.

7 What she said is correct. That's a policy
8 issue, as far as telephone crime reporting unit, where
9 they do not at this point take stolen car reports if it
10 is not the registered owner of that vehicle. So that's
11 something that I will go back, take a look at, and get
12 with our legal counsel as well to see what type of
13 remedy I can have put in place. And one of the reasons
14 we don't do that is so that a person can't report
15 somebody else's car stolen. So that was the reason
16 with that being. Meaning a girlfriend gets mad at
17 boyfriend, fraudulently reports his vehicle being
18 stolen. So that's the reason that has been in place,
19 but we will take a look at that and see about modifying
20 that. And I will be able to report back to the Board
21 as far as what remedy has been put in place to address
22 certain circumstances like this.

23 CHIEF OF POLICE CRAIG: Commander, could you
24 also get the complainant's name and phone number and
25 give her a call back as to what you learned from your

1 inquiry as to the situation?

2 COMMANDER BETTISON: I sure will, Chief.

3 CHIEF OF POLICE CRAIG: Thank you.

4 COMMANDER BETTISON: Thank you, sir.

5 CHAIRPERSON TAYLOR: Just a minute.

6 Commissioner Warfield, did you have any comments?

7 COMMISSIONER WARFIELD: Yes. Commander
8 Bettison, unfortunate this is déjà vu for me. One of
9 the few times I came to a Board of Police Commissioners
10 Meeting before being placed on the Board was when my
11 company vehicle was stolen out of my driveway three
12 times. And the issue with a company vehicle being
13 stolen from you is that the company then, no matter how
14 great a worker you are, then lifts a suspicious eye at
15 you. And I know we -- we don't fully understand that.
16 But anything that we can do to service her son will be
17 greatly appreciated. And we thank you for going back
18 and wanting to revisit that, but we definitely need
19 something in place, because being a former
20 pharmaceutical rep, when my van was stolen, there were
21 unfortunately pharmaceuticals in that van. And so the
22 FDA even got involved, and it became a federal offense.
23 And so we have to, you know, be able to allow the
24 citizens of the City of Detroit some leeway in
25 instances like that. Especially if we have more and

1 more corporate citizens moving into the city who may or
2 may not have corporate cars, that we are able to
3 service them a little bit better.

4 So I thank you, sir, for already
5 understanding what the issues are and being able to do
6 something with it. So thank you.

7 COMMANDER BETTISON: Thank you. And I will
8 be able to report back to the Board next week and
9 provide you with an update.

10 MS. MCCANTS: He has only been back in the
11 city three months, from moving from out of state. They
12 transferred him back home, which I was glad he came
13 back home, but I mean to this.

14 CHAIRPERSON TAYLOR: We will take care of
15 you, Ms. McCants.

16 MS. PANNELL: Good evening, Board. My name
17 is Sharon Pannell. Good evening, Chief.

18 I have two questions. Are you going to keep
19 Nip-It program? It seemed to be working for our
20 Northwest side.

21 And you was talking about opening back up the
22 precincts. Can you tell us something about that too,
23 sir?

24 CHIEF OF POLICE CRAIG: The good news is that
25 we have an exhaustive review under way that actually we

1 introduced our consultant team to staff
2 today -- yesterday, and they have been on the ground
3 working. So as we look at restructuring and look at
4 how to improve our efficiencies, one of the things I am
5 committed to is opening stations. I don't think a
6 virtual station works at all, you know, and I will be
7 candid. I will be candid with you. You know, I have
8 officers that are performing the duties of a vehicle
9 maintenance officer. That's a person that gasses and
10 gets my car washed. That is waste. I am identifying
11 waste. I am going to start and have started in my
12 office first. So it is important. This is not Culver
13 City, California or Santa Monica where virtual
14 precincts work. This is the City of Detroit. And I
15 want you to know -- and I think there is a misnomer
16 that these precincts are closed. You should be able to
17 go in the precinct now.

18 UNIDENTIFIED SPEAKER: You can't.

19 CHIEF OF POLICE CRAIG: You cannot?

20 UNIDENTIFIED SPEAKER: You can't.

21 CHIEF OF POLICE CRAIG: Well, we are going to
22 have to unlock those doors.

23 MS. PANNELL: I go in there because they know
24 me.

25 CHIEF OF POLICE CRAIG: Because I am told

1 that the whole concept behind that is to free the
2 officers up. But I am committed to that, you know, the
3 officers are committed. In fact, it is the officers,
4 during my conversations with them, that are struggling
5 with virtual precinct.

6 As far as Nip-It, if it is an effective crime
7 fighting strategy, certainly we will keep it.

8 MS. PANNELL: Good.

9 CHIEF OF POLICE CRAIG: And we are going to
10 add to that. And so I am committed to those things
11 that work. Those things that don't work very well, we
12 are going to try something different.

13 MS. PANNELL: I really appreciate it. I am a
14 very active person in the community. And I am trying
15 to stay in Detroit because I have a choice. I do not
16 have to stay here in Michigan. I am retired. And I
17 can go to any city I want to go to. But I have a paid
18 for house, and I want to stay here.

19 CHIEF OF POLICE CRAIG: I understand.

20 MS. PANNELL: But I don't want to stay here
21 under fear.

22 CHIEF OF POLICE CRAIG: I live in the City of
23 Detroit. I understand. And I want to see Detroit come
24 back to the luster that was here when I left.

25 MS. PANNELL: We are seniors now. We retired

1 to be comfortable. Not to live in fear.

2 CHIEF OF POLICE CRAIG: I understand.

3 (Applause).

4 CHAIRPERSON TAYLOR: I just want to take a
5 minute to acknowledge the Wayne County Commissioner,
6 Erma Clark.

7 (Applause).

8 CHAIRPERSON TAYLOR: Thank you, ma'am.

9 MS. CLARK: I want to say, I thank you.

10 CHAIRPERSON TAYLOR: Go to the mic, Miss.

11 MS. CLARK-COLEMAN: Wayne County Commissioner
12 Erma Clark-Coleman. And this is my district. But I
13 just want to say thank you. When I heard about these
14 virtual precincts being closed, and my first thought
15 was, you know, they always tell you that if you are
16 frightened, if you are a woman, or some man driving out
17 there, and someone starts to follow you, they say,
18 drive straight to the police station. But my thought
19 was, you drive to the police station, and the police
20 station is locked. So what does that do? I mean, what
21 does that do for the person, if you don't -- then you
22 don't know where to go. You certainly aren't going to
23 get out of your car. And some of the visuals that I
24 saw was that you could walk in the lobby, the outer
25 door, but then you are boxed into this little small

1 lobby, because you can't get into the police station.
2 You can get attacked by just being in that little area.
3 So that was a question that I was going to ask. And I
4 am glad that someone else did ask it. I am glad to
5 hear you say that you are going to take care of that.
6 I thought that was the craziest thing I have ever heard
7 of. And that's no reflection, but I know you are
8 trying to save money, but there's some things that you
9 can't save money on. You have got to provide a safe
10 haven for the people to go to. And the police station
11 has always been that safe haven.

12 Thank you very much.

13 CHIEF OF POLICE CRAIG: Thank you.

14 MS. WALKER: Hi, my name is Zetty (phonetic)
15 Walker, and I am an ex-Wayne County employee for Wayne
16 County Detention Facility. Ex-President of
17 Grandparents Raising Grandchildren through NSO. And I
18 also want to thank the 10th Precinct because when I was
19 with NSO raising my grandkids, they had a program in
20 the office up there where they would give the kids
21 bikes. And I want to thank you all.

22 I am here today because I had an incident
23 today with this Officer Caldwell with my grandson
24 sitting on a porch. I am going to make a complaint
25 with Internal Affairs. My son was in an incident with

1 the police in October, so I have been getting a lot of
2 harassment. They have been stopping my grandkids going
3 to the store, coming to the store, you know, they
4 friends standing on my porch, they coming up slamming
5 them.

6 And so today, I was about tired with this
7 smart-talking cop, because I told him, I said, I ain't
8 got to talk to you. There is somebody over you. But I
9 am tired of the harassment. They have got my kids
10 scared. I had one that was scared. He wouldn't even
11 go to school for six months, he was scared to go out
12 the house. Every time they go out the house, they are
13 getting stopped on the street or up on the corner. I
14 can't have that. You know.

15 And I done started taking pictures. I done
16 started video. I videoed a lot of stuff. But I am not
17 going to have this. You know. The kids, like I tell
18 them, I worked with the detention facility, I tell
19 them, you know, you have to respect the police and
20 everything. Ain't none of my grandkids, I have got
21 seven grandsons, and none of them been to the youth
22 home, okay, at all, period. And I told them, you have
23 to respect them. But the police also have to respect
24 you also.

25 CHIEF OF POLICE CRAIG: I agree.

1 MS. WALKER: And I am not going to have them
2 talking to me any kind of way, like, you know, I done
3 did something myself, when I am asking you, what is the
4 problem? I just left my grandson on the porch. We was
5 sitting out there 40 minutes. And then, bam, here they
6 just drive up. So I just wanted to get that issue
7 across. And I will be talking to the Internal Affairs.

8 CHIEF OF POLICE CRAIG: Commander Stair is
9 the commanding officer of Internal Affairs. He is
10 here.

11 Commander, can you make contact?

12 Thank you.

13 CHAIRPERSON TAYLOR: Let me just say, I just
14 wanted to remind you that Robert, our timer, is not
15 here today, but we still want to adhere to our
16 two-minute time limit.

17 MR. BLACK: Good evening, Commissioners, good
18 evening, Chief.

19 CHIEF OF POLICE CRAIG: How are you doing?

20 MR. BLACK: My neighbors, as well as the men
21 and women of the 10th Precinct, this is my first
22 Commission Meeting. My name is Warren Jose Black. I
23 have lived in the LaSalle/Ford community for over
24 57 years. My father was a precinct delegate. And I am
25 one of the founders of the Playground Boys,

1 Incorporated. It is a nonprofit group within this
2 neighborhood. And why we started the group was to save
3 the playground that's one of the only playgrounds run
4 north and south in the city. And what we do is every
5 year, we have a Community Action Day on the playground,
6 which will be August 17th, which we are inviting all
7 the officers and the community to come out and
8 participate. We have a Health Fair. We give away free
9 food and backpacks to the kids. And we work with
10 Focus: HOPE.

11 With that being said, to be a member of our
12 organization, you have to be a property owner within
13 the boundaries of Davison, Oakman, 12th and Linwood,
14 whether it is a property or a home. And I will be
15 brief. But I would like to thank the officers for
16 doing their job diligently. I hope we can get a Drug
17 Free Zone sign posted on the float -- on the
18 playground. And thank you for patrolling the
19 neighborhood, because my mother is 85, and the seniors
20 are not being held hostage. So when you are there, you
21 know, it makes a difference. Driving through makes a
22 difference.

23 Thank you for your time.

24 (Applause).

25 CHIEF OF POLICE CRAIG: Thank you.

1 MR. FOSTER: Good evening, Commission. Good
2 evening, Chief.

3 CHIEF OF POLICE CRAIG: Good evening.

4 MR. FOSTER: My name is Emmett Foster, second
5 generation business owner, Foster's Car Wash at West
6 McNichols.

7 I just want to come out today and actually
8 show of support. Just over about a year ago, I was
9 actually victimized. And I said to myself, to my
10 family, that we have got to continue to be a
11 stakeholder in the community. We have been there for
12 over 30 years. So we have had our ups and downs in the
13 business. However, we have actually reopened.

14 I want to reach out and say to the Commission
15 to continue to take conservative steps. Me as a
16 35-year-old business owner is going to continue to take
17 the same eyes, sights of my liking, of my stature, and
18 continue to keep our residents safe. And I don't see a
19 lot of that going on in the city of Detroit right now.
20 At this point right now, I continue to take a gamble to
21 come into the city because I know what the city was
22 like before, and I know what it can be in the future,
23 as well. And I understand the residents' concerns.
24 This is an older city. And they have concerns.

25 And just moving forward, Chief, I am fully

1 aboard with you. This should be the safest city in
2 America. However, there is conservative steps that we
3 do need to take. I have talked to other young business
4 owners, and we are willing to make those steps
5 financially, to back this city to get the 5,000
6 officers that we know that we need to cover 144 square
7 mile radius.

8 CHIEF OF POLICE CRAIG: Thank you for that.

9 MR. FOSTER: Thank you.

10 (Applause).

11 MR. ROSS: Good evening, Commissioners,
12 Chief. I have a report here. My name is Mike Ross,
13 from BBK Towing. I have a report here from Operation
14 Nip-It, which we all know is a very effective tool.

15 I just have two questions about Operation
16 Nip-It. I have a copy of the report and the data
17 coming down from the City Attorney as well as you,
18 Chief, and you, Commissioners. My first question would
19 be: Who is in charge of the towing?

20 And my second question would be: Who makes a
21 decision as far as what towing companies are used
22 outside their areas? And this question is being asked
23 due to a discrepancy found in a report generated by
24 your Department, not by a civilian, regarding companies
25 being used from one side of town to the other. And we

1 just -- we have a copy of the report, and for you, the
2 Chief, and for the Commissioner, and if we can get some
3 kind of clarification on that.

4 CHIEF OF POLICE CRAIG: Lieutenant Barren is
5 here. We will take a copy of the report, and if you
6 have some specific questions, that's his area of
7 responsibility. Thank you.

8 MR. BROCK: How you doing? My name is Dennis
9 Brock. B-r-o-c-k is the spelling of my last name.
10 Welcome, Chief.

11 CHIEF OF POLICE CRAIG: Thank you.

12 MR. BROCK: Thank you for coming back to the
13 city. We need all the help we can get.

14 I am one of the owners of BBK Towing and
15 Recovery, and I just want to say if you can look into,
16 you know, what we are asking, we can surely use the
17 help. I thank the Police Commissioners, they have been
18 helping, but I found a few little problems here and
19 there. And we just kind of just want a little help on
20 it.

21 CHIEF OF POLICE CRAIG: Okay. Again, I will
22 get briefed by the Lieutenant, try to understand what
23 the issues are. And if at some point we need to have a
24 forum of tow truck company owners to address the
25 issues. I have heard a little of what's going on. So

1 maybe that might be something we have a single purpose
2 meeting to address some of your issues and concerns.

3 MR. BROCK: Okay. Thank you. That sounds
4 great.

5 CHIEF OF POLICE CRAIG: Okay. Thank you.

6 MS. PLUMBER: Good evening. My name is
7 Jeanette Plumber. And first of all, first and
8 foremost, my company organization is called Back This,
9 which means becoming a community that help instill
10 safety. I want to commend all of the 10th Precinct
11 police officers because each time that we have needed
12 them, they were there. And, you know, that's a plus on
13 our side. I live on the west side of Detroit between
14 Joy Road and Tireman bordering West Grand Boulevard.
15 Okay. Some of those children that you arrested over on
16 Whitney has been terrorizing our side of the
17 neighborhood, which is on the other side of I-96,
18 Maplewood, all the -- Tireman. So I want to thank you
19 for helping us with that. But we also have some more
20 children over there that are taking upon themselves to
21 set the houses on fire. And we definitely need help
22 with that, because these little kids are ranging from
23 eight years old up to about 15. You say something to
24 them, they want to fight you.

25 CHIEF OF POLICE CRAIG: Have you had a

1 conversation with the 10th Precinct command?

2 MS. PLUMBER: I used to talk with Officer
3 Hornbuckle. Now that he is retired, I have to get to
4 know the new person that's in charge.

5 CHIEF OF POLICE CRAIG: He is standing right
6 behind you.

7 MS. PLUMBER: But I just wanted to tell you
8 that we appreciate the police coming when we call them.
9 We haven't had any problems as far as the police
10 coming, but we are having a lot of problems with these
11 children.

12 CHIEF OF POLICE CRAIG: I understand. We
13 have a solution for that too. Especially our
14 middle -- mid school, I don't want to get into it now
15 but we -- especially our middle school age children,
16 you know, we can get to them at the middle school age,
17 can have an impact on them by the time they get to high
18 school. Not to leave the high schoolers out. We have
19 something for them, as well. But we are already
20 starting some dialogue about what we can do in an
21 intervention way to work with those youth. And it does
22 include the parent. Parents don't get off. They have
23 to be very much a part of this effort.

24 (Applause).

25 MS. PLUMBER: Yes. Because a lot of them,

1 these grown people are grafting these kids in. They
2 have them to do their dirty work.

3 CHIEF OF POLICE CRAIG: I understand.

4 MS. PLUMBER: And they collect on the
5 benefits. So we need to join forces and do something.
6 Because our houses are going up like Christmas trees
7 over there. And it is starting to smell like mold and
8 mildew.

9 CHAIRPERSON TAYLOR: Okay. Thank you.

10 MS. PLUMBER: It is terrible. Thank you.

11 MR. STOKES: Good afternoon to the Board of
12 Commissioners, to the Chief of Police. My name is
13 Alvin Stokes. I am the Chairman of the Citizens
14 Community Relations of the 10th Precinct. I welcome
15 you again to the 10th Precinct.

16 I am here to pat our officers on the back.
17 They can't do it themselves so I am going to do it for
18 them. I wouldn't trade these officers for nothing in
19 the world. Are there issues? Yes, there are. Can
20 they be solved? Yes, they can. But these officers put
21 their pants on one leg at a time just like the rest of
22 us. And the work that they do, they go above and
23 beyond the call of duty. Now, do we have any bad
24 officers? I don't know because I haven't ran into
25 them.

1 You know, my biggest issue was communication
2 as far as the Police Department is concerned. Is it
3 still an issue? Yes. But we are working through it.

4 We have got a command force at the 10th
5 Precinct that's great. The last time I was before the
6 Board, I complained about moving Love and we got a new
7 commander. I was able to meet with the commander and
8 he gave me his word that he is there for us. Been
9 changing sergeants as far as Community Relations. We
10 have had two sergeants -- three sergeants now in the
11 last year-and-a-half. But now Sergeant Woody, he is
12 great. I mean, we are learning to work with him.

13 But the thing is, is we have got community
14 groups within the 10th Precinct that are working
15 together. And that's what it is going to take to make
16 Detroit better. You are going to have to start with
17 the community. All our issues are not police issues.
18 So we have got to get those people from downtown out of
19 the Coleman A. Young Building and start getting them to
20 do their work as far as Detroit is concerned.

21 Detroit is going to come back. And it is
22 going to come back on our backgrounds. Because we are
23 the ones that's going to bring it back. And we are
24 asking for y'all to just support us.

25 Thank you.

1 (Applause).

2 CHIEF OF POLICE CRAIG: Thank you.

3 MS. RICE: Good evening. My name is Julie
4 Rice, and I am a resident of the Hope Village, as well
5 as a business person. I am responsible for ten stores
6 for Dollar Tree. So my questions are really much
7 broader. I have five stores within the City of
8 Detroit. And it is like the Tail of Two Cities. I
9 have one store on Jefferson at Jefferson and Joseph
10 Campau. I have another store at Jefferson and
11 Dickerson.

12 Jefferson and Dickerson, we have an officer
13 who is part of something, the Alter Road/Jefferson
14 project. This woman is amazing. She is out there.
15 She is talking to people. The crime there is zero. I
16 mean, nothing. You have no problems that she doesn't
17 know about. When you call her, she is right there.

18 My store at Jefferson and Joseph Campau,
19 every day at least two cars are being broken into. I,
20 too, have a corporate vehicle, and I have had my car
21 stolen from that very place and had to go down to the
22 1300 and do all the paperwork and had to be the butt of
23 the jokes of all my colleagues. But --

24 Okay. So my question is twofold. One, will
25 we see such a project like the Jefferson/Alter Road

1 project where we do have these officers in the smaller
2 mall settings where the business community can go to
3 that person and relate to that person on a daily basis?

4 And the other thing is, it is my
5 responsibility to find locations that are safe to open
6 stores. And I have tried a million different ways to
7 get on your website, to find out crime information, and
8 I can't get it.

9 CHAIRPERSON TAYLOR: Thanks.

10 CHIEF OF POLICE CRAIG: My Chief of Staff
11 will meet with you and get some information.

12 MS. VANCE: Good evening. Bridgett Vance,
13 Community Safety Coordinator for about six miles of
14 community. I am an employee of Focus: HOPE here. And
15 I work to identify residents who want to take on
16 leadership as it relates to community policing. And it
17 expands as far east as I-75, from Linwood to I-75, and
18 then from Oakman to I-94 where I am working with Chief
19 Holt and various other stakeholders in the community to
20 address these issues.

21 My question is about community policing. I
22 haven't heard, and you may have said, I just haven't
23 heard your stance on community policing. How you feel
24 about it. How you see that planning out in the city of
25 Detroit. How you see that unfolding in our precinct.

1 I have been in this position for five years, and we
2 have had about four to five chiefs of police. And high
3 turnover in our precincts. So I am hoping that you
4 stay as long as you can.

5 CHIEF OF POLICE CRAIG: Well, I appreciate
6 your kind words. And just so you know, community
7 policing is really the core of the successes that I
8 have been a part of, starting here in Detroit. Really
9 Detroit in the '70s was one of the first cities that
10 really engaged the community. And we had many stations
11 walking foot beats. It was amazing.

12 And part of that model I had an opportunity
13 to take to Los Angeles where Los Angeles, frankly, was
14 behind the times in community policing then, but
15 through time, L.A. certainly became a leader in
16 community policing.

17 And as I have said and I will continue to say
18 it, we, the police, cannot do it alone. We need to be
19 in partnership, many for partnerships. And when I talk
20 about partnerships, I mean we don't tell the community
21 what to do, but how we can work together. That's the
22 real key. When I look at and I know that here in
23 Detroit we have a Citizens on Patrol or an
24 organization, I think there is a member or two here, I
25 know in Cincinnati, Cincinnati probably has one of the

1 most robust Citizens on Patrol anywhere I have seen,
2 and I will tell you, in those neighborhoods where we
3 have active community members engaging in Citizens on
4 Patrol, they were the safest neighborhoods.

5 MS. VANCE: Absolutely.

6 CHIEF OF POLICE CRAIG: We started one in a
7 neighborhood called Avondale that was probably the most
8 violent area in the city, and did not have a Citizens
9 on Patrol, but once we went in, worked with our local
10 clergy leaders, worked with our neighborhood residents,
11 we started for the first time a neighborhood patrol,
12 Citizens on Patrol in that area, and for a year, there
13 were no homicides, all of 2012. So I know community
14 policing partnerships work.

15 So my stance is clear. I, we, can't do it
16 alone.

17 MS. VANCE: Thank you very much.

18 (Applause).

19 MS. HATCHER: My name is an Evangelist Dora
20 Hatcher. I am from the Northeastern District.

21 And to you, our new Chief, and to all our
22 commissioners, to the audience, I came in here tonight
23 to do one thing, but I am going to do something
24 different that I think is better. After hearing you
25 tonight, I applaud you for what you said that you are

1 going to do. Because I have a problem with a Chief
2 every year or two. Because how will your Police
3 Department ever get straightened out? Because let's be
4 real. People pick their friends for what they want,
5 and when they leave and somebody else come, they pick
6 their friends. So it just keeps it in an uproar.

7 CHIEF OF POLICE CRAIG: I agree.

8 MS. HATCHER: They are sensing the morale is
9 low with our officers. I know they don't get a lot of
10 money, and they are putting their life out there on the
11 line. I will tell you what I have told two other
12 chiefs. I never thought I would get this old to have
13 to get a gun to take care of myself. Okay. And I am
14 legal. And I don't have a problem with it. Because I
15 am too old. I have been in my home 45 years, to go
16 through what I went through a few months ago trying to
17 get an officer out, not because of my Northeastern
18 District police officers, because of that 911. Okay.
19 Because once I told them, do you want me to shoot them?
20 then they sent the police out.

21 So I am just saying, I am hoping that you
22 will, with God's help, get this Police Department
23 together where we can go in and not get a little foyer
24 with a telephone. Okay. When I need help, I need
25 help.

1 CHIEF OF POLICE CRAIG: I agree.

2 MS. HATCHER: So I hope and I am praying, and
3 I am one of those, I work in the city, they know me,
4 and I don't mind speaking what's on my mind. And I am
5 looking forward to working hopefully with you. I am a
6 member of the Detroit Police Alumni Association. And I
7 wonder why did I take it? Because we don't do nothing.
8 I have offered to go in there and work. I know you all
9 have a union. You may have to work things out. You
10 have got officers. I can take a phone call. I know
11 how to take a report.

12 So thank you.

13 CHIEF OF POLICE CRAIG: Thank you. Your
14 comments have been echoed in different places across
15 the city. Let me just say that it is no secret that
16 the morale in the Detroit Police Department is low
17 because of the instability of leadership. I know it.
18 Because I have worked in departments where there's been
19 stability. Just think, imagine this, in the 209-year
20 history of the Cincinnati Police Department, I was only
21 the 13th police chief. Thirteen. I am told, and my
22 partner over here to my right has driven for seven -- I
23 am the seventh chief in how many years?

24 UNIDENTIFIED SPEAKER: Six months.

25 CHIEF OF POLICE CRAIG: I will be candid. It

1 is ridiculous. It is appalling. And we as a city,
2 because I can call Detroit home, I live here now, we as
3 a city have got to get away, new Mayor, new Police
4 Chief. If the Police Chief is not performing, which is
5 me, included, get rid of me. But if we are performing
6 and we are serving this community, and we are doing
7 what we need to do, then guess what, let's stabilize
8 this Police Department, because it does affect crime.

9 MS. JACKSON: Good evening. Kim Jackson,
10 President of Northeastern District.

11 I just want to first of all commend all of
12 our officers. I know we are in number 10. But I want
13 to commend all the officers across the city for just
14 doing -- just getting out here every day. It couldn't
15 be me. That's all I can say. It could not be me. So
16 I take my hat off to all the men and women that put
17 their life on the line every day. That's my first
18 comment.

19 Second comment is that our meetings at the
20 Northeastern District when we meet every second Tuesday
21 of the month, we recognize our officers at our
22 community meetings. And we do this so that the
23 community know what officers do. A lot of people don't
24 understand or they just don't want to understand what
25 they do. And we like to let our community know that

1 these are your men and women that's on the street every
2 day. And this is what they do. So we have an officer,
3 or a couple officers every month that we honor in our
4 district. And I just think that's something that
5 should be shared across the board, because that's
6 something that's so important. I mean, it might be
7 little to us, or little, you know, maybe that's their
8 job, so they are like, it is okay, but it is not okay.
9 It is something that needs to be recognized. And I
10 just wanted say thank you.

11 Welcome, Chief. Thank you, Board.

12 CHIEF OF POLICE CRAIG: Thank you for sharing
13 that. We need to recognize our officers. That was the
14 reason why today we acknowledged members of the 10th
15 Precinct for that outstanding police work. So thank
16 you for that.

17 MS. MCGATNY: Hi, my name is Glenda McGatny.
18 I am the President of the Buena Vista Block Club.

19 And I have been very pleased in the last
20 probably eight months, we have had to the call the
21 police to come out, and they came out within five to
22 ten minutes. We had great response.

23 But my complaint is we have a gentleman who
24 is going around in Russell Woods, probably about
25 55 years old, going into backyards, going into vacant

1 homes, and some occupied homes, he is riding a bicycle,
2 he is pulling a shopping cart, and he is taking items
3 that does not belong to him.

4 He has been approached. The police, they
5 take the items from him, but then they let him go.
6 This has been going on since November of last year.

7 And I need to know why he has not been
8 arrested and he is still going around in our
9 neighborhood making us feel very unsafe early in the
10 morning, late at night, pulling garbage dumpsters with
11 items that he fills and takes away, like on Tyler and
12 some other areas. Why is this happening, when he has
13 been reported? People have taken pictures of him. And
14 this is continuing. They still let him go. He should
15 be in jail.

16 CHIEF OF POLICE CRAIG: Talk to the Commander
17 from the 10th Precinct. He will look into that for
18 you. He is standing right behind you.

19 MS. NICKERSON: Jackie Nickerson, from
20 Russell Woods.

21 And I am here for a fun thing. It is time
22 for Jazz in the Park again. And we invite you all to
23 come because it is a gathering of 7 to 800 people.
24 Nothing goes wrong. So it doesn't make the paper. We
25 have had it for many, many years, but we are very proud

1 of Jazz in the Park because nothing ever goes wrong,
2 but -- so we will never make the paper. So here it is.
3 We will expect you on July 21st between 6:00 and 8:00.
4 And it is nice for you to be there, sir, you will see
5 something pleasant.

6 CHIEF OF POLICE CRAIG: Thank you.

7 CHAIRPERSON TAYLOR: Ms. Jackie, what's your
8 last name? I'm sorry.

9 MS. NICKERSON: Nickerson.

10 MS. MCKISSICK: Good evening. My name is
11 Mary McKissick, and I am former President of the
12 Detroit Citizen Police Academy Alumni Association. We
13 welcome you, and we look forward to working with you.

14 I have one question, though. I am one of the
15 senior citizens that enjoy going to the movies. And I
16 just want to know when -- are we going to be getting
17 new vans any time soon?

18 CHIEF OF POLICE CRAIG: I don't have the
19 answer to that one. I really don't. But I will -- we
20 can look into it.

21 MS. MCKISSICK: Good.

22 CHIEF OF POLICE CRAIG: Because I know it is
23 important to be able to transport community members,
24 but I am not certain.

25 MS. MCKISSICK: Thank you. We look forward

1 to working with you.

2 MS. ROBINSON: Hello. My name is Lisa
3 Robinson, and I am from Oakman Boulevard Community
4 Association. I am the Vice President. I also
5 participate in our community patrol.

6 We have had several cleanups in our area
7 during the summer. On the 18th we boarded up four
8 vacant houses. And I would just like to publicly thank
9 Commander Suchoski because he and I think one or two
10 other officers were with him, we also had volunteers
11 from Focus: HOPE, and they were wonderful. They took
12 on the responsibility of using the saw and boarding up,
13 you know, cutting the wood and everything. And made
14 the job much more easier for us. If we wouldn't have
15 had them, it wouldn't have gone as quickly, so I just
16 wanted to come up and personally thank them.

17 CHIEF OF POLICE CRAIG: Thank you.

18 MS. TAYLOR: I am Reverend Virginia Taylor,
19 and I live here in this area. And this is one of the
20 happiest days of my life that I see the 10th Precinct
21 and the Chief all meeting here together. And I want to
22 thank the 10th Precinct because I had a call this week.
23 And I was so excited I have been dancing ever since to
24 know that things are coming together, and we do see the
25 light, and because of the work and the things that we

1 are doing, and I know you don't want to hear about
2 things you used to do, but I can kind of help with the
3 things that we used to do and bring back that old
4 fashioned love and respect in our communities.

5 Once a year, since I am the last living
6 creature of the Tyler Waverly Buena Vista Block Club
7 Association, and that's been gone almost ten or
8 15 years, but I have been hanging on for the last six
9 years, at least once a year we have had in our area
10 with the help of Focus: HOPE and Ms. Vance that just
11 talked to you, we have been working together to see
12 about the weeds all being cut down. I have gone out in
13 the community and engaged in the people that live in
14 the community and the young people to help cut the
15 weeds in our area. And also with the help of Focus:
16 HOPE. So over the last six years we have been working
17 along with my great grandkids to pass out information.
18 We put out flyers. We put out posters. And you might
19 have seen some of them in the neighborhood in the area,
20 which includes Linwood, Glendale, Davison, and 14th
21 Street. That has usually been our area that we have
22 been working in the last five years, six years that we
23 have been working in.

24 And I live on Buena Vista between 14th and
25 LaSalle. And I am just very happy to see that the

1 community again with the Commissioners, with the Chief
2 of Police, and everybody working together again, my
3 prayers have been answered. Thank you.

4 MS. MCCANTS: My name is Yolanda McCants. I
5 just have one question for the Chief.

6 Can I, can our officers get some decent cars?
7 Other places --

8 CHIEF OF POLICE CRAIG: Thank you.

9 CHAIRPERSON TAYLOR: Ms. McCants, yes, I will
10 get that question from you later.

11 MR. DRAIN: Good evening. My name is Jerome
12 Drain, and I am working with the Safety Initiative with
13 Focus: HOPE and LISC, as Ms. Vance had indicated, we
14 are working in the Six Mile area. One of the questions
15 I have -- and we are working to increase block clubs
16 and see patrols in those areas.

17 One of the questions I have is: With the
18 Compstat, is there a way to segregate the stats for
19 areas that have extremely active block clubs and/or
20 extremely active CB patrols so that we can use that
21 information to go out into the community and prove to
22 the residents that extremely active block clubs and CB
23 patrol are an excellent deterrent as far as driving
24 down crime.

25 CHIEF OF POLICE CRAIG: It is my goal and

1 commitment that you will have accurate and timely crime
2 statistics. That commitment also goes to our friends
3 in the news media because I want to make sure that
4 people who live, work, and play in the city of Detroit
5 are aware of what crime is happening, where it is
6 happening. We want to make sure we update our website.
7 You will have that information. So that's a process
8 that is a priority for me. As I indicated earlier on
9 in this session, we have our consultants. They are in
10 town. They are working on that. They know Compstat is
11 a best model practice that has worked for me in several
12 places, and I am absolutely certain it will work here.

13 MR. DRAIN: Thank you.

14 MS. ROMANO: Good evening. Anna Romano.

15 Sir, it is an honor and pleasure to finally
16 meet you. At our previous meeting I did ask a question
17 to D.C. Tolbert, but it was already asked, but I am
18 just going to reiterate it. At previous meetings, we
19 were given the stats to Nip-It. And under the command
20 of Interim Inspector Barren, I know they called him
21 Acting, but that Acting word, I prefer Interim, to use
22 that word, that phrase, but I know they were giving
23 acting. As a community, we have seen what a success it
24 has done in our neighborhoods, not just on the west
25 side but also on the east side. And what can we do as

1 business owners, as residents, to ensure that Nip-It is
2 continued throughout the summer months?

3 CHIEF OF POLICE CRAIG: Stay involved.
4 Certainly, I have heard nothing but good about Nip-It.
5 And again, I am going to evaluate all of our programs,
6 and those that are most efficient, those that are
7 working, we are going to continue to move forward with
8 that.

9 MS. ROMANO: And the other question I have
10 is: During the reorg on March 4th, we did lose two
11 units. They were placed in the districts. And that
12 was tact mobile and gang squad. And we did have the
13 community outcry for keeping those units. Also, the
14 students, high school students came out. I mean, they
15 were at the Board of Police Commissioners Meetings and
16 everything, and Commissioner Warfield and the rest did
17 talk to them and let them know that their voices
18 mattered and they could -- and they were being heard.
19 Are you going to bring back those two units? Are you
20 looking into that?

21 CHIEF OF POLICE CRAIG: I am absolutely
22 looking into it. You know, I started here in the '70s
23 when we had a tactical services section. And part of
24 Compstat, in order for Compstat to be effective, we
25 have to have a citywide unit that can hit those

1 hotspots in realtime. And so we can't do it the way we
2 do it now. We will do it differently. I like -- I
3 love TSS. And given that I spent so much time in the
4 city of Los Angeles, there is no secret that it is the
5 gang Mecca. I worked gang units. I managed gang
6 units. I understand a response to the gang culture.
7 And so we are going to be working on that, as well.

8 MS. ROMANO: I appreciate that, because at
9 this time, if you will notice that with the officers
10 answering runs, they cannot hit those hotspots at the
11 gas stations, party stores, from 7:00 to 3:00.

12 CHIEF OF POLICE CRAIG: I understand.

13 MS. ROMANO: Thank you so much, sir. And I
14 look forward to seeing you at all the meetings and
15 working with you.

16 CHIEF OF POLICE CRAIG: Absolutely. Thank
17 you.

18 MR. JENKINS: Good evening. I am Walter
19 Jenkins, Acting President for the Maplewood Family
20 Block Club. David Jackson.

21 MR. JACKSON: Acting Vice President for the
22 Maplewood Family Block Club.

23 MR. JENKINS: First of all, I want to give
24 thanks to the 10th Precinct for working with the --
25 diligently patrol faithfully in our neighborhood. As

1 one of our neighbors, Jeanette Plumber, spoke of, I
2 want to give them thanks.

3 I also want to give special thanks to Officer
4 Brown and Officer Tabb for working diligently with me
5 to help establish our block club.

6 We just had a block party on the 4th were we
7 fed the community. We have been cleaning up the
8 neighborhoods, working together, so they have been
9 working with us. I really want to thank them for that.

10 But we also have a concern that Mr. Jackson
11 is going to talk about.

12 MR. JACKSON: One question I wanted to ask.
13 I don't know if it is really even your department or
14 whatever, but was wondering if there is anything we can
15 do with the City whereas all these vacant fields and
16 lots that are, you know, just tremendously out of
17 control, I mean, you know, while riding down some of
18 the streets and it looks like a forest. We just -- we
19 go through the community in our neighborhoods cutting
20 the fields and the streets, trying to keep it down, but
21 we are just wondering if there is anything that we can
22 do to work with the City and, you know, to help control
23 that because we have been having a lot of robberies,
24 kids hiding in the bushes and robbing people that's
25 going to the stores late at night, and our seniors.

1 CHAIRPERSON TAYLOR: Mr. Jackson, I think
2 that's something you probably need to go to the City
3 Council and address that with them.

4 MR. JACKSON: Okay.

5 CHIEF OF POLICE CRAIG: I will just add that
6 as our crime abatement efforts, my conversations with
7 Detroit's Crime Commission, we recognize that when
8 blight is allowed to not be addressed, it tends to
9 attract criminal behavior. So there are some
10 neighborhoods that have been working in conjunction
11 with the Police Crime Commission to remove vacant
12 buildings, blight, and so it is like taking one
13 neighborhood back at a time. So that's important to
14 me. And I do understand how blight can attract
15 criminal activity. So it is important.

16 MR. JACKSON: Thank you.

17 MR. JENKINS: Thank you.

18 MS. SMITH: Good afternoon to the
19 commissioners, and to you, Chief, and to the ladies and
20 gentlemen in the audience. My name is Bernice Smith.
21 I am your political activist. I do quite a bit of work
22 in the neighborhoods, know what's going on. And like
23 to let it be known to the public.

24 Chief, we are glad to have you here. I knew
25 the organization or the selection committee that

1 brought your name in use, and I was very hesitant
2 because I felt as though, what is his background? And
3 after investigating and talking to my relatives in
4 Cincinnati, you did get an okay. I am for real. I am
5 not no phony person. As a matter of fact, I will tell
6 you this. I am one of the first Police Commissioners
7 under Coleman Young. '74. So you know I know about
8 the Police Department. All right. The first black.
9 In other words, I am a favorite and a supporter of the
10 Police Department and the Fire Department. They have
11 gone through so many trials and tribulations, that
12 nobody is standing up for them. I want their morale to
13 come up like it was before you take it away, not you,
14 per se, but before they have taken away their hours and
15 increased their medical plans, that they have been
16 taken away. Their over -- so many things --

17 And Brown is not here today, Baby, so let me
18 have a chance.

19 Anyway, Chief, I will be watching what you
20 are going to be doing. There is something that I want
21 to talk to you in person about. I don't think it
22 should be brought up in public. But the fact is, you
23 have a job to do here in this city. And we know that
24 it is not going to be easy. I do commentary on the
25 radio, and I will talk about you and anybody else that

1 do wrong --

2 CHIEF OF POLICE CRAIG: And just know this --

3 MS. SMITH: -- because -- just let me
4 finish -- I am not on anybody's payroll. I am a widow,
5 81 years old, and I do my job diligently. I am in
6 charge of my precinct over in Midtown, I have been
7 there 18 years. So I want you to know I am close to
8 you. And Mr. Orr, I have talked with him also, so
9 therefore, I want to tell you, believe me when I come
10 to you and tell you things, I am very sincere about it.
11 I met you two weeks ago. And I think then that we
12 didn't get off to the right track. But anyway, we are
13 going to do good because of the fact that --

14 CHIEF OF POLICE CRAIG: Really?

15 MS. SMITH: -- I am going to get off, I am
16 going to get off, but I just wanted to let you know
17 since you are coming back --

18 CHIEF OF POLICE CRAIG: Wow. Been here
19 almost two weeks. Almost two weeks.

20 MS. SMITH: Well, you can ask Mr. Orr or ask
21 the Mayor about me. They know that I will tell the
22 truth about whatever happens.

23 So good luck to you, and hope that you will
24 be successful with our Police Department because you
25 must bring up their morale because it is very low now.

1 And stay away from Brown.

2 CHAIRPERSON TAYLOR: Are there any more
3 comments? Are there any more comments? Are there any
4 more comments?

5 If not, I am going to have Commissioner
6 Warfield wants to make some comments at this time. So
7 we will have him too.

8 COMMISSIONER WARFIELD: Thank you, Madam
9 Chair.

10 Those of you who come to our Police
11 Commission Meetings on a regular basis, you know and
12 you understand and I believe appreciate the very
13 transparent manner in which we conduct our business.
14 We do not do it behind closed doors. We have been
15 above board and in front of you in everything that we
16 do.

17 Unfortunately, there is a story that's out
18 there that is completely not true. And those of you
19 who come to our meetings, you know that because you
20 were here. Some of you were here when we came back
21 from San Diego fresh off the plane and held a
22 communities meeting to find out what you all wanted us
23 to ask the new Chief of Police. It is in our minutes.
24 You all were here when we sat at this table and debated
25 about who would be the companies to search for the

1 Chief of Police. You were here when we voted in the
2 open to determine what company that would be. You were
3 here as we waited to get a report back from that
4 company on who they had chose. You were here when we
5 had struggles dealing with who was going to pay for the
6 search for the Chief of Police. You were here and we
7 reported back to you when the Emergency Manager came
8 and signed the contracts for the search to continue,
9 after it was begun and then stopped. We were open with
10 all of that. It was the Mayor and the Emergency
11 Manager who made the decision on which candidate to
12 hire as Chief of Police. The process was open. The
13 process was aboveboard. And the process was part of
14 our public record.

15 Let me say this to you real clearly. We
16 voluntarily turned over everything that was asked of us
17 by way of FOIA to turn it over. So if you see
18 documents floating around on TV, it is because we
19 willingly gave those up. They didn't have to ask us
20 twice. We did it, and I think in about a week- or a
21 two-week period of time gave them all the minutes as
22 relates to this search. Gave them all memos as relates
23 to this search. I say this because I want you to know,
24 especially those of you who follow us on a week-in and
25 a week-out-basis, that we have been aboveboard and

1 transparent in all of our dealings. And nothing -- and
2 this man would not be a part of it if it was -- nothing
3 was done under the table, and nothing was done
4 underhanded. Absolutely nothing. We welcomed the
5 inquiry. We welcome those who want to look into it.
6 It is not an issue with us, but I want you to know the
7 truth. Because you were there from the resignation of
8 the last Chief, to the naming of this Chief. And you
9 were part of the process, unlike you have never been
10 before in the history of the City of Detroit. And I
11 just wanted to let you know that. And I thank you all
12 for your support.

13 MR. SCOTT: Madam Chair, I wasn't going to
14 say anything. I was asked whether I was going to
15 speak.

16 Ron Scott.

17 What I was going to say, Pastor Warfield, was
18 to co-sign exactly what you said. As you know, that I
19 am here virtually every week, as well as many of the
20 good citizens who are here in the audience. And we are
21 coming up on a very important election. We are going
22 to determine about the election of Police Commissioners
23 in terms of oversight. I was here in 1974 when the
24 Police Commission was founded. I was here before that
25 during the antistress activities that led to it and the

1 election of Mayor Young. I was here before they were
2 50 percent African-Americans here, when the Police
3 Department had its struggles in terms of trying to come
4 into compliance with the modern era. And here when the
5 Police Commission has had the continuing consent
6 decree. And all of which have been about trying to
7 change the culture of this Department. I hope that
8 that is a consideration, and a continuation. We have
9 been talking about nice programs, but we have got to
10 change the culture of this Department if we are going
11 to move forward in a modern environment.

12 The other thing is, to the Commission, this
13 Commission has been one of the strongest Commissions
14 ever. And I, Chief, this is no aspersions about you
15 because you have only been here two weeks, I wouldn't
16 say anything negative, but the mention was made that
17 Mr. Orr made the decision. Mr. Orr chose, he put his
18 hand in the gumball and got three out. And it went
19 through the Mayor. In this time when our
20 constitutional rights are being challenged, we have to
21 really understand that we made that decision. We made
22 the decision on three people, through this governmental
23 body, and one came out, and it was you. So when it is
24 mentioned before, please don't leave the Commission
25 out, because that represents the people. You are the

1 people's Chief. And please remember that. Mr. Orr is
2 here as an employee of the Governor of the State of
3 Michigan, who many of us will work to vote out. But at
4 any rate, that's just my personal feeling. But
5 nonetheless, whether you vote for him or not, this body
6 is one of the most progressive bodies in this country.
7 And that's why they chose and, in fact, even before it
8 was known it was going to be you, many of them
9 intimated that it would be you because they felt that
10 you were the most progressive. So when it is mentioned
11 before, please do not leave this body out because that
12 would be like leaving the people out.

13 (Applause).

14 CHAIRPERSON TAYLOR: Thank you.

15 So if there is no more comments from the
16 audience, we will close this session. Meeting
17 adjourned.
