5 CHAIRPERSON BELL: Good evening. I am going
6 to call the Board of Police Commission Meeting
7 Community Meeting to order at this time. I am your
8 Chair, Commissioner Willie Bell, from District 4.
9 Welcome you to Cobo Hall.

10 If this is your first time, this is a
11 fantastic facility, just on walking through it, just on
12 a casual note. And I just want to welcome you to Cobo
13 Hall. And we would recognize our host for this evening
14 shortly in the program.

15 At this time, I am going to ask Deacon Adams,
16 our Commissioner deacon, to come forward to bless us
17 for the occasion with a prayer.

18 DEACON ADAMS: Thank you.

19 Dear awesome wonderful God, we come to you
20 praising, uplifting, and glorifying, and magnifying
21 your holy name, oh, heavenly Father. And we ask you to
22 synchronize our minds and our hearts so that we can
23 deliberate your business so that we can all be fair and
24 just in all things that we do.

25 We uplift our mission, oh, heavenly Father,

1 to be able to support and take care of your people that
2 you have charged us with.

3 All these things we ask for in the name of
4 your son Jesus Christ of Nazareth. In thanks we give
5 his name. Amen.

6 AUDIENCE: Amen.

7 CHAIRPERSON BELL: Thank you, sir.

8 We are going to start with introductions.
9 And we are going to start to my left with the
10 Commissioners who will introduce themselves. That is
11 our community format.

12 So to my far left.

13 COMMISSIONER SHELBY: Commissioner Richard
14 Shelby, District 1.

15 COMMISSIONER VANN: Commissioner Edgar Vann,
16 District 2.

17 COMMISSIONER CRAWFORD: Commissioner Reginald
18 Crawford, District 3.

19 COMMISSIONER TAYLOR: Commission Jessica
20 Taylor, at large.

21 COMMISSIONER CARTER: Commissioner Lisa
22 Carter, District 6.

23 COMMISSIONER MOORE: Police Commissioner
24 Ricardo Moore, District 7.

25 COMMISSIONER DEWAELSCHÉ: Eva Dewaelsche, at

1 large.

2 COMMISSIONER WHITE: Good evening.

3 Commissioner Donnell White, at large.

4 CHAIRPERSON BELL: Thank you, Commissioners.

5 Once again, Commissioner Willie Bell. And to
6 my far left sitting in for Chief Craig, he do not need
7 an introduction, you see him all the time in the media,
8 he is a hard charging working Assistant Chief,
9 Assistant Chief Dolunt.

10 A.C. DOLUNT: Hi.

11 CHAIRPERSON BELL: He is one of my favorite
12 Assistant Chiefs. And you see he brought his Detroit
13 Lions water cup of coffee. I guess he's going to stay
14 for a while.

15 A.C. DOLUNT: Yes, sir.

16 CHAIRPERSON BELL: But we all have a small
17 bottle of water.

18 Thank you, Assistant Chief, for filling in
19 for the Chief.

20 And I am going to ask our Executive Secretary
21 to introduce -- Secretary to the Board, George Anthony,
22 to introduce the rest of the staff of the Board of
23 Police Commissioners.

24 SECRETARY ANTHONY: Thank you, Mr. Chair.

25 For the record, George Anthony, Secretary to

1 the Board.

2 Mr. Chair, if you will indulge me, there were
3 a couple of Commissioners that did not introduce
4 themselves. So I would like to read their names in the
5 record.

6 Commissioner Willie E. Burton does not appear
7 to be here. I think he has a cold.

8 And Commissioner Conrad Mallett is not here.

9 CHAIRPERSON BELL: Thank you, sir.

10 SECRETARY ANTHONY: The staff for the Board
11 is Ms. Pamela Davis-Drake, seated in front, she is the
12 Chief Investigator for the Office of the Chief
13 Investigator. Ms. Linda Bernard, also seated in front,
14 she is the attorney to the Board.

15 We also have Supervising Investigator Ainsley
16 Cromwell from the Office of the Chief Investigator, and
17 he is sitting in the audience.

18 Robert Brown, Mr. Robert Brown is our Office
19 Manager. And Sergeant Alan Quinn is recording our
20 proceedings. And Ms. Rhonda Foster from Hanson Court
21 Reporting Service is taking the transcript.

22 That completes the introduction, sir.

23 CHAIRPERSON BELL: And since we on an
24 introduction note, I am going to ask Assistant Chief to
25 introduce the Chief's staff and any officers that are

1 in the room, please.

2 A.C. DOLUNT: Thank you, sir.

3 Through the Chair, Assistant Chief James
4 White is here, and I have no problem if he is in front
5 of the media all the time, for the record.

6 A.C. WHITE: Deputy Chief.

7 A.C. DOLUNT: Yeah, Deputy Chief Dave
8 LaValley.

9 You are Director, right, Celia? Oh, she is
10 Deputy Chief. Oh, crap, Deputy Chief Sylvia
11 Washington. She is in charge. That's all I know.

12 Who else is over here? I have got Captain
13 Williams here, Deputy Chief Fitzgerald, Captain Hope,
14 Mahone. Who else? Any more captains here? Pritchett.
15 You know what? There is a lot of people here. So we
16 are good.

17 CHAIRPERSON BELL: Not really. We have got
18 some of my favorite people in the back. Would you have
19 them introduce themselves then? My captain from the
20 5th Precinct and others?

21 A.C. DOLUNT: He is your favorite?

22 CHAIRPERSON BELL: One of my favorites.

23 CAPTAIN BLISS: Captain Bliss.

24 CAPTAIN TOSQUI: Captain Aric Tosqui, Third
25 Precinct.

1 CAPTAIN CHAMBERS: Captain Michael Chambers,
2 Fourth Precinct.

3 CAPTAIN KYRIACOU: Nick Kyriacou,
4 10th Precinct.

5 CAPTAIN LEACH: Captain Leach, 11th Precinct.

6 CHAIRPERSON BELL: Any other officers?
7 Missing anyone?

8 Did we get Captain Jarvis?

9 CAPTAIN JARVIS: Captain Jarvis, Education
10 and Training Division.

11 CHAIRPERSON BELL: Please. Another one of my
12 favorite captains.

13 A.C. DOLUNT: Commander Wilson is hiding back
14 there too.

15 CHAIRPERSON BELL: Okay.

16 A.C. DOLUNT: Lieutenant Miles.

17 CHAIRPERSON BELL: Okay.

18 A.C. DOLUNT: Did I say Fitzgerald?

19 CHAIRPERSON BELL: Okay. Is that it?

20 Thank you. Thank you for your attendance and
21 your ongoing commitment to the City of Detroit.

22 If this is your first Community Meeting of
23 the Board of Police Commission, could you please stand?
24 If this is your first meeting.

25 Welcome. Thank you for coming out. Thank

1 you.

2 Any others? So as Conrad Mallett,
3 Commissioner Mallett would say, the rest of you are
4 regulars, then, huh? That's an inside remark.

5 I would ask -- once again, we are happy to be
6 here at Cobo Center. And we give thanks to our host,
7 Mr. Bruce Smith.

8 Could you come up, come forward, and give us
9 a little tidbit about Cobo Center is not Cobo Hall any
10 more?

11 MR. SMITH: Well, yes, it is Cobo Center. I
12 am not very much for talking. I am the Public Safety
13 Manager, Manager of Public Safety and Security.

14 Just wanted to let you know that the
15 restrooms -- go out the door, the restrooms are to the
16 right in the far corner.

17 Welcome to our facility.

18 And we should be finished with construction
19 somewhere around August. So we are still going. We
20 are not quite done yet.

21 CHAIRPERSON BELL: I think you need to say
22 you had an overflowing crowd for the Auto Show. It was
23 overflowing?

24 MR. SMITH: Yes, we did very well actually
25 for the Auto Show. I don't remember the numbers off

1 the top of my head because there is so many events
2 going on right now in my head that's still to come. We
3 have a big event coming shortly, the Shell Eco. I am
4 sure you will hear about it, and it will be a pretty
5 nice event.

6 CHAIRPERSON BELL: Thank you. Thank you,
7 sir. Thank you for hosting tonight.

8 Commission item number 8 is approval of
9 agenda for the meeting tonight. You have the agenda
10 before you. What is your pleasure?

11 COMMISSIONER MOORE: So moved.

12 COMMISSIONER CRAWFORD: Supported.

13 CHAIRPERSON BELL: Properly moved and
14 seconded.

15 Ready for the question, those in favor, aye?

16 COMMISSIONERS: Aye.

17 CHAIRPERSON BELL: Those opposed?

18 Motion carried.

19 Next item would be approval of the minutes
20 from Thursday, March the 5th. The Chair would
21 entertain a motion.

22 COMMISSIONER VANN: I so move.

23 COMMISSIONER TAYLOR: Support.

24 CHAIRPERSON BELL: Ready for the question,
25 those in favor?

1 COMMISSIONERS: Aye.

2 CHAIRPERSON BELL: Those opposed?

3 Motion carried.

4 Item number 10 is the Chairperson report. I
5 really don't have an official report. I think we
6 reserve some remarks later. There are a couple of
7 things I was involved with, but I think that the
8 Assistant Chief is going to report out the major event
9 this week. So I am not going to steal their thunder,
10 but I am going to allow them to share that particular
11 major event that I had an opportunity to take part in.
12 It was highly impressive. So we can move right into
13 the Secretary Report.

14 SECRETARY ANTHONY: Thank you, Mr. Chair.

15 This is not necessarily a report, but it is
16 more so I would ask the Board's indulgence for a
17 presentation. The presentation will talk about or will
18 seek the Board's support to bring the NACOLE Conference
19 to Detroit in the 2016 year, for 2016.

20 And so here to just make that brief
21 presentation is Ms. Andrea Cadotto and Mr. Ainsley
22 Cromwell from the Board of Police Commissioners -- or
23 from the Office of the Chief Investigator.

24 CHAIRPERSON BELL: Okay.

25 SECRETARY ANTHONY: Mr. Cromwell is the

1 National Vice President for NACOLE, and Ms. Cadotto is
2 with the Convention Bureau.

3 CHAIRPERSON BELL: Okay. Could we pause for
4 one second? I didn't have in my notes, but we normally
5 have our duties and responsibilities.

6 Now if you could pause, Commissioner Donnell
7 White is going to read the charge and duties and
8 responsibilities of our Charter mandate.

9 Thank you, Commissioner White.

10 COMMISSIONER WHITE: Thank you, Mr. Chair.

11 Duties and responsibilities of the Detroit
12 Board of Police Commissioners, Accountability through
13 Civilian Oversight.

14 (Commissioner Mallett entered proceedings at
15 about 6:44 p.m.)

16 COMMISSIONER WHITE: We were created in 1973.
17 The citizens of Detroit adopted a new form of
18 governance for the Police Department by revising the
19 Detroit City Charter and creating the Board of Police
20 Commissioners. The revised City Charter became
21 effective on July 1, 1974.

22 Its current composition by the 2012 City
23 Charter provides for the Board to have 11
24 commissioners, four members appointed by the Mayor,
25 subject to the City Council's approval, and seven

1 members elected from each district, one from each non
2 at-large district. The 2012 Charter gives the Board
3 supervisory control and oversight of the Police
4 Department as set forth in the Charter.

5 The meetings: The Board meets at the call of
6 its chairperson, and is required to meet at least once
7 each week, but may vote to recess during the
8 Thanksgiving, Christmas, and New Year's holidays. All
9 meetings are held in accordance with the Michigan Open
10 Meetings Act.

11 The Duties: The Board is responsible for the
12 following specific duties:

13 Establish policies, rules and regulations for
14 the Police Department in consultation with the Chief
15 and the approval of the Mayor.

16 Review and approve the departmental budget.

17 Receive and resolve citizen complaints except
18 those alleging criminality.

19 Act as final authority in imposing or
20 reviewing discipline of employees of the Department.

21 Make an annual report to the Mayor, the City
22 Council, and the public of the Department's activities
23 during the previous year, including the handling of
24 crime and complaints, and of future plans.

25 The Board may subpoena witnesses, administer

1 oaths, take testimony, and require the production of
2 evidence.

3 The Board approves the promotions made by the
4 Chief, and consents to the appointment of necessary
5 Deputy Chiefs.

6 The staff: The Board appoints a Board
7 Secretary. It also appoints a Chief Investigator and
8 such additional staff of investigators as it deems
9 necessary. Moreover, the Board appoints the Director
10 of Police Personnel, who must be a civilian. All Board
11 appointees serve at the Board's pleasure.

12 The Board's function: We, the Board, look at
13 ourselves as a liaison between the citizens of the City
14 of Detroit and the Detroit Police Department.

15 Thank you, Mr. Chair.

16 CHAIRPERSON BELL: Thank you, Commissioner
17 White.

18 And Mr. Anthony, we can proceed now.

19 SECRETARY ANTHONY: Mr. Chair, Commissioner
20 Mallett has just arrived.

21 CHAIRPERSON BELL: Yes. Good to see you,
22 Commissioner Mallett.

23 COMMISSIONER MALLETT: Thank you, sir.

24 MS. CADOTTO: While he is starting the video,
25 I will just formally introduce myself. I am Andrea

1 Cadotto, National Sales Manager for the Detroit Metro
2 Convention & Visitors Bureau.

3 I believe most of you are familiar with our
4 organization and what our role is within the City and
5 really the three counties.

6 So the Detroit Metro Convention & Visitors
7 Bureau is funded by the hotel tax of three counties.
8 That's Wayne, Oakland, and Macomb. And with that, we
9 are charged with the role of bringing conventions to
10 the great new Cobo Center, the Downtown Detroit area,
11 as well as all of our hotels and attractions throughout
12 the counties.

13 I recently was requested by NACOLE to submit
14 a bid for Fall of 2016. And it is my understanding
15 that this Board had submitted that bid approximately
16 five years ago, and unfortunately we were not
17 successful. I think that at that time, probably
18 Detroit was not poised to actually maybe put ourselves
19 on that national stage. And so before I can move
20 forward to do the great things that our
21 Convention & Visitors Bureau does, it is very important
22 that we have local support from your organization, as
23 well as other organizing committees.

24 In your packets, there is a binder that
25 actually has the full request for proposal that I would

1 like each of you to review. I hate to say that I am
2 giving you homework, but this, unfortunately, is a
3 relatively short timeframe in which we have to draft a
4 host committee.

5 I can tell you that your hotel committee,
6 Cobo Center, the Convention & Visitors Bureau, are
7 attractions. We are ready to host this event.

8 One of the things that we discussed
9 internally is, are you ready? And we feel that we
10 cannot move forward unless you are ready to put Detroit
11 on this grand stage.

12 So I think that there are two things that I
13 would like you all to walk away with tonight, is to
14 have some conversation relatively quickly as to, is now
15 the right time to bring this event to Detroit? And who
16 would be the right individuals to champion that
17 progress or that program with us at the
18 Convention & Visitors Bureau?

19 So as you called up the gentleman from Cobo,
20 obviously, we have a beautiful facility, a beautiful
21 Marriott Hotel that's been renovated, and a pretty --
22 pretty cool downtown now that a lot of people outside
23 of Detroit just don't know about. And so that's my
24 job.

25 And I am going to show you just a brief

1 promotional video. And then from there, I would like
2 to just find out if you have any questions, any
3 immediate thoughts on that.

4 And then certainly with the help of George we
5 can table this conversation for another time that's
6 maybe more appropriate.

7 So thank you for your time.

8 (Video played).

9 MS. CADOTTO: So I don't know about everyone
10 else, but that certainly looks like a location that we
11 want people to come and experience.

12 SECRETARY ANTHONY: Use your microphone.

13 MS. CADOTTO: As I was saying, that obviously
14 looks like a destination that we want people to come
15 and experience.

16 So I think that it is very important that
17 each of you read the request for proposal, because
18 there are not only time commitments, financial
19 commitments, committee commitments. This is a very big
20 deal to bring to Detroit. I am sure many of you have
21 been -- I am not sure if Ainsley wants to share a
22 little bit and we can --

23 MR. CROMWELL: Ainsley Cromwell.

24 I would agree, it is a great time to bring
25 this conference to Detroit. The conference has been in

1 Cincinnati, San Jose, Kansas City. It is going to be
2 in Riverside, California this year, and it is going to
3 be in a convention center similar to this, but not as
4 large and not as beautiful as this center. I really do
5 wish that you could support this activity.

6 NACOLE is a nonprofit organization. It is
7 basically the clearinghouse for civilian oversight of
8 individuals and agencies around the country.

9 Approximately 300 individuals attend the
10 conference each year. And we talk about things in
11 regards to mediation, body cameras, risk management,
12 how to protect civil rights. It supports effective
13 policing. We build bridges, such as the Board of
14 Police Commissioners, in the community, increase
15 confidence with the police, and help manage risk.

16 We are not a bunch of people that wear
17 hoodies and put NACOLE on the back. It is really an
18 education center for individuals in oversight.

19 The training at the national conferences are
20 very intense. I think some of the Board members have
21 attended a few years. And it is a very good
22 organization. And I hope that the community will
23 support this effort and bring the national conference
24 to Detroit. Just want to say that at this time.

25 CHAIRPERSON BELL: Commission, any questions,

1 concerns?

2 COMMISSIONER MOORE: What resources would you
3 need to make this happen? You will be the point
4 person, correct?

5 MR. CROMWELL: Other cities have committed
6 cash, but sometimes it is not just about cash, it is
7 about timing. And sometimes we have had conferences on
8 the West Coast. Now it is time for a conference in the
9 Midwest. We will be competing with other cities. Some
10 of the donations that cities give are in-kind
11 donations, like we will pay for the audio, Cobo Hall
12 might reduce their price, something to that effect.

13 So as many resources or in-kind donations
14 that we can think of to compete with those other cities
15 would be very beneficial.

16 COMMISSIONER MOORE: When would NACOLE make
17 their decision on what city?

18 MR. CROMWELL: Some time around April, late
19 May timeframe. So it is very soon.

20 MS. CADOTTO: Soon.

21 MR. CROMWELL: The request for proposal is
22 pretty detailed. As much community support as we have
23 and show strong interest, I think we have a very good
24 shot. Other cities that I know of, I think Vermont is
25 in competition with Detroit. So it is competitive, but

1 I think we can do it.

2 COMMISSIONER MOORE: Thank you.

3 COMMISSIONER VANN: Mr. Chair?

4 CHAIRPERSON BELL: Yes, sir.

5 COMMISSIONER VANN: I have had the experience
6 of being involved with NACOLE a number of years ago
7 when I first served on the Commission and served as
8 Chair of this Commission. And this would be a really,
9 really good time for us to be able to host this
10 convention and to participate in a real learning
11 experience, as well, for all of us so that we are aware
12 of all of the trends that are going on in civilian
13 oversight boards, just as we are organized here, across
14 the country. We would be able to observe those trends
15 and share best practices, as well.

16 I would hope and urge that we would wrap our
17 arms around this in whatever way we need to. And that
18 we as a Board would endorse the proposal to bring them
19 here.

20 And that possibly, Mr. Chairman, at your
21 discretion, that maybe a committee of the Board would
22 be established to help work with the Convention Bureau
23 and with distinguished Ainsley Cromwell toward making
24 this happen in Detroit.

25 CHAIRPERSON BELL: Any other comments from

1 Commissioners?

2 Yes, sir, Commissioner?

3 COMMISSIONER WHITE: Thank you, Mr. Chair.

4 Just a question as it relates to, has there
5 been any study done as it relates to the number of
6 attendees, the economic impact to Detroit that we can
7 foresee?

8 MS. CADOTTO: You will find in their proposal
9 they were very thorough as far as the number of
10 attendees, their revenue spend.

11 We at the Detroit Metro Convention & Visitors
12 Bureau actually generate a revenue spend. While we
13 would say that a group the size of 300 may not have the
14 largest economic impact as maybe some other
15 organizations, but they are certainly distinguished and
16 powerful. So I believe that maybe not necessarily
17 monetarily, but in the presence of the media, and the
18 presence of our current situation, and certainly where
19 Detroit is going, it will have an undisclosed amount of
20 impact financially for us. Because it will also show
21 other national associations similar that Detroit is
22 certainly a destination for them. And that is what we
23 are trying to accomplish.

24 CHAIRPERSON BELL: Any other comments from
25 Commissioners?

1 COMMISSIONER MALLETT: Mr. Chairman, on
2 page 3, Andrea, of the proposal, it says financial
3 contribution.

4 MS. CADOTTO: Yes, sir.

5 COMMISSIONER MALLETT: This particular entity
6 does not have as much budgetary control as we might
7 like. We certainly don't have a discretionary budget
8 where we can commit the City of Detroit to a
9 contribution. But obviously, this is not the first
10 organization of its kind to make a demand like that.
11 So you are not surprised. So how have you managed this
12 kind -- what is the normal industry response to this
13 kind of --

14 MS. CADOTTO: Well, I think most of these
15 organizations always ask for the sky. And then we try
16 to come somewhere in the middle.

17 I think one of the things that Detroit is
18 very strong in is that we have large community support,
19 as many of you are involved in other organizations or
20 have maybe seen other events come to Detroit. There is
21 some sort of corporate sponsorship that can be obtained
22 in some cases. There are sometimes negotiations done
23 between hotels and convention centers to rather than
24 give a cash donation, reduce the organization's overall
25 cost.

1 COMMISSIONER MALLETT: And so your
2 organization manages that on behalf of an entity like
3 ours?

4 MS. CADOTTO: That is correct.

5 COMMISSIONER MALLETT: So that if we were to
6 vote to support this and the Chairman then established
7 a committee, there would be recognition that in the
8 absence of an appropriate -- appropriation from this
9 body, which we can't make, and certainly don't have the
10 money, then they would be directed elsewhere to find
11 what they need?

12 MS. CADOTTO: That is correct.

13 COMMISSIONER MALLETT: So at the end of the
14 day, what you want from us is a letter of support, and
15 the appointment by the Chairman of a committee or
16 persons interested in making this happen?

17 MS. CADOTTO: Yes. I need resources.

18 COMMISSIONER MALLETT: Mr. Chairman, I have
19 got enough to read. Why don't we just vote on this and
20 take volunteers who want to be on the committee?

21 MS. CADOTTO: Do I get to vote? Because I am
22 all for that.

23 CHAIRPERSON BELL: The Chair would entertain
24 a motion to the effect. I just want to say, it is not
25 about the monetary.

1 MS. CADOTTO: That is correct.

2 CHAIRPERSON BELL: We hosted a conference
3 here about 20 years ago under Coleman A. Young, Chief
4 Hart, of the National Black Police Association.

5 MS. CADOTTO: Which we would like them to
6 come back, as well.

7 CHAIRPERSON BELL: Right. So I was one of
8 the major coordinators, and they had a great time here
9 in Detroit.

10 In this day and age, I think they would have
11 a better time in Detroit, because Detroit is rather
12 unique in terms of what we offer.

13 So the Chair would entertain a motion to the
14 effect to host -- I mean, put in a bid for 2016, host
15 NACOLE.

16 What is your pleasure?

17 COMMISSIONER DEWAELSCHE: So moved.

18 COMMISSIONER VANN: I so move, sir.

19 CHAIRPERSON BELL: Okay.

20 COMMISSIONER DEWAELSCHE: Support.

21 CHAIRPERSON BELL: I guess the court
22 reporter -- okay. Who made the main motion?

23 COMMISSIONER DEWAELSCHE: I did.

24 CHAIRPERSON BELL: Okay. Made by
25 Ms. Dewaelsche. Commissioner Vann, second?

1 COMMISSIONER VANN: Yes.

2 CHAIRPERSON BELL: Okay. We ready. Motion
3 is on the floor.

4 Ready for the question. Those in favor, aye.

5 COMMISSIONERS: Aye.

6 CHAIRPERSON BELL: Those opposed?

7 Motion carried.

8 So no brainer on that one.

9 MS. CADOTTO: Thank you.

10 CHAIRPERSON BELL: And it is good timing that
11 we are meeting here tonight, not knowing the timeframe
12 that we have to submit this in 2000 -- I mean, shortly.
13 I mean --

14 MS. CADOTTO: I have my work cut out for me,
15 the next couple of weeks, expect a phone call.

16 CHAIRPERSON BELL: And I know that Ainsley
17 Cromwell will be lobbying. He is our National Vice
18 President involved and George Anthony is involved. And
19 so this is good timing. We must go forward. So I am
20 pleased that the Board has taken the initiative. You
21 can do your homework a little bit later. And we will
22 formulate a committee dealing with this situation.

23 Thank you, once again, for bringing this to
24 our attention.

25 Thank you, George.

1 MS. CADOTTO: Thank you.

2 CHAIRPERSON BELL: And thank you, Ainsley.

3 Ainsley, would you circulate information
4 about the national organization NACOLE, please? Thank
5 you.

6 And the next item of business would be
7 Assistant Chief Dolunt.

8 A.C. DOLUNT: Okay. Assistant Chief Dolunt,
9 here on behalf of -- through the Chair, on behalf of
10 Chief Craig, who was at the NACOLE conference down in
11 Atlanta.

12 And I guess you have a surprise for me.
13 Because I have no idea what you are talking about, the
14 big event. So what was the big event?

15 UNIDENTIFIED SPEAKER: (Inaudible).

16 A.C. DOLUNT: The what? Oh, the thing on
17 Tuesday? I knew about that, okay.

18 CHAIRPERSON BELL: The Call to Action.

19 A.C. DOLUNT: Okay. There's so many big
20 things that happen around here.

21 CHAIRPERSON BELL: Okay. I am not aware of
22 that. But I know I was at this big affair.

23 A.C. DOLUNT: Okay. Well, a couple of
24 things. First of all, it has been a brutal two weeks,
25 and it started with the six shootings at the club on

1 Chalmers. However, the officers that responded did a
2 great job. We had two people in custody in a couple of
3 hours. And I believe a 12-count warrant was signed
4 against these individuals. These two, quote, unquote,
5 citizens felt they could just go out and rob and shoot
6 people indiscriminately for no reason allegedly. So I
7 am hoping that the justice system works quickly. And
8 that these individuals are not going to be released out
9 to the community, because these are innocent citizens.
10 I can honestly say that these guys were preying on
11 innocent people. And that bothers me a lot.

12 Some people, I am not saying anyone should be
13 shot, but some people are doing nefarious deeds out
14 there, as they say. And these individuals took
15 advantage of law-abiding citizens.

16 The next night we had a double kidnapping
17 again from Indiana. The officers went out there and
18 did a fantastic job. And I believe five or six of
19 those individuals were charged, Federally.

20 Unfortunately -- and then several days later,
21 the judge, federal judge, was shot. And that's a crime
22 pattern we have been working on for a while.

23 And that led to the meeting on Tuesday. The
24 attendance was phenomenal. And we need more of that.
25 The citizens have come out en masse and truly care.

1 And that's a good neighborhood, and it is around the
2 city, most of our community organizations, most of our
3 neighborhoods are really engaged.

4 It is a very small percentage of people that
5 commit the majority of the crimes, as most of you know
6 that. And they feel they can get away with literally
7 murder, because some of the sentences are not as harsh
8 as they should be. And while I am a proponent of
9 rehabilitation, some individuals don't want that
10 opportunity. They don't want to get a job. And they
11 prey on senior citizens, and young kids trying to get
12 their act together to go to school.

13 And I think the thing that bothers me more
14 than anything is that these individuals have
15 grandparents too. And how would they feel if their
16 grandparents were subjects of brutal crimes? And I
17 don't think they think about that. So that's what
18 bothers me.

19 And that being said, the big thing I thought
20 you were talking about was the cameras, the body
21 cameras. We are rolling that out tomorrow in the 11th
22 Precinct. And luckily, Assistant Chief White is here.
23 So if there is anything that you wanted to ask him, I
24 mean, I think that's a big thing based on where we are
25 at.

1 CHAIRPERSON BELL: Well, I just want to --
2 before you bring up Assistant Chief White, I just want
3 to -- the Call for Action against crime, town hall
4 convening at the Detroit Golf Club, was really
5 outstanding in terms of a short notice. And there had
6 to be about 400 to 500 people there. And I want to
7 thank Commissioner Vann for his attendance, Linda
8 Bernard for her involvement. And the Commission had
9 the opportunity to speak, and I can't say enough in
10 terms of the Chief, Deputy Chief Hall, all -- Captain
11 Balinski in terms of their respond to that type of
12 gathering.

13 And my understanding that there will be other
14 gathering in other parts of the city, and -- but if
15 that's a measurement of a community coming together, I
16 was impressed by a short notice. And they must have a
17 tremendous networking there.

18 And there was dialogue with NPO's, with the
19 security officers there. As you know, they have
20 security from the University District to Sherwood
21 Forest Department.

22 I think, though, Commissioner Vann live in
23 that neighborhood, I heard a rumor that he live in that
24 neighborhood. And Commissioner Conrad Mallett live in
25 that neighborhood. But it was -- I recognized several

1 individuals from the police department, other -- some
2 of my neighbors, church members. And it was just
3 really a fantastic concern in terms of not just the
4 judge being shot, but there was other instance that
5 they were concerned, and there was a crime prevention
6 component that they talked about in terms of working
7 with the security force, with the block club, and the
8 Crime Prevention Officer Sergeant -- what's his name?
9 Sergeant --

10 UNIDENTIFIED SPEAKER: Brian --

11 CHAIRPERSON BELL: -- he just fantastic in
12 terms of breaking it down. So I hope to use him on the
13 East Side when we have one of those forum, but he do an
14 excellent job.

15 But the program was really meaningful I think
16 in terms of trying to maintain people who live in the
17 city of Detroit and trying to stay in the city of
18 Detroit. When something happening, you know, they need
19 to get the Police Departments available and responding.

20 And I just appreciate the Department giving
21 me an opportunity to speak to the Board of Police
22 Comission, pass out literature, that type of
23 interfacing. That we want to continue to work together
24 because we all are concerned about public safety. And
25 DPD is on the cutting edge in terms of reaching out to

1 the community. I want to say that over and over again.
2 So therefore, it was not an adversary role.

3 I hear about what's happening in Ferguson.
4 We just pray that they can reach some type of
5 understanding, that -- because that type of violence,
6 that type of shooting of police officers, is totally
7 unacceptable. I know people want to protest, you have
8 got people like that engaging that type of conduct. It
9 just sends a wrong message to all people that want to
10 protest in a lawful, orderly manner. We just up come
11 from southern Alabama, I know people attended, like
12 Linda. There was no issue there. Young and old, black
13 and white, people from all walks of life, celebrating
14 an occasion.

15 But as the President stated, we must go
16 forward. We must go forward. We all in this together.
17 We must build those bridges.

18 So I just wanted to share that with you in
19 terms of my observation, my participation, and my
20 concern about what's happening in this country. That's
21 why I think the civilian board has a significant role.
22 And thank you for allowing me to speak to that.

23 Chief White?

24 A.C. WHITE: Thank you, Assistant Chief
25 Dolunt.

1 Good evening, Board.

2 I have presented this information to you
3 before. But for the benefit of the audience, I would
4 just highlight very briefly how we are moving forward.
5 I would like to say I am going to go off script. There
6 really isn't a script for this process, what I have to
7 present tonight. I am very, very proud of our officers
8 in the Detroit Police Department. I won't say that we
9 are the only agency in the country, but I don't know of
10 many agencies where the police officers have brought
11 the idea of body cameras to management.

12 Our agency was approached about a year ago
13 from a police officer, from the 2nd precinct, Officer
14 Session, who said, hey, this is something we need to
15 look at. It might be a good idea for the Police
16 Department.

17 At that time, we piloted it with a company by
18 the name of Taser. A lot of people think that Taser is
19 just a Taser gun. But Taser is actually the company,
20 and the weapon that they make is commonly referred to
21 as a taser, but they also do the body camera. We did
22 that for a year. Some things that we liked, some
23 things that we were not too excited about at the time
24 because the technology was growing. And at that
25 particular time, it didn't meet the needs that we were

1 looking for.

2 So we did a more aggressive, more -- I guess
3 you would say more aggressive pilot this year. We put
4 an RFP out. A very transparent process where
5 basically, list the needs that you have for your
6 agency. And all companies are allowed to participate.
7 Put out the RFP. We received a total of seven
8 companies that were interested in participating.

9 Of the seven companies, once we set down with
10 them and talked to them about what was needed, five of
11 them said, yes, we can do that. We can meet your
12 needs.

13 After we sat down with five companies again
14 and said, okay, this is how we are going to pilot, only
15 three companies were able to meet our needs. One is
16 Taser International. The other is Data 911. For some
17 reason, the third company is escaping me, but I can
18 provide the name. I sent it in an e-mail.

19 SECRETARY ANTHONY: Innovative Solutions.

20 A.C. WHITE: Innovative Solutions. Thank
21 you, sir.

22 And one of the key things I wanted to
23 accomplish, certainly post-bankruptcy, not a lot of
24 money available, we wanted a company that was able to
25 pilot with us free of charge, let us test the

1 equipment, let us break the equipment, let us see how
2 it works with our officers. I say that somewhat tongue
3 in cheek, but it is important to see how the equipment
4 is going to respond to real life situations, when
5 officers are chasing people, officers drop the
6 equipment. We want to get into what happens if an
7 officer tries to deactivate the system purposely. We
8 want to do a lot of different things to the equipment.

9 So we get the participants for that. We are
10 going to do a total of three companies. Each company,
11 we are going to participate -- or each company will
12 participate in the pilot for 30 days. The pilot will
13 be a total of 90 days.

14 And then at the end of 90 days we will
15 present to this Board, as well as City Council, a
16 budgetary strategy to make cameras reality for the
17 Police Department.

18 A couple key points for the Board to be aware
19 of. The officers are operating with a draft policy.
20 Not a policy that's solidified yet. And we wanted to
21 do that to give us the flexibility as we go through the
22 process. There are some things that won't change. The
23 officers will use the cameras while interacting with
24 citizens. However, with a few stipulations. If there
25 is a victim of certain crimes, like child abuse, sexual

1 assault, those citizens will not be videotaped under
2 any circumstances, for obvious reasons.

3 If videotaping a citizen compromises an
4 investigation, such as a homicide investigation,
5 someone says, you know, I have some information for
6 you, but I don't want to be taped, we have given the
7 officers the flexibility to not tape those citizens.
8 We are going to study that to see how that works.

9 And then lastly, citizens will be made aware
10 when we knock on your door, we are wearing a camera.
11 We will come in and provide police services. If a
12 citizen requested to turn a camera off, we will turn a
13 camera off and continue to provide the police service.
14 However, with that one, the last thing we should see on
15 the camera is the citizen requesting to turn the camera
16 off. So we don't want officers having the ability --
17 not that I think they would, but we don't want officers
18 having the ability to flick the camera off and say that
19 we were asked without seeing that request come through.

20 Again, we are very excited about this
21 opportunity, very proud of our officers. What's
22 happening around the country I think is no secret.
23 This is going to further enhance our transparency.
24 It's going to allow us to show our stories, show our
25 interaction with our citizenry. We are not perfect.

1 There are going to be mistakes. I am not standing
2 before this Board saying that there won't be videos
3 that show officer misconduct from time to time. But
4 overwhelmingly, overwhelmingly our officers do an
5 outstanding job. And, you know, we are very confident
6 that this will be a win for the city.

7 Any questions?

8 COMMISSIONER MOORE: Through the Chair.

9 CHAIRPERSON BELL: Yes.

10 COMMISSIONER MOORE: What is the
11 functionality of the camera? Is it a live download or
12 is it stored, the video stored in the camera? What's
13 the actual --

14 A.C. WHITE: The answer to that is yes,
15 different cameras have different functionalities, one
16 of the things we are going to study. But the feed
17 uploads to a Cloud base. And if I may ask a question
18 of -- I see one of our tech people in our audience, I
19 believe one of them.

20 (Inaudible).

21 A.C. WHITE: Thank you.

22 COMMISSIONER MOORE: Thank you.

23 COMMISSIONER DEWAELSCHE: I have a question.

24 CHAIRPERSON BELL: Yes, ma'am.

25 COMMISSIONER DEWAELSCHE: How will the camera

1 be secured on the body? I mean, have you decided on
2 the lapel cameras? Because I thought I read something
3 about cameras on glasses.

4 A.C. WHITE: Yes, ma'am. We have not made a
5 permanent selection of which style we will go with. We
6 will test all three options. One option being the
7 lapel. One option being the glasses. And then the
8 other option is just a little square block that the
9 officer will wear right on his chest or her chest.

10 COMMISSIONER DEWAELSCHÉ: And how will it be
11 secured?

12 A.C. WHITE: The clips. They clip on. The
13 eyeglass option has a magnet attached.

14 COMMISSIONER DEWAELSCHÉ: So if there is like
15 some activity, running, would it easily fall off or --
16 I mean, is it going to be that secure with clips? I
17 guess I can't imagine it --

18 A.C. WHITE: That's one of the things we want
19 to test. And if we find that, that will guide our
20 selection. If we find that the officers are losing the
21 cameras through foot chases, then it may push us to
22 make a selection to a more sturdier clip.

23 COMMISSIONER WHITE: Mr. Chair?

24 CHAIRPERSON BELL: Yes, sir.

25 COMMISSIONER WHITE: Thank you.

1 Chief White, given that this is our second go
2 round as it relates to a pilot, what type of data
3 research analysis is readily available for our review
4 from the first trial?

5 A.C. WHITE: To be frank, sir, the first
6 trial was really kind of fish in the water, so to
7 speak. We did not do a comprehensive analysis. We did
8 an after action report. That was basically anecdotal.
9 We didn't get what we wanted from that first study.

10 This study will provide the data I think that
11 we are looking for in terms of officer usage. The
12 interaction -- we are going to study the interaction
13 with the citizens. We are going to study citizen
14 complaints. And we are also going to study the
15 officers' behavior with the camera. And I think once
16 we get that, I will be able to provide the Board with
17 more information. I would not want -- I can give you
18 the first data. You are not going to get much from it.

19 COMMISSIONER WHITE: Okay. The second
20 question I had was related to the draft policy.

21 A.C. WHITE: Yes, sir.

22 COMMISSIONER WHITE: And just if you could
23 speak to a little bit more to why are we considering a
24 draft policy? Is there any precedence for us having
25 that? And if so, how do we hold the officers

1 accountable to a policy that is not enshrined in an
2 SOP?

3 A.C. WHITE: Excellent question.

4 The draft policy, which is a live document
5 that we will certainly massage out as needed, it will
6 not change from its current standing, daily. So let me
7 say that again. Today, the draft policy is the policy.
8 Okay. So you are to adhere to the rules and
9 regulations of this policy today.

10 If we find a need to change the policy as we
11 go through the process, we wanted to leave it in a
12 draft mode and not solidify the policy. But we may
13 change certain aspects of it, and rerelease it again in
14 draft mode. So if we make a change and there are
15 additions or deletions a week from now during the test,
16 then that policy will be reissued in draft mode to the
17 officers to follow during that period of time.

18 COMMISSIONER WHITE: Thank you.

19 And through the Chair, Assistant Chief, I
20 guess I would ask, Mr. Chair, I would ask that this
21 body be provided a copy of that draft policy prior to
22 the trial being implemented.

23 A.C. WHITE: I have already sent it to the
24 Board.

25 COMMISSIONER WHITE: I apologize. It was

1 forwarded to us.

2 A.C. WHITE: Yes, sir.

3 And also as pointed out by Deputy Chief
4 LaValley, we operate under the training directive, the
5 training directive and special order mode. And that is
6 a solid directive that gives the officers direction on
7 how to conduct themselves on a daily basis.

8 CHAIRPERSON BELL: Any other comments,
9 Commissioners?

10 COMMISSIONER CARTER: Through the Chair.

11 Assistant Chief White, have the officers been
12 selected yet that are going to do the trial?

13 A.C. WHITE: Yes, ma'am.

14 COMMISSIONER CARTER: And is it the same
15 officers who did the trial -- the first trial?

16 A.C. WHITE: No, ma'am.

17 COMMISSIONER CARTER: Okay. Thank you.

18 I am sorry, will they be the same officers
19 that will test each camera?

20 A.C. WHITE: Yes.

21 COMMISSIONER CARTER: Okay.

22 COMMISSIONER MOORE: On three different
23 shifts?

24 A.C. WHITE: Yes. And including three
25 services.

1 CHAIRPERSON BELL: Any other?

2 COMMISSIONER DEWAELESCHE: I have one more
3 question. When the camera is turned on and off, will
4 there be a signal of some sort, a light or a buzz
5 or -- because if the officer is turning it off and on,
6 they may forget.

7 A.C. WHITE: Yes. To answer your question,
8 yes, there will be a signal for the officer. The
9 officer will know when the camera is in operation and
10 know when the camera is off. And that was one of the
11 things that we wanted to study too. We want to
12 integrate this with our in-car system. This will not
13 replace our in-car system. It will be an enhancement.
14 We don't want the officers pushing a lot of buttons
15 trying to remember out what camera to turn on. We want
16 their engagement with citizens to be a safe and
17 professional engagement. So we want to make sure we
18 can integrate whatever system we choose to the in-car
19 system.

20 COMMISSIONER DEWAELESCHE: Thank you.

21 CHAIRPERSON BELL: Yes, sir?

22 COMMISSIONER CRAWFORD: Yes, through the
23 Chair.

24 Have you heard any concerns -- well, not
25 those that are testing or part of your pilot program,

1 but just concerns from the union or officers in general
2 about this technology, this -- that is coming, and will
3 be here soon obviously, from the officers, from the
4 perspective of Big Brother, I have got you moment, we
5 have got video of you in the car talking about -- I
6 mean, something that's not even really relevant to the
7 work, nature of the work? Have you --

8 A.C. WHITE: Well --

9 COMMISSIONER CRAWFORD: Well, it's too early.
10 I have read some postings on Facebook, to be truthful.

11 A.C. WHITE: We all have. But I want to
12 frame that in its appropriate perspective. Any change
13 in any organization, whether you are a police officer
14 or barber or doctor, if you bring in wholesale change,
15 you are going to have resistance, you are going to have
16 pushback. I think, you know, in your profession, I am
17 sure, if you make a bunch of changes in your operation,
18 you know, you are going to make some people happy, some
19 people not so happy.

20 But overwhelmingly, you know, the officers
21 understand this technology and they understand, you
22 know, we are trying to do a good job. There is going
23 to be times when we don't.

24 I think what we as managers must do is not
25 major in the minor. I cannot hold an officer

1 accountable for not liking Assistant Chief James White
2 if I find that in the video. What I am looking for is
3 conduct. I am looking for the officer to engage in
4 appropriate conduct and be professional in representing
5 the Detroit Police Department appropriately. And
6 whether or not he wants to have dinner with me or hang
7 out with me, that's irrelevant.

8 And I think we lose the officers' trust if we
9 major in the minor and start disciplining them for
10 issues that have absolutely nothing to do with doing
11 their jobs effectively.

12 So what my commitment is, in earning the
13 officers' trust, is that we will not major in the
14 minor. That we will focus solely on the investigations
15 that are in front of us. And if there's misconduct, we
16 will address the misconduct appropriately.

17 COMMISSIONER CRAWFORD: Thank you.

18 I just want to add to that. I am glad to see
19 that the -- well, this is the second time for the pilot
20 program, but other cities, smaller departments already
21 have them. They have had them for a while. I think
22 Detroit would probably be maybe one of the first major
23 cities, once this is -- major city police departments
24 too, once the officers throughout this department are
25 fitted with body cameras. So it is like on the

1 forefront of some of the new cutting edge technology.

2 And, of course, the accountability and
3 transparency is, in my opinion, the ultimate. And
4 those of us that have attended the conference last
5 year, in Kansas City, this was one of the main issues
6 that they talked about. And as you know, even before
7 the conference, this was the communication coming from
8 the White House from the President and from the Senate
9 and the Congress.

10 Just wish they were also sending some money.
11 Haven't heard of that as of yet. But, you know, that
12 was the talk. So talk is cheap. Send some money, too.

13 A.C. WHITE: Yes, sir.

14 CHAIRPERSON BELL: Any other comments?

15 COMMISSIONER MOORE: Just one final one. Was
16 there any type of legal input or opinion?

17 A.C. WHITE: Yes, sir. Deputy Chief
18 Washington, myself, and the City of Detroit Law
19 Department all worked together to put this policy
20 together.

21 COMMISSIONER MOORE: Thank you.

22 A.C. WHITE: I do want to clarify one thing,
23 if I may, through the Chair, to Commissioner White. I
24 may have mischaracterized the policy, our training
25 directive. Give me the right word.

1 D.C. LAVALLEY: Special order.

2 A.C. WHITE: Thank you. I am doing it again.

3 So the special order is what the officers
4 will be held to, and as you know, we have a year to
5 implement policy after issuing a special order. So
6 that will not change. If there is a violation of that
7 special order, officers can be held accountable.

8 COMMISSIONER MOORE: Thank you.

9 COMMISSIONER WHITE: Mr. Chair, there was one
10 additional question that was put forth by our staff.
11 Is there an opportunity for this body and/or OCI, given
12 that they will have probably more of a direct
13 correlation as this process moves forward to
14 implementation, an opportunity for a presentation of
15 the functionality and/or the capabilities of this
16 equipment?

17 A.C. WHITE: Absolutely. We would love to do
18 it. I will have my staff reach out and put that
19 together immediately.

20 COMMISSIONER WHITE: Thank you.

21 CHAIRPERSON BELL: Any other questions?

22 I think all those were excellent questions
23 and concerns. Because we was exposed to with the pilot
24 program, and also in Kansas City, that was a major part
25 of their training seminar.

1 And I just want to add, Commissioner, you
2 have in your package, there is going to be a conference
3 dealing with that, Body Cameras and their Importance in
4 Building Community Trust, so it's a regional training
5 network opportunity. You have that information.
6 That's going to be held on April the 2nd -- April
7 the 7th in Akron, Ohio. So this is oversight in Akron.
8 So we have an opportunity to attend that one-day
9 session. And hopefully, one or two of us will take
10 advantage of it. I know Supervisor Ainsley Cromwell is
11 going to be attending. And maybe one or two
12 commissioners can make that one-day trip and get more
13 exposure in terms of what they offering in terms of
14 this seminar. That will help us in terms of
15 preparation in terms of -- I don't see any issue. I
16 think it is something that's welcome. I know our
17 officers enthused about in terms of officers' -- the
18 complaints we get, the demeanor, you know, all that
19 would be very helpful, not just with citizens, but also
20 to the police officers involved, it would dispel some
21 of the allegations perhaps. So I think this is on the
22 cutting edge, like you say, this is a national trend.
23 So thank you for bringing it to our attention and
24 involving us in this process.

25 A.C. WHITE: Thank you very much.

1 CHAIRPERSON BELL: First Precinct. Another
2 one of my favorite captains, Petty.

3 CAPTAIN PETTY: Good afternoon. How is
4 everybody doing?

5 COMMISSIONER WHITE: Good.

6 CAPTAIN PETTY: I am going to be brief,
7 talking about the First Precinct. Before we start with
8 my slide, I would just like to say First Precinct is
9 unique. It is different than the other precincts. It
10 is an international border, for one, which is critical
11 since 911. That's a major, major key component to the
12 city.

13 Another caveat to that is downtown, on any
14 given day, you can have a million people down here for
15 fireworks. To answer Bruce's question, we had over
16 800,000 people for the Auto Show. Last weekend, we had
17 over a hundred thousand. So on any given weekend you
18 have that many people coming downtown to enjoy
19 downtown, to go to sporting events, to go to concerts,
20 to go to dinner, to go to casinos, even to come through
21 Detroit to go to Windsor. So that makes the First
22 Precinct a key component when people come to Michigan,
23 and come to Detroit, specifically, they end up
24 downtown. Usually they are going to a family -- even
25 if they go to a family reunion, they end up at Belle

1 Isle. That's still sort of downtown. So downtown is a
2 key component to Detroit, and to Michigan.

3 That being said, our inception was
4 March 31st, 2014. So we will have a birthday in 19
5 days, I believe it will be, that will be the first year
6 that it has been running as the First Precinct this
7 time around.

8 That's a map. There is a -- First Precinct
9 has three scout car areas. Our borders are Mack, Mack
10 and Myrtle on the north. The Lodge on the west. 375
11 on the east. And the river on the south.

12 First Precinct is not only the gateway to the
13 City of Detroit, but for many of our neighbors and
14 allies to the north, it serves as their gateway to the
15 United States. The First Precinct supports the Detroit
16 Windsor Tunnel. It is the second busiest crossing
17 between United States and Canada, after the nearby
18 Ambassador Bridge. Approximately 13,000 vehicles use
19 the tunnel daily.

20 The 2004 Border Transportation Partnership
21 study showed that 150,000 jobs in the region and 13
22 billion in annual production depend on the Windsor
23 Detroit International border crossing.

24 The First Precinct also supports three
25 professional sports teams: Tigers, Lions, Red Wings.

1 And also multiple casinos, countless theaters and other
2 live entertainment.

3 The precinct is two square miles roughly.
4 First Precinct has several entities under its span.
5 You have Patrol, you have Planning, you have Events,
6 Neighborhood Police, and Downtown Services Division
7 Motor and Gaming Operations.

8 Patrol: Uniform patrol component proactively
9 patrol in the downtown area. Officers respond to
10 citizens' calls for service in emergency and
11 nonemergency situations.

12 The primary mode of patrol is vehicular.
13 However, patrol is also patrol on bicycles and foot
14 beats. In downtown, we still have the traditional foot
15 beats. There are several in the downtown area:
16 Riverwalk, Harmonie Park, which is Paradise Valley now,
17 Compuware, financial beats, and Greektown. Just to
18 name a few. The uniform patrol component proactively
19 patrols downtown.

20 Excuse me. Planning entity consists of six
21 police officers and one sergeant. These officers serve
22 as ambassadors for the city. They are also responsible
23 for planning and executing Operation Action Plans for
24 all major events.

25 Some of these responsibilities include: The

1 Fireworks, North American International Auto Show,
2 Thanksgiving Day Parade, Angels Night, Tigers' Opening
3 Day, Free Press Marathon, St. Patrick's Day, and
4 citywide elections, just to name a few.

5 Planning personnel not only serve as
6 Department liaisons with our business partners to help
7 facilitate some of the large events just mentioned, but
8 they also are our liaisons with other units of
9 government when major activities occur.

10 First Precinct Planning: The work in
11 conjunction with the U.S. Secret Service to coordinate
12 visits from the President, heads of state. They also
13 work on films, motion pictures, commercials, videos.
14 We do funerals for fallen officers, city dignitaries,
15 former Mayor Coleman Young, Rosa Parks, Brenda Scott,
16 just to name a few.

17 First Precinct events: That's my traffic
18 component. They do traffic details in and around the
19 downtown area, including Comerica Park, Joe Louis, Fox,
20 St. Andrews Hall, Cobo, Ford Field, Music Hall, Gem
21 Theater, Fillmore, Orchestra Hall, and Detroit Opera
22 House.

23 These officers successfully ensure the safe
24 and orderly flow of traffic and adequate safety for
25 each spectator attending events.

1 Uniformed presence and traffic coordination
2 around the area of any protest or demonstrations.

3 Proactive policing and enforcement around the
4 nightclubs in downtown is also provided.

5 Downtown Services Division. That's my
6 traffic enforcement. Those are the guys that
7 unfortunately give you guys tickets. They do a great
8 job. They make sure that we are safe, as well. They
9 respond and investigate crashes. They do weights and
10 measures to make sure the trucks are weighted properly.
11 Motor also does escorts for funerals. Traffic details
12 surrounding dignitaries. Motor also assists units as a
13 secondary proactive crime reduction unit.

14 NPO, Neighborhood Policing Officers, they are
15 tasked with the following: They do investigations for
16 petitions; they work in partnerships with beat
17 officers, businesses, community groups, clergy, for
18 neighborhood support; they liaison with residents and
19 business owners; they participate in youth groups,
20 programs and events; develop neighborhood and business
21 watch groups; and answer calls for service as needed.

22 They also assist in doing security
23 evaluations for businesses and homes in the downtown
24 area. So neighborhood policing can go in and do
25 security assessments and design and tell you what you

1 need as far as alarms, locks on your doors and windows,
2 even your cars your garages.

3 Gaming operations: They pretty much handle
4 everything in and around the casino. They handle the
5 parking lots of the casinos. Make sure the patrons
6 that come down there have a good time, actually have a
7 good time. Monitor, deal with panhandlers and homeless
8 people. They deal with traffic in and around the
9 casinos specifically.

10 There are multiple facets that make up the
11 First Precinct: Patrol, Planning, NPO's, Events and
12 Downtown Services and Gaming. Each entity provides
13 critical services that make the precinct work as a
14 whole.

15 As the City continues to add its residential
16 population, businesses continue to relocate to
17 downtown. With new businesses continuing to start up
18 in downtown and with the rapid resurgence of downtown
19 hotels, restaurants, and entertainment scene, we
20 believe Detroit's comeback is in full bloom.

21 We, the men and women of the First Precinct,
22 stand prepared to do whatever we can to ensure
23 Detroit's comeback is sustained.

24 Turn on the mic so I can -- I am going to
25 introduce a few of my guys, ladies that work for me. I

1 have from patrol, I have Paul Jones, who is my
2 lieutenant on afternoons. I have Officer Evans in the
3 doorway and Officer Walker who are part of the
4 Planning. I have my Downtown Services guy (inaudible).
5 I have Officer Wilson, who is my right arm. She is
6 part of the Planning, as well. And Sergeant Carter.
7 These are some of the folks of various units that I
8 have (inaudible).

9 CHAIRPERSON BELL: I have one question right
10 off the top.

11 CAPTAIN PETTY: Yes, sir.

12 CHAIRPERSON BELL: Do you think we could host
13 this conference in 2016?

14 CAPTAIN PETTY: I know we can.

15 CHAIRPERSON BELL: With all your experience.

16 CAPTAIN PETTY: Yeah, we can handle it.

17 CHAIRPERSON BELL: Commissioners, any
18 comments, questions in reference to Captain Petty?

19 COMMISSIONER VANN: Mr. Chair?

20 CHAIRPERSON BELL: Yes, sir.

21 COMMISSIONER VANN: I just wanted to try to
22 assess your cooperative relationship with other
23 agencies that work in public safety downtown, with the
24 DPD, for example, with maybe WC3 and others, do you
25 have that same kind of cooperative relationship that

1 exists in Midtown?

2 CAPTAIN PETTY: Yeah, I work with Chief
3 Mohamad. I work with Harold Love, Downtown
4 Partnership. I work with Mr. Mark Hall from Border
5 Patrol. Work well with Secret Service. All of the
6 agencies that are pretty much downtown, in some facet,
7 we work together. Usually during Fireworks, I get
8 resources. I work with Chief Tony from Highland Park.
9 There is not too many folks I don't work with. I have
10 a good working relationship with all of them.

11 COMMISSIONER VANN: Good.

12 CHAIRPERSON BELL: Any other questions,
13 concerns?

14 Commissioner.

15 COMMISSIONER WHITE: Mr. Chair.

16 Thank you, Captain. It's been a very
17 informative report. Specifically related to the
18 stadiums downtown, are we policing externally or both
19 externally and internally?

20 CAPTAIN PETTY: It is a combination. We do,
21 depending on the event, some, we go inside. So, for
22 example, like a World Series, or a playoff game, we put
23 manpower inside. On most games, we are from primarily
24 outside with a small contingency inside, with the
25 exception of Ford Field, who uses secondary for their

1 inside patrol. And we handle the traffic at that
2 venue.

3 COMMISSIONER WHITE: Captain, you may not be
4 able to answer this question, but I will pose it anyway
5 for the purpose of the record.

6 And maybe, Mr. Chair, we can get it answered
7 at a later date.

8 For venues where we are policing inside, is
9 that a revenue-generating opportunity for the City of
10 Detroit or -- I know there was an issue at one point
11 where there were venues that were not paying the
12 Department for its services rendered. And to your
13 knowledge, is that a revenue opportunity for where we
14 are policing internally?

15 CAPTAIN PETTY: With secondary, we get a
16 percentage of whatever the fee is. I don't want to
17 misquote it, but there is a small fee attached to every
18 officer, every hour. So that is some money brought in.

19 Most of the others, like for Joe Louis, for
20 example, we probably put three people inside. Cover
21 the locker rooms. It is not reimbursed. So could it
22 be? Yes.

23 COMMISSIONER WHITE: Thank you.

24 CHAIRPERSON BELL: Commissioner Crawford?

25 COMMISSIONER CRAWFORD: Through the Chair.

1 Talk about secondary employment. Mike
2 Ilitch, who owns the Wings and the Tigers, for years,
3 as a matter of fact, I think I recall when Benny
4 Napoleon was the Police Chief, one or two engaged in
5 that secondary employment for the entire stadium inside
6 and outside. And so I guess today you are saying there
7 is just a few in Ford Field.

8 CAPTAIN PETTY: Ford Field has a large
9 contingency. Numbers could be 50 or 60.

10 Joe Louis, it is mostly external traffic,
11 with the exception, like I said, of two or three on the
12 average. And when it becomes a rap concert, dynamics
13 change. But for the most part, you have a locker room,
14 you have one assigned to the locker room. And then you
15 have a detention room. So those are three posts that
16 are usually associated with Joe Louis.

17 COMMISSIONER CRAWFORD: Historically, other
18 major cities have been doing it for years. I know for
19 a fact Atlanta, back in the '80s, was doing it, even
20 before the '80s, still today, that downtown stadiums,
21 basketball, football, and baseball, it is totally
22 secondary employment. I mean, which is a win for the
23 Police Department, it is a win for the business
24 community.

25 And it appears that there still needs to be

1 some work done here. If, you know, we are detailing
2 officers for the inside of the stadium, in particular,
3 and outside also, the outside I understand sometimes
4 with the traffic, you know, maybe some sort of
5 liability in terms of us, you know, perhaps we
6 should -- they want to do the traffic, move the
7 traffic.

8 But in terms of the inside those stadiums,
9 you know, perhaps one day we will complete that where
10 all of the inside personnel -- because in terms of
11 numbers, what Detroit Police Department commits to
12 security during an event, a baseball game or a hockey
13 game or something like that, is -- I don't know the
14 numbers of people, so I mean there is a contingent of
15 officers that are on duty, correct, that are --

16 CAPTAIN PETTY: Say that --

17 COMMISSIONER CRAWFORD: -- that are assigned
18 to cover, there is a contingent of officers that are
19 assigned to cover those events for security still
20 today?

21 CAPTAIN PETTY: Well, just traffic.

22 COMMISSIONER CRAWFORD: Just traffic?

23 CAPTAIN PETTY: Yeah. I don't have any --
24 for like Joe Louis, depending what I have available, if
25 I have Joe Louis and the Fox and the Opera House, then

1 that piece of the pie gets sliced a little smaller. So
2 I could send four over to Joe Louis. Or if it is just
3 a hockey game, I could send eight or nine. And out of
4 that eight or nine, after traffic dies down, we will
5 send two or three inside.

6 COMMISSIONER CRAWFORD: Yes, sir.

7 CAPTAIN PETTY: Then on the outbound, they
8 will bring those three out and put them back with the
9 other five. Because after they do traffic, then there
10 is patrolling the downtown area, and they check the
11 parking lots and little cubby holes. So everybody has
12 a secondary, sometimes three posts. So we kind of move
13 people around.

14 COMMISSIONER CRAWFORD: Yes, sir.

15 CAPTAIN PETTY: But I get what you are
16 saying.

17 COMMISSIONER CRAWFORD: Yeah. We are really
18 thin. Especially when you have 10, 20,000 people, or
19 more, at an event. So hopefully, the millionaires and
20 the billionaires will step up, start paying for, you
21 know, some of that security. It is profitable to them.

22 COMMISSIONER BELL: Commissioners?

23 Yes, ma'am.

24 COMMISSIONER DEWAELSCHÉ: So the officers
25 that you assign to these different events, is it during

1 their regularly scheduled hours?

2 CAPTAIN PETTY: Yes.

3 COMMISSIONER DEWAELESCHE: Okay.

4 CAPTAIN PETTY: Yeah. Events, downtown is
5 event-driven. So it is based on whatever the event is.
6 Auto Shows, they run all day long. Hockey games are
7 usually in the evening. Baseball games are middle of
8 the day or evening. Football is usually Sunday at
9 1:00. So we kind of move them around all over the
10 place. But they are on duty.

11 COMMISSIONER DEWAELESCHE: Thank you.

12 CHAIRPERSON BELL: Any other questions?

13 Comments from the Commissioners?

14 As Commissioner White stated, I think that
15 level of our conversation is another level of the
16 system. We have posed that issue, that's something
17 we need to resolve. I want to thank you, Captain
18 Petty, for doing an outstanding job downtown in the
19 First Precinct. Because we know that's the focal point
20 of, like you say, everybody come to Detroit, at some
21 point in time, they have got to come downtown. That's
22 just the nature of coming to Detroit. So from there,
23 venture out. So thank you, once again, on behalf of
24 the Board.

25 CAPTAIN PETTY: Thank you.

1 CHAIRPERSON BELL: Standing subcommittee
2 reports at this time?

3 If not, we can move to -- Ms. Gail Phillips
4 in the house? Is Ms. Gail Phillips present?

5 We have a resolution for Ms. Gail Phillips.

6 COMMISSIONER CARTER: Resolution honoring
7 Ms. Gail L. Phillips.

8 Now, Therefore, Be It resolved that the
9 Detroit Board of Police Commissioners speaking for the
10 citizens of the City of Detroit and the Detroit Police
11 Department acknowledge the dedication of Ms. Gail L.
12 Phillips. Her exemplary service towards improving the
13 quality of life for all citizens in her community and
14 the City of Detroit merits our highest regards, and
15 best wishes for continued success. We salute and
16 congratulate you, Ms. Gail L. Phillips.

17 Detroit Board of Police Commissioners.

18 CHAIRPERSON BELL: Thank you, Commissioner
19 Carter.

20 At this time, the Chair would entertain a
21 motion to receive the resolution.

22 COMMISSIONER MALLETT: So moved.

23 COMMISSIONER CRAWFORD: Second.

24 CHAIRPERSON BELL: It has been properly moved
25 and seconded.

1 Ready for the question. Those in favor?

2 COMMISSIONERS: Aye.

3 CHAIRPERSON BELL: Those opposed?

4 Motion carried.

5 Any old business?

6 COMMISSIONER MALLETT: Mr. Chairman, I want
7 to specifically apologize to you. You and I were
8 scheduled to be at the City Council together to present
9 the budget. That night -- that Thursday, I came home
10 to six feet of water in my basement. The story is too
11 long to go through how it is it got there. But
12 nevertheless, to be perfectly honest with you, by the
13 time the drama had died down enough for me to reconnect
14 with my professional responsibilities, it was about
15 1:00 on Friday afternoon. So forgive me for leaving
16 you in a lurch there, but I understand, as always, you
17 were able to muddle through and do an excellent job.
18 So I appreciate that. And we will manage to do what we
19 said we were going to do earlier.

20 CHAIRPERSON BELL: Yes, sir. Thank you,
21 Commissioner. Understood. And I got your e-mail. And
22 I can understand, that's a serious matter. And we was
23 able to go forward with the assistance of Mr. Anthony,
24 our Board Secretary, and Commissioner Jessica Taylor.
25 And the budget went forward, and it was a welcome

1 dialogue with the Council. And we are looking forward
2 to the interaction dealing with the budget, and the
3 unique part of it, that we talked about amendments, and
4 they are receptive to that.

5 COMMISSIONER MALLETT: Excellent.

6 CHAIRPERSON BELL: They definitely
7 entertained that and understood. They didn't really --
8 because as you know, the Emergency Manager, in terms of
9 overall, it's pretty much set, and I think the Council
10 just approved a budget without any changes in terms of
11 citywide.

12 So what I liked about that, I don't know if
13 you are aware, but Councilwoman Mary Sheffield,
14 District 5, stated on record that she was more in
15 support of us being reinstated when the time come to be
16 fully duly charged by the Charter. And that was the
17 dialogue she had with us. So that was welcome in terms
18 of not soliciting that, but she just pretty much voiced
19 her support for that. So that was very meaningful for
20 us sitting at the table and for the audience.

21 I want to thank Mother Bernice for attending.
22 She in the house? Okay. She was there before we got
23 there. So as you know, Commissioner Mallett, she is
24 one of our strongest supporters.

25 COMMISSIONER MALLETT: Yes, sir.

1 CHAIRPERSON BELL: So it was a good dialogue.
2 We are looking forward to working with Deputy Chief
3 Tolliver in reference to the budget issues that we hope
4 to deal with in 2015 and '16. So appreciate your work
5 prior to. That has helped us in terms of preparing for
6 that meeting. So I felt comfortable, but I was looking
7 forward to you engaging Council, because I know you
8 have that skill set.

9 Moving right into announcement. On Thursday,
10 which is next week, March 19th, at 3:00, we will be
11 once again meeting at the Public Safety Headquarters at
12 Third and Michigan. So please feel free to come down
13 at 3:00 on Third and Michigan for our regular meeting.

14 Our next Community Meeting will be held at
15 the 11th Precinct on April the 9th at Galilee
16 Missionary Baptist Church, at 5251 East Outer Drive.
17 That's at 6:30 p.m., so we would continue to promote
18 that in terms of going northeast of the 11th precinct,
19 I think that is District 3. Is that 3? Is that
20 Commissioner Crawford district?

21 COMMISSIONER CRAWFORD: Yes.

22 CHAIRPERSON BELL: So we are looking for some
23 great interaction with hosting there at Galilee
24 Missionary Baptist Church. I have the good intention
25 of contacting the pastor there. I know he is an

1 activist. And we are looking forward to bringing some
2 of the people from his church in that area. And
3 that's -- is that the 11th Precinct? 11th Precinct?

4 SECRETARY ANTHONY: Yes.

5 CHAIRPERSON BELL: Captain Leach.

6 CAPTAIN LEACH: Yes.

7 CHAIRPERSON BELL: He worked with my favorite
8 captain, Hope; is that right?

9 CAPTAIN LEACH: Yes.

10 CHAIRPERSON BELL: Out of the 7th Precinct.

11 CAPTAIN LEACH: Yes.

12 CHAIRPERSON BELL: Okay, then. I know that
13 the 11th Precinct have a history of hosting, because I
14 worked at number 11. So you have to open up the
15 hospitality. That was former Commander Haddad, as you
16 well know, always had great meetings over there for the
17 Commission and for the community. So he moved on to
18 Dearborn. But I know Captain Leach and Captain Hope
19 are going to do an excellent job.

20 Oral communication from the audience. Please
21 give your name. And limit your comments to two
22 minutes. We are somewhat flexible, but we do have a
23 time format. I know we want to leave downtown. We are
24 enjoying ourself here, but please come forward to the
25 mic.

1 Captain Petty, you didn't say anything about
2 the Coney Island on Lafayette. Are they still there?

3 UNIDENTIFIED SPEAKER: He stepped out in the
4 hallway, but it is still there.

5 CHAIRPERSON BELL: Is Coney Island still
6 there?

7 UNIDENTIFIED SPEAKER: Lafayette is still
8 there. Still better than American Coney.

9 CHAIRPERSON BELL: Okay. Lafayette, okay.
10 All right. Because people, when you travel, they
11 always ask about the coney island downtown, so...

12 Yes, sir.

13 MR. BOWMAN: Yes. Scott Bowman from Detroit.

14 And I am just here to comment briefly on the
15 body camera topic, but also I wanted to pass along
16 to -- talking to you a few minutes ago on the phone,
17 that Willie Burton apologized for not attending tonight
18 but he was feeling ill. And that's why he didn't make
19 it over here.

20 Yeah. Regarding the body camera issue, it is
21 a complicated issue because there are times when one
22 won't want them on. And there are times when they
23 should be on. But perhaps some people may not want
24 them on, even though they should be on.

25 And I think that is where one of the -- for

1 me, one of the key issues comes in, is ideally, it is a
2 two-edged sword, where the camera will end up showing
3 that someone who is a civilian breaking the law, will
4 identify -- will verify that they are doing so. And so
5 that they cannot lie their way out of it quite so
6 easily, just saying cameras don't lie.

7 And likewise, the other edge, is that a law
8 enforcement officer also breaking the law will not be
9 able to lie about it and get away with it. And so the
10 idea is to keep everybody honest.

11 And the problem is when you have one of the
12 two parties in control of the device, it seems to me
13 that you have then a problem where if it is the law
14 enforcement officer who is the one breaking the law,
15 that -- or is uncertain about whether or not he wants
16 anyone to see what he is doing or she is doing, that
17 that person would then be able to turn it off and then
18 that event would be -- go undocumented.

19 And so what I was going to suggest was that
20 in addition to the body camera matter and, you know, it
21 is an expensive thing, I don't know how broad it can be
22 anyway given all of the other pressing costs that the
23 police department has to endure, and, you know, there's
24 been recently a cut in retirement, and so on. So my
25 additional suggestion is a policy condoning the use of

1 cameras, be they in phones or handheld, just standalone
2 cameras, by civilians in any place where there is not a
3 reasonable expectation of privacy. And that if there
4 is any altercation or arrest going on, that they be
5 allowed to continue recording, and that your officers
6 as a policy be instructed not to stop people from doing
7 that. Because I believe that would provide the
8 additional neutral check on the whole process. Thank
9 you.

10 CHAIRPERSON TAYLOR: Thank you, Mr. Bowman.
11 Commissioner Crawford.

12 COMMISSIONER CRAWFORD: There is a policy,
13 sir. It is called the United States constitutional
14 rights that citizens have in terms of you talking about
15 them being in a public place, using cell phone video in
16 a public place. They can do that. There's nothing --
17 being that this is a constitutional Police Department,
18 as we have heard so many times, they cannot stop them
19 or seize their -- I mean, we have heard a few
20 incidents, let's be truthful about it.

21 MR. BOWMAN: I had a personal experience of
22 being stopped and suffering some severe consequences.

23 COMMISSIONER CRAWFORD: Okay. But also, too,
24 you know, for years, there are a number of police
25 chiefs in America, some of them, they love cameras.

1 And I say that is because for years, there was a show
2 on, I think it is still on, called Cops, where police
3 officers rode around, there was a camera crew in the
4 car, they entered your house and others' houses, I
5 often wondered how they could do that, without the
6 citizen tell them stop the camera at the door, the
7 officer come in, but I think that the policy that is
8 the draft policy we have now, and I am sure there will
9 be some changes to it as the Assistant Chief White
10 stated, as we get through this pilot program before its
11 final document. And in terms of this policy, I think
12 it will be a good policy.

13 There are other departments across this
14 country, they have policies in place. They didn't just
15 put body cameras on officers and send them out there.
16 So as a matter of fact, there was some policies that we
17 viewed when we were in Kansas City pertaining to --
18 well, some of the other departments that actually have
19 a policy.

20 So I understand your concerns, but in terms
21 of a citizen videoing or using their cell phone to tape
22 something that's in a public place, or on the street,
23 they can do that. And they have done it. And if you
24 check the Internet today, you will see a lot of video
25 footage of officers who were engaged in police

1 activity. That is just there. You can Google it. And
2 you will see a lot.

3 And also, too, it tells both sides of the
4 story, too. There are a number of times officers have
5 been accused of things. And we look at the video
6 footage, it didn't occur. You know. Most recently
7 even you will find some shootings where officers were
8 actually shot approaching vehicles. They had on a body
9 camera. You can see the encounter, what has occurred.

10 And also, too, the body camera makes for a
11 very good witness in terms of identifying a
12 perpetrator. So...

13 CHAIRPERSON BELL: Thank you, sir.

14 MR. BOWMAN: Thank you.

15 CHAIRPERSON BELL: Any others?

16 MR. KABAKA: Greetings. My name is Kenneth
17 Kabaka. I am the President of Metro Detroit Cab
18 Drivers Association. I am going to submit a letter to
19 this body, but I am going to deal with the fourth
20 paragraph. And that is, as we go through revision of
21 Chapter 58 in the new TNC section for Vehicle for Hire
22 ordinance, we request that any police codes, standard
23 operating procedures, executive orders, general and
24 special orders, and any ongoing changes initiated by
25 the command structure in the Detroit Police Department

1 for the Vehicle for Hire ordinance be included in
2 Section 58 and 59, the vehicle for hires ordinance.

3 The Association knows that right knowledge
4 corrects wrong behavior. We have been having issues as
5 we go along that we have been talking about. I have
6 copies for the record.

7 I am not going to sit up here and rehash and
8 be repetitious over what's been going on. Those of you
9 all know that we have been coming before this
10 Committee, we have been trying to iron this out. We do
11 believe that there needs to be a dialogue, but now that
12 spring is coming, we are getting ready to spring
13 forward, too, because things are not moving like they
14 were supposed to be moving.

15 And also, Commissioner Crawford, I am
16 definitely -- I am a photographer. Supreme Court has
17 already ruled that as long as there is not a yellow
18 tape, anything out there is public domain, as long as
19 it is in the public. So that answers that person's
20 question. It has already been the law of the land.

21 So -- but really, you know, the cabbies are
22 business people in this city. We have been catching
23 hell, and excuse my French, and we are tired of it. So
24 it is like about time that we are going to go ahead
25 and -- hopefully we can work this out with dialogue,

1 but it has to be an honest dialogue. It cannot be
2 where we are going to have -- just because we are the
3 powers that be, we are going to enforce it the way we
4 want. We want respect because we give respect. So we
5 are doing this honorably. We are coming here and we
6 are letting you know spring is coming and the Cab
7 Drivers Association is getting ready to spring forward,
8 too.

9 Thank you.

10 COMMISSIONER BELL: Thank you, sir.

11 CHAIRPERSON BELL: Any others?

12 MS. SMITH: Good evening --

13 COMMISSIONERS: Good evening.

14 MS. SMITH: -- to the Commission, and to our
15 Steven.

16 First of all, I want to let you know Friday
17 was a beautiful event at the Detroit Police scape for
18 the ball. And everyone was there and they had a good
19 time. And I am sure those that did not be in
20 attendance, you are going to be sorry. You better come
21 next time.

22 In the meantime, Steve did a wonderful job
23 also. I met his wife. Lovely woman. Met a lot of
24 wives that night too. So I just want to let you know,
25 if you do anything wrong, I know your wives so I can

1 tell on you.

2 So seriously speaking now, the forum that was
3 held this past Tuesday, it was in the University area.
4 The people that were coming late, they were not able to
5 get in. Of course, I was fortunate because a lot of
6 the police know me and they let me in anyway.

7 But in the meantime, the people were asking
8 questions in regards to the situation that happened in
9 their area about the judge. And we did hear some
10 remarks in regards to the lighting. They do have new
11 lights over there.

12 But one lady complained that she could not
13 see the perpetrators that ran because of the trees that
14 was blocking. So I think Jones, President Jones is
15 going to get on that, in regards to that, so you won't
16 have to worry about that.

17 But in the meantime, I am glad that you are
18 going to have this new -- what is it, the body cameras?
19 With us living in Detroit, we need all the help we can
20 get in regards to the crime that we are having. Look
21 like it is increasing. And I don't like it. A young
22 man got killed this morning at 4:30. And Steve was on
23 it. I don't know when he sleeps. But anyway, of
24 course, I know he is not the only one out here. We
25 have a lot of policemen that are doing a good job out

1 here. And I support them to the highest. But we have
2 got to be careful that -- they are in danger also.

3 And I am really asking, not only the Council,
4 to give them some more money. Give them an increase.
5 We have got people that come here and advertise from
6 Arizona talking about \$40,000, no education, no
7 nothing. Now that's ridiculous, but we must support
8 our police department. And I hope that we will give
9 them more money. So let them know they are worth
10 getting out there, putting their lives on the line. I
11 don't like it not one bit. Tomorrow I will be on the
12 air talking about what we talked about tonight and
13 about the radio cameras.

14 Conrad was on the other day, and he spoke
15 about his business, which is fine. But the thing is,
16 we need to -- what's the matter? Talking about the
17 hospital. But anyway, we need to just protect our
18 police officers. And I beg the people that knows
19 anything that you see or hear, we are looking for this
20 killer that killed the young lady from Grosse Pointe.
21 I am with Malik and them, and it is a
22 hundred-some-thousand dollars. But my thoughts are
23 this. Somebody knows here in Detroit -- I have got to
24 get out of here. And I do hope. But I think he has
25 gone out of town. He is on the low, you know, he is

1 hiding out. And people need to tell the police. We
2 trust you. We not going to put you in danger. We want
3 you to tell us who does what and let us know what's
4 going on in this city. We don't want you to be running
5 around here killing and going on at each other. It is
6 terrible. We are scared to come out of our homes, half
7 of us. But the fact is, the police is doing a good job
8 and I admire them to the highest. I love them. Thank
9 you.

10 (Applause).

11 CHAIRPERSON BELL: Captain, are you coming to
12 the mic? Yes, sir.

13 CAPTAIN PETTY: I just need to say one thing
14 I forgot. It would be on my head, not my heart if I
15 didn't introduce my NPO's or my majors, Officer Harris
16 stand up, and Officer Shank.

17 (Applause).

18 CHAIRPERSON BELL: Thank you, Captain Petty.

19 CAPTAIN PETTY: Thank you.

20 CHAIRPERSON BELL: Any other remarks?

21 Comments?

22 If not, we are in the process of standing --
23 there is no other business before the Board at this
24 time.

25 But who are the two young boys sitting over

1 there?

2 CAPTAIN WILLIAMS: This is Christopher
3 Williams, and this is Arnold Williams, Junior.

4 CHAIRPERSON BELL: And why are they here?

5 CAPTAIN WILLIAMS: Because I am Captain
6 Williams, and I am here. And I made them come.

7 CHAIRPERSON BELL: I was watching the
8 interaction. And I said, that's what it is all about.
9 Sons and fathers coming to meetings and activities, and
10 well behaved, you know, and it is a blessing.

11 And if we can encourage more of that. I
12 always say people talk about education, the lack of
13 skill set. No, we need to talk about families. We
14 start at that level. We start at that level. And you
15 continue all the way up. And that's the foundation.

16 When young mens out here engaging, they don't
17 get there overnight. There is a certain pattern. And
18 you will find that a whole lot of instance, they don't
19 have that father role model in their home.

20 And mothers do a great job, I know, I was
21 raised by my mom and dad, but I had a grandmother, yea
22 tall. But that was a different day and age.

23 But it is good to see that type of
24 interaction. And I want to thank you for coming out
25 with your sons. That's encouraging. And we all need

1 to recognize that.

2 I see a couple of retired police officers in
3 the house, too. I would like to recognize Roy
4 McAllister, retired lieutenant. And anyone else? My
5 friend Al Bobin (phonetic), did he leave? He had to
6 go.

7 Thank you for coming out. I know you have a
8 vested interest in terms of what's happening in the
9 city, and you are still engaging. So that's a bonus.

10 I want to thank all of you for coming out
11 tonight. It is a blessing to see when people come out
12 and interact with DPD and the Board of Police
13 Commission. And I just encourage you to stay faithful.
14 And just don't give up on Detroit. This is the D, and
15 that's why you are here. If you can't say nothing good
16 about Detroit, don't say nothing about Detroit.
17 That's -- you can't say something good about DPD, don't
18 say what? Don't say nothing.

19 On that note, thank you. Thank you. I hope
20 to see you in the near, near future.

21 Commission, we would stand a motion for
22 adjournment.

23 COMMISSIONER MOORE: So moved.

24 COMMISSIONER WHITE: Second.

25 CHAIRPERSON BELL: Proper moved and second.
