5 VICE CHAIRPERSON DEWAELESCHE: Good afternoon  
6 and welcome to today's Board of Police Commission  
7 meeting.

8 I'm Commissioner Eva Garza Dewaelsche, and  
9 I'm standing in for Commissioner Carter, Chair, who is  
10 excused for today's meeting.

11 I'd like to start by first asking if our  
12 Commissioner, Bishop Vann, would lead us in invocation.

13 COMMISSIONER VANN: May we pray.

14 God, we do thank you for this day, for its  
15 opportunities. We thank you for life and health and  
16 for strength. We thank you for the acuity of mind that  
17 brings us to this table as we plan and deliberate for  
18 the safety of the citizens of the city of Detroit,  
19 along with the Detroit Police Department. We ask that  
20 you would give us grace in our oversight role of the  
21 department. We also ask that you would protect those  
22 who serve us every day, the leadership of our  
23 department and, of course, the men and women who every  
24 day lay their lives on the line for us. Bless the  
25 cause of public safety and public safety oversight

1 everywhere. We're cognizant and aware of so many  
2 incidences where this is so needed. So bless the work  
3 that we do, bless the wisdom that we need and then, oh,  
4 God, bless the minds that will help to make it happen.  
5 This we ask in your name. Amen.

6 AUDIENCE: Amen.

7 VICE CHAIRPERSON DEWAELESCHE: Thank you,  
8 Commissioner.

9 Could I ask the secretary do we have a quorum  
10 today?

11 MR. HICKS: Yes, Madam Chair.

12 VICE CHAIRPERSON DEWAELESCHE: Okay.

13 MR. HICKS: We do have a quorum.

14 VICE CHAIRPERSON DEWAELESCHE: And then I  
15 would like to start with introductions from my right.

16 COMMISSIONER SANDERS: Commissioner Derrick  
17 Sanders, At-Large.

18 COMMISSIONER BROOKS: Commissioner Elizabeth  
19 Brooks, At-Large.

20 COMMISSIONER BELL: Commissioner Willie Bell,  
21 District 4.

22 COMMISSIONER BURTON: Commissioner Willie  
23 Burton, District 5.

24 COMMISSIONER CRAWFORD: Commissioner Reginald  
25 Crawford, District 3.

1 COMMISSIONER VANN: Commissioner Edgar Vann,  
2 District 2.

3 COMMISSIONER SHELBY: Commissioner Richard  
4 Shelby, District 1.

5 VICE CHAIRPERSON DEWAEELSCHÉ: Thank you.

6 Commissioners, you received the agenda for  
7 today's meeting, and I'd like to have you review it and  
8 ask if there's a motion to approve today's agenda?

9 COMMISSIONER VANN: Move the adoption, Madam  
10 Chair.

11 COMMISSIONER CRAWFORD: Support.

12 VICE CHAIRPERSON DEWAEELSCHÉ: It's been moved  
13 and seconded. All those in favor indicate by saying  
14 aye.

15 COMMISSIONERS: Aye.

16 VICE CHAIRPERSON DEWAEELSCHÉ: Aye. Opposed?

17 The motion carries.

18 You have also received in advance the minutes  
19 for July 13th, and I ask that if you have had a chance  
20 to review them could I please get a motion to approve  
21 those?

22 COMMISSIONER SANDERS: Move for adoption.

23 COMMISSIONER VANN: Supported.

24 VICE CHAIRPERSON DEWAEELSCHÉ: It's been moved  
25 and seconded. All those in favor indicate by saying

1 aye.

2 COMMISSIONERS: Aye.

3 VICE CHAIRPERSON DEWAEELSCHE: Opposed?

4 Thank you. Motion carries.

5 At this time I'd like to ask the Chief -- I'm  
6 sorry, not the Chief, the board secretary if he would  
7 please introduce our staff for the Board of Police  
8 Commissioners office.

9 MR. HICKS: Thank you, Madam Chair. I do  
10 want to indicate just before getting to those  
11 introductions that, as it's normally the case, Sergeant  
12 Quinn is taping our meeting, Media Services is doing  
13 the audio visual work and Sheila Rice is the court  
14 reporter today.

15 And then I want to turn to, of course, the  
16 staff, and I'm going to go down the front row. All the  
17 way on this side of the room is, of course, Gail  
18 Oxendine, the Director of Human Resources. Next to  
19 Gail coming in my direction, of course, is our attorney  
20 Mr. Wyrick. I'm going to skip over Gail -- I mean over  
21 Pam to come back, but we also then have Ms. White who  
22 is policy, Ms. Blossom who's media outreach, Ms.  
23 Johnson who is, of course, our fiscal person and, of  
24 course, Mr. Brown who's up here. And then I'm going to  
25 go back to Ms. Drake who can introduce not only

1 herself, but also other members of OCI who may be  
2 present.

3 MS. DAVIS-DRAKE: Good afternoon. For the  
4 record, Pamela Davis-Drake, Chief Investigator of the  
5 Office of Chief Investigator. With us today is Senior  
6 Investigator Adela Rivera who's also a former  
7 commissioner.

8 VICE CHAIRPERSON DEWAELSCHÉ: Thank you. And  
9 we have Assistant Chief White who is sitting in for the  
10 Chief today, and in just a second I'll ask you to  
11 introduce your staff as well.

12 I just want to say a few words regarding the  
13 Board of Police Commissioners vice chair report, which  
14 is what I'm going to be presenting right now.

15 First I want to express on behalf of the  
16 board our support and gratitude to the families of  
17 injured and fallen officers. In the recent period,  
18 Officer Johnson, Second Precinct, remains in critical  
19 condition. Officer Keith Baker experienced a heart  
20 attack and is reported to be recovering at home. And  
21 Officer Lindquist remains in recovery. I have also  
22 received a report that Officer Raymoxley Berry of the  
23 Twelfth Precinct recently made his transition.

24 Also in the law enforcement community Police  
25 Officer Dennis Moore lost his wife, Linda Moore.

1 Police Officer Syd Wright (ph) of the Fourth Precinct  
2 and retired Officer Carl Montgomery lost their mother,  
3 Marva Montgomery.

4 I also encourage the commissioners to join us  
5 in the academy's graduation ceremony Friday, tomorrow,  
6 July 21st at Greater Grace Temple. It's at 23500 West  
7 Seven Mile Road in Detroit, and the program starts at  
8 10:30.

9 And I understand that congratulations are in  
10 order for Deputy Chief Renee Hall. D.C. Hall has been  
11 awarded the job of Chief of Police for the city of  
12 Dallas.

13 (Applause.)

14 VICE CHAIRPERSON DEWAEELSCHÉ: D.C. Hall  
15 participated in a national competition for the  
16 position. Her success is a testimony to her excellence  
17 as a command officer and her will and drive as a human  
18 being, and so we congratulate D.C. Hall.

19 DEPUTY CHIEF HALL: Thank you.

20 (Applause.)

21 COMMISSIONER VANN: Madam Chair?

22 VICE CHAIRPERSON DEWAEELSCHÉ: Yes.

23 COMMISSIONER VANN: I just wanted to say that  
24 with regard to Chief Hall, you know, I think that she's  
25 someone that all of us as commissioners really, really



1 appreciate. It's been a joy working with her. I know  
2 that whenever I've needed to work with her on whatever  
3 issue it was she was always very, very compassionate  
4 and always very, very helpful and supportive. And  
5 certainly Dallas' gain is Detroit's loss in this  
6 situation, but we are just -- I'm very proud of the  
7 fact that we produce the kind of quality senior  
8 management law enforcement executives that would be --  
9 that would work in any municipality across this nation.  
10 And so that says a lot for the Detroit Police  
11 Department, but it says a whole lot for Deputy Chief  
12 Hall.

13 DEPUTY CHIEF HALL: Thank you.

14 VICE CHAIRPERSON DEWAEELSCHE: Thank you so  
15 much, Commissioner.

16 COMMISSIONER BELL: Madam Chair, if I may  
17 also.

18 VICE CHAIRPERSON DEWAEELSCHE: Yes, of course.

19 COMMISSIONER BELL: I just want to commend  
20 D.C. Hall also. And as you well know, she's a product  
21 of Detroit public schools, Kettering High School on the  
22 east side of Detroit. And she has been really a  
23 blessing to this board. And in my four years and our  
24 four years as serving as commissioner in 2014 starting  
25 I think in the rank of commander ...

1 DEPUTY CHIEF HALL: Four years ago a  
2 lieutenant actually.

3 COMMISSIONER BELL: Oh, okay. Well, you have  
4 -- I have witnessed your upward mobility in terms of  
5 taking on tremendous tasks. So I just want to wish you  
6 the best.

7 And this is really a milestone for DPD  
8 history, especially impacting African-American officer  
9 going to a major city. Others have gone to Cleveland,  
10 Pontiac and Flint. I just off the top I was familiar  
11 with those individuals, but Dallas is a major city.  
12 And I had opportunity to interact with officers from  
13 Dallas several years, maybe longer than that. So  
14 you're going to a city that really welcomes your type  
15 of professionalism. And I just really want to wish you  
16 the best. If anything we can do in terms of engaging  
17 you as the Chief of Police in Dallas, do not hesitate  
18 to call our vice chair. And, on a serious note, thank  
19 you for your service.

20 DEPUTY CHIEF HALL: Thank you.

21 COMMISSIONER BELL: We're looking forward for  
22 you to make that transition.

23 VICE CHAIRPERSON DEWAELSCHÉ: Any other  
24 comments?

25 I would just like to add that I am extremely

1 proud, first of all, of having been able to work with  
2 D.C. Hall, but I'm also very proud that we have a woman  
3 that is going to be -- a woman leader that is going to  
4 be running the City of Dallas.

5 (Applause.)

6 VICE CHAIRPERSON DEWAEELSCHE: Congratulations.

7 COMMISSIONER CRAWFORD: Through the Chair?

8 VICE CHAIRPERSON DEWAEELSCHE: Yes.

9 COMMISSIONER CRAWFORD: Yes, ma'am. I also,  
10 too, would like to echo some of the same comments, but  
11 also on a personal note this board, and me personally,  
12 we love you. I don't think you have any idea how much  
13 we appreciate you, or did, you know, appreciate you.  
14 And I realize you're going to a bigger city, a bigger  
15 police department, but I know -- I have all the  
16 confidence in you that you're going to do well, even  
17 great.

18 So it's just been an honor to work with you  
19 these last four years, and I've known you even prior to  
20 this. But, yes, ma'am, definitely --

21 DEPUTY CHIEF HALL: Thank you so much.

22 COMMISSIONER CRAWFORD: -- congratulations.

23 (At 3:13 p.m., Chief Craig joined the  
24 meeting.)

25 COMMISSIONER BROOKS: I'd just like to say

1 one quick thing. When I met her, I knew she was one of  
2 the best, because she knew I was working with  
3 recruiting and right away she was out, wherever she  
4 went she was asking people and talking to people about  
5 recruiting. And I don't think too many of you all know  
6 that she really did help us. She came to one of our  
7 meetings, but she didn't organize them all together.  
8 She went to individual people and to small groups. So  
9 I just want to thank her for that. And again, I feel  
10 so proud she's a woman.

11 VICE CHAIRPERSON DEWAELESCHE: Thank you,  
12 commissioners. Any other comments?

13 Okay. Thank you. I'll continue with the  
14 report.

15 On Monday, July 24th, the department will be  
16 opening the new Eighth Precinct located at 21555 West  
17 McNichols at Grand River. The program -- they're going  
18 to have a program, and it will start at eleven o'clock.  
19 Commissioner Richard Shelby is the host commissioner  
20 for the area.

21 And you might want to say a word or two on  
22 the subject, Commissioner.

23 COMMISSIONER SHELBY: Yeah. I'm very happy  
24 that we -- not only do we appreciate in the community  
25 to serve northwest Detroit, the citizens will be happy,

1 I'll be happy. As you know, I live in District 1, and  
2 it's just a great occasion. I want to thank the Mayor  
3 and I want to especially thank the Chief for their  
4 efforts in making this new facility happen.

5 VICE CHAIRPERSON DEWAEELSCHE: Thank you very  
6 much. And we're looking forward to that new precinct  
7 and renovations and upgrades in other precincts as well  
8 as time goes on. Thank you.

9 And I understand that on the Detroit City  
10 Council's agenda for today, July 20th, there is a  
11 resolution sponsored by Council President Brenda Jones  
12 to name the southwest corner of Dequindre and McNichols  
13 the E.L Vann Boulevard.

14 (Applause.)

15 VICE CHAIRPERSON DEWAEELSCHE: In part, this  
16 is recognition of the 40 years of service for Bishop  
17 Edgar Vann. We thank you, Bishop Vann, for your  
18 service and to the large community that you serve and  
19 the nonprofit endeavors that you've, you know, been  
20 prominent in the city in helping us move forward and  
21 actually helping us with the turnaround in the city.  
22 So thank you so much, Bishop Vann, and congratulations.

23 COMMISSIONER VANN: Thank you very much.

24 (Applause.)

25 VICE CHAIRPERSON DEWAEELSCHE: And so that

1 concludes my report. And I would like to ask if the  
2 Chief would be so kind as to give his report, but also  
3 to introduce your staff, too.

4 CHIEF CRAIG: Okay. I'll go around and  
5 introduce the staff. You've already met the new Chief  
6 of the city of Dallas, Chief Renee Hall.

7 She came into my office the other day -- I've  
8 got to share this story. So this is after the news  
9 report was starting to circulate. She came and said,  
10 "You need to cut that TV off." I was watching some  
11 news. She said, "I've got something I need to say."

12 I said, "Wait a minute. You haven't left  
13 here yet."

14 But I did want to make some comments.  
15 Certainly Chief Hall has been with me over four years.  
16 Certainly when I talk about the transition team, the  
17 team that really made it happen, Chief Hall was one of  
18 the ones that was there from the very beginning.

19 When we think about just four years ago that  
20 she was a lieutenant running a precinct. She was in an  
21 acting inspector role, like so many. We hadn't had  
22 promotions in what, eight years, and so she certainly  
23 distinguished herself. I'm deeply appreciative of her  
24 commitment, her loyalty. I know that as she performs  
25 her duties, at one point handling the east and west

1 side of the city, but never had an issue. I knew if  
2 there was a community issue that she would handle it.

3 But also just the support of our men and  
4 women. I'm talking about our police officers that were  
5 involved in critical incidents. I can't think of a  
6 time that I responded off hours to a critical incident,  
7 whether it was an officer-involved shooting, barricaded  
8 suspect, and Chief Hall was there lending her support  
9 and her leadership. So again, deeply appreciative.

10 But when we think about Chief Hall moving on  
11 to Dallas, this is not about James Craig and it is  
12 bigger than Chief Hall, but what it says about the  
13 Detroit Police Department, as I've oftentimes said,  
14 this is one of the nation's great police agencies now.  
15 When people reach out and touch this team, it touches  
16 the team because they believe in the work that we're  
17 doing. And while I'm certainly excited, I'm as excited  
18 for Chief Hall going to Dallas as I was when I came  
19 back to Detroit and then getting also the Cincinnati  
20 job and the Portland job, but I look at some of our  
21 other executives. One was touched for Baltimore,  
22 another was touched for Warren, another actually got  
23 selected as Ann Arbor's Chief. And now Chief Hall this  
24 is going to even open the door wider.

25 So this is really a great day. Having worked

1 in a great organization like the LAPD, it was not  
2 uncommon that Los Angeles police officers were sought  
3 out for chief positions across the state of California  
4 and some a few instances in other large cities.

5 So again I publicly congratulate Chief Hall.  
6 Job well done. And certainly looking forward to the  
7 good news that's going to come out of the city of  
8 Dallas.

9 And with that I guess you can go around and  
10 have our folks introduce themselves.

11 (Introduction of the Staff was made.)

12 VICE CHAIRPERSON DEWAELESCHE: Thank you,  
13 Chief. I wonder if I could just ask if D.C. Hall could  
14 come to the podium just for a second and --

15 CHIEF CRAIG: Absolutely. I would offer her  
16 to take my spot, but --

17 VICE CHAIRPERSON DEWAELESCHE: And maybe say a  
18 couple of words so that way our TV audience can also  
19 have the honor of meeting you and hearing you.

20 DEPUTY CHIEF HALL: Absolutely. Right now  
21 I'm so humbled. I'm so honored. I am just blessed. I  
22 truly -- it's been -- the last couple days it's just  
23 really been making me full.

24 I just want to thank this board. You guys  
25 have been a tremendous asset to the Detroit Police



1 Department, to me personally. I want to thank you for  
2 what you do. You give the community a voice. And as I  
3 go across the country, not everyone has an oversight  
4 committee. And when one is introduced, it's a lot of  
5 pushback in having the community to have a say-so in  
6 what the Detroit Police Department does.

7 But I can tell you that the working  
8 relationship here has fostered great relationships and  
9 enhanced what we have in the community. It's the --  
10 you being at the table and you coming to us and  
11 everybody sitting together, with a voice together  
12 making the decisions for the police department and the  
13 community as a whole, it's what makes cities. It's  
14 truly, truly been a tremendous part of what we do here  
15 as an asset, and I just want to thank you.

16 I just want to say to the men and women that  
17 I've served next to for the last 18 years I thank them.  
18 Every one of you have shaped and molded who I am as a  
19 Deputy Chief. You set the standard, and we just follow  
20 suit. So I just really want to say thank you.

21 Thank you to the citizens here in the city of  
22 Detroit who made my job easier. Anyone who knows me  
23 knows I love God first, I love people second. My  
24 brothers and sisters in blue they're just an automatic.  
25 And although it's hard, I'm operating in duality

1 because it's hard to leave, but I'm so excited because  
2 I know that my steps have been ordered. I truly know  
3 that God has ordained me for such a time as this, and I  
4 must go at this point and do His will, and that's how I  
5 feel on this day. I'm so excited. And I thank each  
6 and every one you individually and collectively, so  
7 thank you.

8 To my Chief, you know, he didn't finish that  
9 story when I came in his office and told him to turn  
10 that TV off. I needed his attention. He told me, "You  
11 ain't running nothing in here."

12 I said, "Listen, you ain't my Chief right  
13 now. You operating in father mode. So I need you to  
14 sit down."

15 CHIEF CRAIG: I would have accepted "big  
16 brother," but God forbid if she had called me her  
17 grandfather.

18 DEPUTY CHIEF HALL: So I left you last, but I  
19 just want you to know that I truly, truly appreciate  
20 you, your mentorship. If it had not been for you, you  
21 noticed me as a lieutenant in this police department.  
22 And you elevated me to the level that I am today, which  
23 allowed me to participate and compete on that platform.  
24 Most of the time when I was speaking, I felt like I was  
25 listening to you in my ear, like who's talking here.

1 So I just want to thank you publicly. I've already  
2 thanked you personally.

3 CHIEF CRAIG: Yes.

4 DEPUTY CHIEF HALL: So God bless you, God  
5 keep you.

6 And keep me lifted, please. Pray for me.  
7 Pray for my strength each and every day. And I just  
8 plan to make the other DPD the best DPD. So we're in  
9 competition now.

10 VICE CHAIRPERSON DEWAEELSCHÉ: Thank you  
11 again, Chief.

12 (Applause.)

13 VICE CHAIRPERSON DEWAEELSCHÉ: -- and we know  
14 that you're going to take what you've learned here and  
15 make Dallas a great police department, and  
16 congratulations again. Thank you.

17 At this time we have a presentation to the  
18 board, and it's on Real Crime and Greenlight.

19 MR. HICKS: Excuse me, Madam Chair. Just  
20 before you go to the presentation to the board --

21 VICE CHAIRPERSON DEWAEELSCHÉ: Okay.

22 MR. HICKS: -- the Chief typically does his  
23 report.

24 CHIEF CRAIG: You know, I deferred. I wanted  
25 certainly Chief Hall to have an opportunity. So we can

1 go right into --

2 VICE CHAIRPERSON DEWAELESCHE: And I kind of  
3 took it as that. So we'll go straight to the  
4 presentation. The presentation of Real Crime and  
5 Greenlight is first.

6 CAPTAIN SEVEC: Good afternoon, everyone.

7 COMMISSIONERS: Good afternoon.

8 CAPTAIN SEVEC: As I mentioned earlier, I'm  
9 Captain Sevec from Crime Intel Unit. This is  
10 Lieutenant Russell. She's my partner.

11 LIEUTENANT RUSSELL: I'm his right hand.

12 CAPTAIN SEVEC: Right hand. There you go.

13 So the Crime Intelligence Bureau we have two  
14 units within our command, the Realtime Crime Center and  
15 the Crime Intel Unit. We're a 24-hour,  
16 seven-day-a-week operation. Our current staffing  
17 levels, we have six police officers, two police  
18 assistants, 14 civilians crime analysts, 10  
19 intelligence specialists, four sergeants, two  
20 lieutenants and myself. We're responsible for running  
21 the Realtime Crime Center, Project Greenlight. We  
22 prepare all department maps, crime stats and analytics.

23 We aid in investigative process to increase  
24 apprehension and case clearances. Unit supports  
25 patrol, traffic, investigations, crime prevention and

1 administrative functions.

2 Here are some of our intelligence products.  
3 We're tasked with identifying emerging crime patterns  
4 and alerts. We research, investigate and distribute  
5 person of interest reports. We complete comprehensive  
6 work-ups on all homicides, nonfatal shootings, critical  
7 assaults, threats to law enforcement and critical  
8 infrastructure. We also provide counterterrorism team  
9 reports.

10 We prepare fugitive apprehension work-ups.  
11 Information is retrieved from existing databases. For  
12 example, our CRISNET system, CAD and LEIN. We're not  
13 creating anything new here. We're just pulling from  
14 existing databases and pushing that out as fast as  
15 possible. Here's an example of one of the crime  
16 patterns we established in the Third Precinct.

17 Crime stat and crime mapping. Crime stat  
18 reports and the CompStat package, which include  
19 historical crime comparisons for Part 1 crimes within  
20 the city of Detroit. Also included we look at  
21 department staffing, 911 calls, response time, arrest  
22 trends and investigative unit workloads. We also  
23 maintain all map information on map info and RGIS  
24 tables to include specialized requests, for example,  
25 the Angels Night Task Force.

1           The Realtime Crime Center serves as the  
2           department's center for analytic excellence, providing  
3           investigative support to the department by accelerating  
4           the identification of crime patterns and trends,  
5           habitual and first time offenders, providing patrol  
6           officers with actionable information. We increase  
7           officer safety by communication, communicating all  
8           available information to response units.

9           Some of the technology we use, LPRs, license  
10          plate readers. We have fixed locations, also cameras  
11          mounted on patrol units. HD surveillance cameras  
12          located at various locations, including Greenlight. We  
13          also have access to city cameras.

14          Facial recognition, this is only used on  
15          criminal suspects. We don't -- we're not running a  
16          facial recognition on everyone that walks into the  
17          Greenlight, just if they're suspected of a crime. We  
18          have access to GPS tether tracking, and we conduct  
19          social media surveillance.

20          Here's an example of our work flow product.  
21          An officer responds to a scene of a nonfatal shooting.  
22          Our operator monitors the video feeds in the area,  
23          radio channels and monitors the phones for any intel  
24          requests. Our operator then contacts the officer in  
25          the field using the radio, communicates any information

1 that we have on a realtime basis.

2 Project Greenlight. The Realtime Crime  
3 Center monitors businesses that have entered into the  
4 Greenlight initiative. Crime intel provides strategic  
5 monitoring of all available citywide cameras to detect,  
6 prevent and investigate crime.

7 Incidents and 911 calls are continuously  
8 monitored by our personnel who provide actual  
9 intelligence to responding units in realtime. All  
10 camera footage is the property of the Greenlight  
11 businesses, and any footage stored by the Realtime  
12 Crime Center must show a criminal act.

13 Here's a map as of Tuesday. We had 184.  
14 Since that time we're at 185. We have an additional  
15 location in the Tenth Precinct on Wyoming. In the last  
16 three months we've had over 8,000 special attention to  
17 these businesses, and we're averaging 12.7 runs since  
18 January. Those runs are trending up, but in January we  
19 were at a hundred locations. Now we're at 185. And  
20 we're also seeing the phenomenon if the crime happens  
21 in the neighborhood or down the street they're coming  
22 to the businesses as a safe haven and calling 911.

23 We also have an additional GIS specialist and  
24 the project manager that are being funded through a SPI  
25 grant, Smart Policing Initiative. The GIS specialist

1 actually started this week, and the project manager is  
2 starting later in the month.

3 This is a product we put out every week  
4 through the precinct commanders and captains. It looks  
5 at -- it averages how many locations they have, how  
6 many they've had come online in the past week, how many  
7 calls -- average calls a day, average calls per  
8 location. And then it looks at special attentions,  
9 average special attentions a day and average per  
10 location and the most common runs they're getting and  
11 the most problematic location. And we also use that at  
12 the Realtime Crime Center to see what locations we  
13 should be monitoring most on the cameras.

14 The CTAT team, Counterterrorism Threat  
15 Analysis Team, is also located at the Realtime Crime  
16 Center. We produce daily threat assessment reports,  
17 which provide international and domestic terror-related  
18 information. The report includes a spotlight on  
19 national news that covers threats against law  
20 enforcement and domestic and international terrorism.  
21 We provide a comprehensive list of events in the city  
22 for potential threats. We monitor all critical  
23 infrastructure within the city of Detroit and put out a  
24 report five days a week.

25 And CTAT is comprised of investigators from



1 the Realtime Crime Center and members from HIDTA, the  
2 Department of Homeland Security and the Detroit Crime  
3 Commission. We've recently partnered with the NYPD,  
4 their Shield Program, which provides training to  
5 citizens and gives us additional access to information.  
6 They're several large departments nationwide that share  
7 information with us now.

8 And that concludes my presentation. Any  
9 questions?

10 VICE CHAIRPERSON DEWAELESCHE: Commissioners,  
11 do we have any questions or comments?

12 COMMISSIONER VANN: Madam Chair, just a  
13 couple questions. The Detroit Crime Commission that  
14 you listed as one of your partners, is that a city of  
15 Detroit agency?

16 CAPTAIN SEVEC: It is a private agency.

17 COMMISSIONER VANN: I saw the Detroit logo on  
18 the Detroit Crime Commission. So I guess that may be  
19 along with the other logos that I saw. I thought that  
20 it was a separate agency, so ...

21 CAPTAIN SEVEC: Yeah, they're separate from  
22 the DPD. Yes, sir.

23 COMMISSIONER VANN: And what's the  
24 relationship that you have with them?

25 CAPTAIN SEVEC: They work with us. They help

1 us vet events in the city, major parades, any kind of  
2 event like the Tigers game. We divide up the events,  
3 and they look at some of them and we look at some of  
4 them to divide the workload.

5 COMMISSIONER VANN: Okay. Let me just ask  
6 another question about your statistical analysis and  
7 the crime stats that you produce. Can you just tell us  
8 what the impact of population decline is on statistical  
9 analysis?

10 CAPTAIN SEVEC: It's -- we generally just  
11 look at the raw numbers. We're not comparing that to  
12 the population or decline or increase. We just look at  
13 the raw --

14 COMMISSIONER VANN: So that's not an  
15 indicator or a factor that you consider?

16 CAPTAIN SEVEC: No.

17 VICE CHAIRPERSON DEWAEELSCHÉ: Any other  
18 questions or comments?

19 COMMISSIONER SHELBY: Through the Chair.

20 VICE CHAIRPERSON DEWAEELSCHÉ: Yes.

21 COMMISSIONER SHELBY: We're talking about GPS  
22 tracking. Are you getting information from like state  
23 parole boards who people on tethers or Wayne County  
24 Sheriff's Department that also has a tether unit?

25 CAPTAIN SEVEC: Yes. We have access to their

1 systems. We also have a contract employee who works  
2 part time. He's actually a MDOC agent full time. So  
3 he's helped us with facilitating that working  
4 relationship.

5 VICE CHAIRPERSON DEWAEELSCHE: Any other  
6 commissioners?

7 COMMISSIONER BELL: Yes, ma'am. I have one  
8 question from Commissioner Burton who had to leave.  
9 His question in terms of is this the policy of this  
10 particular entity, is this the policy that you're  
11 sharing with us? Is there a policy?

12 CAPTAIN SEVEC: We have a policy known as --  
13 this is a PowerPoint to try to cover the basic  
14 operation of our unit.

15 COMMISSIONER BELL: Okay. Could you share  
16 that policy with the board?

17 CAPTAIN SEVEC: Absolutely.

18 COMMISSIONER BELL: Okay. My question is as  
19 a pushback, I guess there was a demonstration at one of  
20 the sites, potential sites, that was just a couple days  
21 ago, an owner said he could not afford it. Can you  
22 clear up the issue about cost factor for Greenlight  
23 program now as we speak in 2017 versus in the past?

24 CAPTAIN SEVEC: I'm not really familiar with  
25 the pricing output. We just monitor the locations.

1 But I know they have payment plans that they put in  
2 place.

3 CHIEF CRAIG: Through the Chair.

4 VICE CHAIRPERSON DEWAEELSCHE: Yes.

5 CHIEF CRAIG: When the program started and we  
6 brought in high definition cameras, the department with  
7 Comcast, Comcast gave businesses an opportunity to  
8 finance it like you would a home security system and  
9 pay monthly. Because early on Greenlight it was an  
10 outlay of approximately between six and \$7,000, initial  
11 outlay. But then when Comcast got involved, DTE got on  
12 board with us for lighting, that lowered the cost and  
13 gave financing options.

14 We, as a matter of practice, we don't go out  
15 and -- I don't want to use the word strong-arm. I know  
16 many of our community members have taken upon  
17 themselves to go in in group and they will go to the  
18 location. It's amazing to hear and read about this,  
19 but they will go to a neighborhood and basically tell  
20 the management or the owner that you need to become a  
21 Greenlight. You want us to patronize your business, we  
22 expect you to become a Greenlight, because we don't  
23 feel safe, your place is filthy, you allow loitering.

24 And so that phenomenon is happening in  
25 different parts of the city. It's certainly not

1 something that we coerce, but it does happen. We  
2 certainly --

3 So they're different options. Most  
4 businesses seem to welcome and want Greenlight. As was  
5 not mentioned, we're looking at establishing a  
6 Greenlight corridor on Michigan Avenue. There's a  
7 neighborhood that is considering it. I think it's  
8 Palmer Woods, Sherwood Forest. I know there's a  
9 business district in southwest Detroit well over a year  
10 ago expressed interest to me.

11 So we're going to Greenlights everywhere. I  
12 think it's a great thing. It's worked very  
13 effectively. We know that when we look at Greenlight  
14 locations crime certainly has been a reduction.  
15 Generally speaking, generally, whenever there's a  
16 violent crime it happens to be caught in a Greenlight  
17 area, in an area of a Greenlight location or at the  
18 location itself, we generally make an arrest within 24  
19 hours. And so it's worked out real well. And there  
20 are many other cities that are trying to understand  
21 that want to adopt Greenlight.

22 VICE CHAIRPERSON DEWAELSCHÉ: Thank you,  
23 Chief.

24 And, Commissioner, go ahead.

25 COMMISSIONER CRAWFORD: I'm sorry. Through

1 the Chair. I, too, think that Greenlight is a great  
2 thing. However, I must caution those who want to  
3 protest or boycott a business. I do understand. I  
4 used to march on businesses with many groups in the  
5 city. We actually would close them down because they  
6 didn't clean up. It was always this crime and other  
7 things going on in businesses. And with the issue of  
8 -- when it comes to -- I mean, a simple boycott is  
9 different, but it's kind of threading a -- walking a  
10 thin line when you or those out there in some  
11 organization and group -- and believe me, there can be.  
12 And I looked at some things -- this is years ago and  
13 out of New York, some civil litigation that may come  
14 out of this toward those particular groups and  
15 organizers who want to do this.

16 If there is a grievance with a particular  
17 business and those in the community choose not to  
18 patronize that business, as I wouldn't, then do so.  
19 But, if they want to kind of use this issue of  
20 Greenlight, they may have some issues that may come out  
21 of that.

22 However, I do support the Greenlight. And I  
23 think all the businesses -- and there was a question  
24 that Bishop Vann asked in terms of the decrease and  
25 increase in crime, et cetera. It's something that --

1 as a matter of fact, I can assure you if you ask the  
2 business owners they will probably tell you their  
3 business has increased, because when you're operating a  
4 clean business and you have a Greenlight and those who  
5 may want to go there for other reasons simply to just  
6 occupy that business and in some cases take over it, do  
7 certain things and commit crimes, they move on. I  
8 mean, we've witnessed that. ]

9 But also, too, sir, there was the GIS  
10 specialist project manager. You said there was funding  
11 for that. Is that federal funding?

12 CAPTAIN SEVEC: Yes. The department was  
13 awarded a SPI grant, Smart Policing Grant, and they're  
14 funded completely through that grant.

15 COMMISSIONER CRAWFORD: Federal? Federal  
16 funding?

17 CAPTAIN SEVEC: Yes.

18 COMMISSIONER CRAWFORD: Thank you.

19 VICE CHAIRPERSON DEWAEELSCHÉ: Any other  
20 questions or comments?

21 I have one question as it relates to the  
22 Greenlight locations that you had on the map. Could  
23 you -- is there a way to get back to the map, because I  
24 just wanted to kind of show you?

25 There are pockets of areas that don't have

1 Greenlights. It looks like they're spread out pretty  
2 evenly throughout the city, but on the northwest -- I  
3 mean, I'm sorry -- northeast side of the city there's  
4 like a big pocket right next to I believe it's  
5 Hamtramck. Would there be a reason for that? Maybe is  
6 it not very many businesses there or maybe not very  
7 many gas stations?

8 And also the southern part of southwest  
9 Detroit there's only one Greenlight there, and that's a  
10 highly, you know, populated area. So I'm just curious.

11 CAPTAIN SEVEC: That's going to be the focus  
12 of the GIS specialist and the project manager --

13 VICE CHAIRPERSON DEWAEELSCHÉ: Okay.

14 CAPTAIN SEVEC: -- to find out where we need  
15 to expand and coordinate outreach to those businesses.

16 CHIEF CRAIG: Through the Chair.

17 VICE CHAIRPERSON DEWAEELSCHÉ: Yes.

18 CHIEF CRAIG: It should also be noted that in  
19 each of our precincts the neighborhood police officers  
20 not only visit those Greenlight locations, they log in  
21 -- actually sign in they've been there. So that's an  
22 added bonus to being a Greenlight location, but it's  
23 part of the role of the NPO. The NPO will also look at  
24 -- say a location is having repeat calls for service.  
25 And let's say that, you know, it's the type of calls



1 that come out of a location, a party store, gas  
2 station, it's loitering, narcotic sales, you know.  
3 Certainly the NPO will have a conversation with  
4 management and make a suggestion that, you know, you  
5 might want to consider Greenlight if they're willing to  
6 be, as I like to refer to, a good neighbor. Because  
7 part of the problem we know in some locations they're  
8 clearly part of the problem. They're allowing drugs to  
9 be sold in and around their facility. So the last  
10 thing they want is a Greenlight. And so that's another  
11 issue we deal with.

12 Again, we don't force people to get the  
13 Greenlight, but certainly if there's a problem location  
14 and they're seeking help and they're looking for  
15 strategies that might abate criminal activity, the  
16 Greenlight is certainly an option.

17 VICE CHAIRPERSON DEWAELESCHE: Thank you. Any  
18 other commissioners?

19 COMMISSIONER VANN: Madam Chair, I, too,  
20 think that the Greenlight project is a very, very good  
21 project for our city. I commend the Chief for  
22 instituting it and establishing it.

23 In looking at the schematic there, you know,  
24 I do see a pattern of Greenlights on major  
25 thoroughfares, what appears to be Jefferson, what

1 appears to be Grand River, what appears to be Seven  
2 Mile, Six Mile, et cetera.

3 So would it be the work of the project  
4 manager to -- as you continue to saturate to look at  
5 potential problem places that would not necessarily be  
6 on those larger thoroughfares, because with CompStat  
7 you have the data that helps to support the need?

8 CAPTAIN SEVEC: Absolutely. We'll be looking  
9 at where the crime is where we have gaps in coverage.  
10 We'll be looking at all of that, yes.

11 VICE CHAIRPERSON DEWAEELSCHE: Thank you. I  
12 just have one more quick comment that I wanted to make,  
13 and that is with regard to the pricing or the cost.  
14 The incident that you spoke of was on TV.

15 COMMISSIONER BELL: Yes.

16 VICE CHAIRPERSON DEWAEELSCHE: It was a gas  
17 station owner, I believe, who was still making  
18 reference to the \$6,000 cost that it is. And I think  
19 what we need to do to increase the numbers is to let  
20 the community know and the business owners that it's no  
21 longer that necessarily now that we're doing the  
22 partnership with Comcast.

23 Is that correct, Chief?

24 CHIEF CRAIG: Through the Chair, that's  
25 correct. We've been very -- we've done a lot of

1 publicity on this, you know. In my wildest dreams I  
2 would not have guessed that it would have caught on to  
3 this degree. We're talking about eight initial  
4 locations January of --

5 When was that, James White? When did we  
6 first meet? January of 2016? 2017?

7 ASSISTANT CHIEF WHITE: No, '16.

8 CHIEF CRAIG: 2016. Here we are sitting at  
9 184 locations, 80 in the pipeline. You know, given  
10 that our Realtime Crime Center temporary location we're  
11 using now is clearly reaching what we consider  
12 capacity. Now, I'm confident, unless James White tells  
13 me different, that we should be opening the new  
14 Realtime Crime Center probably in the next three  
15 months --

16 ASSISTANT CHIEF WHITE: Yes, sir.

17 CHIEF CRAIG: -- is it safe to say?

18 So three months, which we'll increase  
19 staffing, increase capacity. And so -- but when you  
20 look at the number of calls we're handling a day.

21 As you probably don't recall, that Greenlight  
22 locations are priority one calls now. And so what we  
23 also find people doing is they may have had an incident  
24 somewhere else. They'll go to the nearest Greenlight  
25 location like it's a police station. And when the call

1 comes in -- because it is. You know, part of the whole  
2 early concept of Greenlight -- you remember, police  
3 stations were closing in the city of Detroit, the most  
4 ridiculous thing I've ever heard of, close police  
5 stations. So there were no safe havens for people in  
6 the neighborhoods. So, of course, quickly opened up  
7 police stations and not only that trying to figure out  
8 -- because in downtown and midtown then the lighthouse  
9 project, the little blue lights, and they signify safe  
10 havens.

11 So I began to reflect and say what if we can  
12 create the safe havens in the neighborhood. Of course,  
13 police stations obviously you'll need to be open 24  
14 hours a day, seven days a week. We put ATMs in the  
15 police stations early on. The reason why we did,  
16 because we want people to come to a safe location and  
17 we did that.

18 So then that was the birth of the Greenlight,  
19 those clean gas stations or party stores that have a  
20 welcoming feel. And now we've built in with the high  
21 definition cameras, the lighting. It's just gone to  
22 another level and it's growing quickly.

23 And so in terms of the capacity, I think --  
24 was is it, 187 now?

25 CAPTAIN SEVEC: 185.

1 CHIEF CRAIG: 185. And it's going to  
2 continue to grow.

3 And so as you probably know, there's an  
4 ordinance that one of the council persons was  
5 considering, and probably will introduce, that any  
6 business open after 10:00 must have -- I mean the  
7 early, early ordinance required cameras or video, not  
8 to the level of cameras and videos that we're using at  
9 Greenlight. There may come a time where council may  
10 require that any business open after 10:00 will need a  
11 Greenlight, so ...

12 COMMISSIONER BELL: Madam Chair --

13 VICE CHAIRPERSON DEWAELSCHE: Yes.

14 COMMISSIONER BELL: -- one more question  
15 concerning on this question here.

16 Chief, are these service station owners  
17 organized? Is there an association?

18 CHIEF CRAIG: Through the Chair, there is an  
19 organization. I can't tell you that all of them are  
20 part of this, but there is an organization out of  
21 Dearborn. That was an early meeting I held probably  
22 two months after my tenure, in fact. I didn't make  
23 very many friends at that meeting. And the reason why  
24 I didn't make very many friends, because I started to  
25 talk to the community, and the complaints I heard most

1 keep going to these gas stations crime is going on and  
2 dirty -- and they kept saying dirty.

3 So when I met with the gas station owners  
4 some were offended. I said this is not reflective of  
5 all, but if you have a dirty gas station clean it up.  
6 They say, well, why don't you send the policemen to  
7 come. I said I can do that, too, because that was  
8 during the early time that frankly DPD didn't respond  
9 to all calls. Of course we do now and have been.

10 But my point was in cleaning up the gas  
11 station we all know that when a place is filthy it does  
12 what, it attracts criminal activity. And so I knew if  
13 I was living in a neighborhood and I wanted to go  
14 someplace, whether it's a gas station, party store, if  
15 it's dirty I don't want to go inside of there, because  
16 you're going to find other things.

17 And so there was a lot of resistance to that  
18 early conversation, but since that time they've been  
19 great partners. I mean, great partners.

20 COMMISSIONER BELL: Thank you.

21 VICE CHAIRPERSON DEWAELSCHÉ: Chief, is it  
22 Nasser Beydoun who's the head of that association?

23 CHIEF CRAIG: In fact, Nasser Beydoun --  
24 what's interesting, that gas station on Wyoming and Six  
25 was our very first Greenlight. This is without all the

1 high end, high definition camera. He was our first.  
2 He bought it early on. And he admitted even before we  
3 upgraded to where we are today, he said he saw a  
4 significant increase in business right away.

5 So I mean this is good for business, it's  
6 good for our neighbors. And the saying it always says  
7 be a good neighbor. If you work, do business in the  
8 community, you may not live there, but be a good  
9 neighbor. You know, do your part in making that  
10 location a safe location.

11 So we're committed to it. And I've got to  
12 tell you our neighborhood groups have just been  
13 phenomenal.

14 VICE CHAIRPERSON DEWAEELSCHE: Thank you.  
15 That was a great presentation and a very good update on  
16 Greenlight. Thank you so much.

17 CAPTAIN SEVEC: You're welcome.

18 (Applause.)

19 VICE CHAIRPERSON DEWAEELSCHE: Next do we have  
20 any standing or ad hoc committee reports,  
21 commissioners?

22 COMMISSIONER BROOKS: Yes.

23 VICE CHAIRPERSON DEWAEELSCHE: Go ahead,  
24 Commissioner.

25 COMMISSIONER BROOKS: I'm going to talk about

1 recruiting. Sergeant Gonzalez and Commissioner  
2 Dewaelsche and I met the other day to talk about  
3 recruiting. We're losing and we're gaining. So we  
4 have a lot of discussions on the different colleges,  
5 the locations, on where we are recruiting.

6 And I was very impressed with Sergeant  
7 Gonzalez, because she -- I think she's out there. She  
8 talked about going out of the state of Michigan, within  
9 three and a half radius of the state. So she's been to  
10 Indiana Tech, Toledo Tech, and she has recruited a lot  
11 from Toledo. I hope I have all of this right.

12 Commissioner Dewaelsche suggests that we  
13 recruit up north, because jobs are not as plentiful.  
14 People need jobs. And we both agree that that's a  
15 very, very good suggestion.

16 Our churches we're doing great with  
17 recruiting at the churches, evangelist ministries,  
18 Dumas Outreach Ministries (ph), Perfecting Church and  
19 Solomon Temple. And we're also at Selfridge Air Force  
20 Base, which is -- I'm saying Air Force Base, but it  
21 really isn't an Air Force Base. It's a National Guard  
22 Base. And so we have all -- I think all of the  
23 departments there, the Army, Navy, Marines.

24 We talked about the high schools and what  
25 high schools that Sergeant Gonzalez has gone in. We



1 talked about what's going to happen in August. We had  
2 a veterans -- all these names I'm mentioning are names  
3 where there's going to be recruiting tables or either a  
4 booth. We're going to have the veterans in Southfield,  
5 DPD Field Day, Semac in Taylor. We're going to have  
6 the African World Festival in August and the Latino  
7 Festival. There were recruiting booths set up at the  
8 Tiger station, Grand Prix, Motor City Pride and Flat  
9 Rock's festival.

10 So we have a lot to discuss, and I feel that  
11 we're really, really doing well if we can get more  
12 people to sign up by letting them know that this is  
13 indeed a career.

14 And I think our police person that is going  
15 to Dallas is a good example of a career if you're a  
16 police person. So we couldn't do any better than that.

17 Also, we discussed and I'm going to -- we're  
18 going to talk to our personnel lady, Gail Oxendine,  
19 when recruiters get halfway or partway through and they  
20 decide this is not for me, or whatever reason, what can  
21 we do to keep them interested as a police career. So  
22 we would like to meet with you at some time to talk  
23 about what keeps a recruit from finishing and  
24 graduating. I know there are -- we know that there are  
25 a lot of reasons, but maybe we can help along the way

1 and stop some of those that would drop out and keep  
2 them going.

3 So, Sergeant Gonzalez, out there do you have  
4 anything to add?

5 SERGEANT GONZALEZ: No. Thank you.

6 COMMISSIONER BROOKS: I didn't want to do  
7 everything we talked about and name every school or  
8 church.

9 SERGEANT GONZALEZ: No, that was about it.

10 COMMISSIONER BROOKS: And our vice chair do  
11 you have anything?

12 VICE CHAIRPERSON DEWAELESCHE: I would just  
13 say that Sergeant Gonzalez is really out there doing  
14 heavy-duty recruiting.

15 COMMISSIONER BROOKS: Yes.

16 VICE CHAIRPERSON DEWAELESCHE: You can tell by  
17 her planner that she opened up as she sat down with us.

18 COMMISSIONER BROOKS: Yes.

19 VICE CHAIRPERSON DEWAELESCHE: It was just  
20 full of all of these activities, so ...

21 SERGEANT GONZALEZ: There is -- we are a  
22 team. So it's not just me. I have my officers, and my  
23 lieutenant helps us all with church and guides us with  
24 the church. And actually Chief Hall got us into some  
25 of the churches where I wasn't able to get in. So I

1 appreciate all the help, and I'm always out there. If  
2 you guys have any suggestions, any doors that I can  
3 walk through, I'm willing to walk through, but it's a  
4 team effort. So thank you.

5 CHIEF CRAIG: Through the --

6 VICE CHAIRPERSON DEWAELSCHE: And so I would  
7 highly -- oh, I'm sorry. Go ahead, Chief.

8 CHIEF CRAIG: No. I'll wait for you.

9 VICE CHAIRPERSON DEWAELSCHE: I was just  
10 going to say I would highly recommend if anyone in the  
11 audience, community groups, staff, if you know of any  
12 events that are occurring at your churches, at your  
13 schools, at your neighborhood groups, please send an  
14 E-mail to Sergeant Gonzalez, just  
15 GonzalezS@Michigan.gov, if that's what it is.

16 MS. OXENDINE: DetroitMI.gov.

17 VICE CHAIRPERSON DEWAELSCHE: Yes. And  
18 please, she'll follow up. She's done it. I'm sending  
19 her stuff every week and she follows up with everyone.  
20 So please help us.

21 Go ahead.

22 COMMISSIONER BROOKS: Let's not forget the  
23 Access job fair and all the others that are going on.

24 VICE CHAIRPERSON DEWAELSCHE: Yes. We're  
25 working with Access to also participate in their job

1 fair, and that's coming up. So, you know, we're doing  
2 as much as we can to spread the word that Detroit  
3 Police Department is hiring.

4 Okay, Chief.

5 CHIEF CRAIG: Through the Chair, I just want  
6 to remind the board when you compare what we're doing  
7 to other agencies across this country who are  
8 challenged with hiring, despite our pay that's not on  
9 par with many other agencies, we are in excess of 300  
10 police officers in the last fiscal year. That's not a  
11 small undertaking.

12 I want to also add that not too long ago, I  
13 think I pointed out in my earlier remarks, that there  
14 hadn't been promotions in this police department to the  
15 rank of sergeant and lieutenant for eight years. Over  
16 the last four years we have promoted or created over  
17 800 positions. And I only bring that up to suggest  
18 that we have created an environment of excitement and  
19 it shouldn't be overlooked, because we talk about what  
20 retains folks. They want to be in a place where they  
21 have solid leadership. They want to be in a place  
22 where they feel value that does matter.

23 And I was trying to understand some of your  
24 comments. It's not like we have -- one comes to mind.  
25 We did have a police officer that graduated from the

1 academy on a Friday and then on a Monday went to work  
2 quick and went to work over at Ford Field. I can't  
3 think of any other instances that way.

4 And the other part of it is we do have  
5 standards that we must maintain. Not everyone's going  
6 to make and graduate from the police academy. But I  
7 will tell you in my sense and judgment in comparison to  
8 what I see across the country and having been in other  
9 agencies, we do an above average job, well above  
10 average, and we are hiring some phenomenal recruits.  
11 Even the way they respond to some of the critical  
12 incidents, the shooting incidents that we've had that  
13 I've oftentimes talked about the ten police officers  
14 that have been shot or killed in the line of duty since  
15 September of last year. These are young people who go  
16 out, they perform ethically, constitutionally. And so  
17 I'm excited about that. I just wanted to make that  
18 point known.

19 VICE CHAIRPERSON DEWAELESCHE: Thank you,  
20 Chief.

21 Any other --

22 COMMISSIONER BELL: I just have one more  
23 comment.

24 VICE CHAIRPERSON DEWAELESCHE: Please.

25 COMMISSIONER BELL: We have this recruiting

1 effort. Chief, you might want to take the quote the  
2 military takes. Once a person they bring back and put  
3 them in a temporary assignment in terms of a career,  
4 young officers. So perhaps we can entertain that.  
5 They got one year under their belt. It could be  
6 contemporarily 30 days, whatever, it could be part of  
7 the recruiting process, because they are the ones who  
8 went through the academy and recently grads, you know.  
9 And I think especially if they might be -- you know,  
10 whatever high school they might -- you know, just go in  
11 there and talk to the seniors, just an idea. But, as  
12 you well know, that's the approach to the military.  
13 They put these young officers only on temporary  
14 assignment in terms of that type of approach. I don't  
15 know.

16 And I know Dallas PD years ago, I don't know  
17 if they can afford it now like most cities, they -- in  
18 fact, Memphis Police Department. My nephew was  
19 recruited out of college, and he got a signing bonus of  
20 \$5,000. This has been about 15, 20 years ago. And I  
21 think it's one way to reach out to Wayne State, U of D.  
22 I don't know. I know we strapped for money, but that's  
23 like a signing bonus that they was recruiting at the  
24 time. I don't know if we'll been able to indulge in  
25 that or not.

1 CHIEF CRAIG: But through the Chair, and I've  
2 reported out on this well over a year ago, I brought an  
3 idea here that we've done very effectively in Los  
4 Angeles called police magnet. We have two police  
5 magnet schools. We have young people in high school in  
6 police magnet programs in the city of Detroit. And  
7 because certainly one of the criticisms, and I know  
8 it's coming from this board, is how many Detroit police  
9 officers live inside the city of Detroit. So to  
10 counter that, certainly that's city law, that's the  
11 ordinance.

12 We have identified and looking at a third  
13 high school, a police magnet program. These young  
14 people all live inside the city of Detroit. And  
15 certainly the idea is upon graduation from high school  
16 they're poised to become Detroit police officers.

17 We have the unique distinction -- I don't  
18 know how many departments do it, but very few, but we  
19 hire at the age of 18. And so if you graduate you can  
20 literally graduate from high school, if you're 17 maybe  
21 go into a cadet program, and then maybe get hired in as  
22 a police officer. So we've designed that, because  
23 that's built in recruiting and it's worked very well so  
24 far.

25 VICE CHAIRPERSON DEWAELSCHE: Thank you. Any

1 other comments, commissioners?

2 COMMISSIONER VANN: Yes, Madam Chair. I know  
3 that in my congregation with the officers that I have  
4 there are extensive recruiting efforts by other  
5 municipalities. Atlanta, for example, where, of  
6 course, you know, there's been police shortages as we  
7 know throughout the country.

8 Have we seen an impact from other  
9 municipalities on our recruiting efforts?

10 CHIEF CRAIG: Through the Chair. In fact, we  
11 hired -- I want to say we hired one Dallas police  
12 officer. We hired one Dallas police officer.

13 DEPUTY CHIEF HALL: Yes, sir.

14 CHIEF CRAIG: We did hire one Dallas?

15 DEPUTY CHIEF HALL: Is that a nudge?

16 CHIEF CRAIG: I'm going to come get some  
17 more.

18 DEPUTY CHIEF HALL: Maybe I can take a few  
19 with me.

20 CHIEF CRAIG: I already know which ones. I  
21 think that beautiful shield says "Detroit Police."

22 But one area we've seen and we've lost I want  
23 to say eight -- we've lost eight of our police officers  
24 to the state of Washington. And I'm going to tell you,  
25 so here's what the state of Washington -- in fact, I



1 think it's their county. A county in the state of  
2 Washington came here aggressively recruiting right in  
3 -- yeah, where Seattle is located, but it was a county  
4 because they pay them 80,000 a year.

5 MS. OXENDINE: Tacoma.

6 CHIEF CRAIG: Tacoma? Tacoma, Washington,  
7 80,000 a year, take-home police vehicle.

8 Now, they have some retiree health care  
9 issues, pension issues. So the grass is not  
10 necessarily greener.

11 I will also tell you it doesn't surprise me  
12 that some of the officers that have been recruited away  
13 come back and --

14 MS. OXENDINE: Yes, they do.

15 CHIEF CRAIG: Gail, I know you're going to  
16 process the number, and how often do -- and one of the  
17 reasons why they don't always make it back to DPD is  
18 because candidly some of them leave here with some  
19 issues and so they want to come back home and the porch  
20 light is not on, so ...

21 COMMISSIONER BELL: We can identify with  
22 that.

23 VICE CHAIRPERSON DEWAELSCHÉ: Commissioners?

24 COMMISSIONER SANDERS: Through the Chair.

25 VICE CHAIRPERSON DEWAELSCHÉ: Go ahead,

1 Commissioner Sanders.

2 COMMISSIONER SANDERS: My report consists of  
3 ride-alongs. I've been doing it for the last I'll say  
4 four months. I'm at Precinct 11 right now. I just did  
5 a ride-along. And they didn't have the vehicles that I  
6 thought they would have, but I know they coming.  
7 Because I did talk to A.C. White and he explained it to  
8 me.

9 But Precinct 11 is a good police force. I  
10 noticed -- I rode along with a lieutenant that was  
11 training a recruiter. And the way that he was training  
12 that recruiter, you know, was shocking. He was really  
13 training the guy. We would drive, and the recruit was  
14 driving too fast so he'll tell him, okay, stop the car,  
15 stop the car and I want to get out. "Where are we at?  
16 Where are we at?" And the recruiter guy was thinking  
17 where we at, where we at.

18 And he say, "No, you can't do that. You've  
19 got to know where you are at all times."

20 And I like the way that he did that. You  
21 know, it's almost like you going to school and being  
22 trained while you in school doing math or arithmetic or  
23 anything in that order.

24 And I seen that out of most police force in  
25 stations that I have been around. So I seen that the

1 officers really care about training these recruiters.  
2 And I tell you it's a joy to see that -- even though I  
3 was sitting in the back seat, did not get hurt, sat in  
4 the back seat, and it was a good thing, you know.

5 I'm looking forward to going to Precinct 10  
6 next week. And I want to keep it going, because I want  
7 to know exactly what the officers do, you know, while  
8 they out there. And I want to see their functioning.

9 And, man, you've got some excellent officers  
10 and commanders of these police stations. I have had  
11 nothing but love from them. But we do need to get them  
12 new cars, though, please.

13 CHIEF CRAIG: Well, through the Chair. I  
14 don't understand what formula you're using to determine  
15 if we have enough or not. Now, I will say  
16 unfortunately, unlike other places I've been, we are  
17 self-insured. And so when a police car is totaled it's  
18 not replaced. So that's an issue. I'll just be  
19 candid.

20 But James White is here. And the council --  
21 not council. The commissioner is talking about number  
22 11 doesn't have enough cars, and I want to know what  
23 kind of formula is being used to determine what's the  
24 right number.

25 ASSISTANT CHIEF WHITE: So good afternoon,

1 board, and through the Chair.

2 COMMISSIONERS: Good afternoon.

3 ASSISTANT CHIEF WHITE: I'd like to just  
4 respond to that and just a couple things briefly.

5 The issue of cars with number 11, what  
6 happened with regards to their deployment is number 9  
7 leapfrogged in a sense. We felt at the time that  
8 number 11 had enough sustainable vehicles.

9 And as you indicated, Chief, with regards to  
10 the vehicles being self-insured, what that causes is a  
11 number of different issues. I don't know if my partner  
12 here -- I don't know what's going on, but he's going to  
13 give to the board a list of deployment for the city.

14 So since -- in approximately three and a half  
15 years we've deployed 375 new police vehicles. Those  
16 vehicles are deployed based on calls for service. So  
17 by way of example, number 8 and number 9 being the two  
18 busiest precincts in the city, they get the largest run  
19 total. Therefore, they get the largest number of  
20 vehicles.

21 Number 9's vehicle fleet went down. We made  
22 a decision, which I support, to leapfrog number 9's  
23 deployment. That impacted number 11's deployment, and  
24 they have lesser cars than they should have had.

25 To date, the emergency order -- the order

1 that this board signed off on this year we deployed 38  
2 vehicles. And we will continue to deploy based on that  
3 schedule.

4 Now, a couple of things happened. The  
5 initial list that the board got did not contain the  
6 changes that we made in that fleet. I've since had a  
7 meeting with the fleet team and informed them that the  
8 integrity of the list is very important. If you're  
9 operating thinking that there's five new cars in that  
10 particular precinct, you get there and they're not  
11 there because we made a change, then it looks like  
12 there's something going on with the list. So that  
13 should not happen going forward. The integrity of the  
14 list will be maintained, and if any changes are made  
15 the board will be informed of that.

16 CHIEF CRAIG: Can you talk about what our  
17 fleet looked like four years ago and where we are  
18 today?

19 ASSISTANT CHIEF WHITE: Yes, sir.

20 Prior to four years ago -- you know, there's  
21 been no investment in the fleet for approximately six  
22 years. And that investment also consists of repairing  
23 vehicles that were broken. I mean, when we had a lot  
24 of challenges, economic challenges, and the instability  
25 of the economic circumstances created a really bad

1 situation.

2 So our ten-year strategy is to really change  
3 the entire look of the vehicle fleet. It's hard to  
4 see, but when you watch the news and you see the fleet  
5 you are seeing some changes in the fleet. You do see  
6 newer vehicles in the fleet.

7 There's a date certain that we won't have any  
8 cars older than 2012. I just read that report last  
9 night.

10 When will that be, if you know? There's a --  
11 it's coming up soon. Do you know the date?

12 We'll provide you with the date where you'll  
13 actually see a flip in the fleet and the only vehicles  
14 that will be older than 2012, and I want to say October  
15 this year, will be NPO vehicles. And those are unique,  
16 because those vehicles are restored by schools and  
17 members in the community. Those are like donations to  
18 restore those vehicles. And for those members who live  
19 inside the city those are take-home neighborhood police  
20 vehicles.

21 VICE CHAIRPERSON DEWAELSCHÉ: Thank you.

22 Any questions or --

23 COMMISSIONER BELL: Yes, ma'am. We have  
24 Commissioner Crawford, through the Chair.

25 COMMISSIONER CRAWFORD: Yes, ma'am. Through

1 the Chair.

2 Also, Assistant Chief, the -- when you say  
3 the busiest precinct, number 9, that the second one was  
4 8, that equates to being more miles put on the vehicle.

5 ASSISTANT CHIEF WHITE: It equates to more  
6 miles being put on the vehicles. Number 8 being one of  
7 the most densely populated precincts in the community  
8 -- or in the city. And then the -- when we say busy,  
9 we're talking calls for service, number of runs and the  
10 vehicles and running literally 24 hours.

11 Compounded by another unique problem that  
12 happened at number 8, which is really an anomaly,  
13 they've had 13 accidents this year. Well, being  
14 self-insured you have to borrow cars from other  
15 precincts, and some of those precincts were 4, some of  
16 those precincts were number 11. So it creates -- it's  
17 a circumstance that we find ourselves with today.

18 However, the good news is we are constantly  
19 deploying. We're currently aligning number 8's  
20 vehicles off to be -- to coincide with the opening of  
21 the precinct. So the fleet manager can talk a little  
22 bit about that.

23 What is our goal for number 8 in a few weeks?

24 CHIEF CRAIG: You know what, before we get --  
25 and I'd also like you to explain to the board, and I

1 just saw it yesterday, I mean the new vehicles have  
2 been deployed to Gang Enforcement, the precinct's new  
3 -- brand new vehicles, Gang Enforcement, detective  
4 vehicles. So there have been a number of new vehicles  
5 added to our fleet.

6 UNIDENTIFIED SPEAKER: Yes. To speak to the  
7 Chief's point, so in our Gang Intel and our Cease Fire  
8 we've deployed 18 of the brand new black boosters in  
9 those operations. In addition, we've deployed 35 of  
10 our investigative operation vehicles to our homicide  
11 detectives, to our investigative ops in our particular  
12 precincts as well in addition to the eight raid vans  
13 that are in our narcotic operations.

14 What you see before you is our two deployment  
15 dates that are upcoming. We have one for the end of  
16 this month, July 31st, and we have another one slated  
17 for Labor Day weekend. What we've committed to is that  
18 an additional 15 vehicles will be deployed on July  
19 31st. So by July 31st 11 of the 12 precincts will have  
20 brand new cars in operation. The remaining precincts  
21 will receive theirs on that Labor Day weekend, and that  
22 is to make sure that we get all those upfitted.  
23 There's been a delay there. So it's not that we have  
24 the cars yet, but we're waiting for those to come from  
25 the upfitter.



1 VICE CHAIRPERSON DEWAELESCHE: Are there any  
2 other questions?

3 COMMISSIONER SANDERS: Through the Chair.  
4 This right here is an updated list; correct?

5 UNIDENTIFIED SPEAKER: Yes. That list is  
6 accurate as of today.

7 COMMISSIONER SANDERS: Because the list I had  
8 before I was going off that list, and so that's why I  
9 was going to the different precincts. So I was going  
10 off the list that you formerly gave me, you know. So  
11 when I got there and the vehicles wasn't there that's  
12 why I asked the question, you know, but the question  
13 was pretty much answered.

14 I understood, you know, when the precinct is  
15 not really taking care of their vehicles in accidents.  
16 That was first told to me when I first started it. But  
17 I did not have an updated list so I went off what I  
18 had, you know. That's why I asked the question. And I  
19 was concerned about the vehicles that the police  
20 officers that do the runs have, because I'm driving  
21 with them and I see old vehicles with some problems  
22 with it or there's vehicles that have a lot of miles on  
23 it.

24 So if you had a precinct on that list that  
25 say they supposed to get four vehicles that's what I'm

1 looking for them to have when I get there, but if they  
2 don't have them I'm going to ask the question.

3 ASSISTANT CHIEF WHITE: May I respond to  
4 that?

5 VICE CHAIRPERSON DEWAEELSCHE: Yes, please.

6 ASSISTANT CHIEF WHITE: Yes, sir, you're  
7 absolutely correct. We make no excuse for that. As I  
8 indicated, we called an audible on how we were doing  
9 deployment based on accidents and vehicles that went  
10 down. The list you had should have been updated and  
11 you should have received a new copy. That is the rule  
12 going forward, and that will happen.

13 As it relates to the list you had, frankly  
14 once we made the first change it was invalid so you  
15 wouldn't have known that, but ...

16 COMMISSIONER SANDERS: Right. So I was going  
17 off what I thought --

18 And on another note, when it comes to the  
19 precinct 11, I guess this have to do with the building  
20 maintenance, I notice the air conditioning is not  
21 working and it's hot as hell in there.

22 ASSISTANT CHIEF WHITE: I am prepared for  
23 that. That was last night at 8 p.m.

24 Okay. So I get to do the fun stuff. As you  
25 know, facilities comes through my command. So the air

1 conditioning wasn't working. You probably noticed it  
2 wasn't working in half the building; is that correct?

3 COMMISSIONER SANDERS: Yes.

4 ASSISTANT CHIEF WHITE: Okay. Now, let me  
5 explain very briefly why that is. There's two air  
6 conditioning units on top of the building. Both of  
7 them are brand new. One of them is burned out. And  
8 here's a problem that we have at precinct 11.

9 Was the area of the back of the precinct near  
10 the kitchen hot?

11 COMMISSIONER SANDERS: No. That was pretty  
12 cool. It was the squad room, the room where --

13 ASSISTANT CHIEF WHITE: The detectives are?

14 COMMISSIONER SANDERS: Yeah, where the  
15 detectives and where they meet at to go out.

16 ASSISTANT CHIEF WHITE: Okay. So what's  
17 occurring there is with the new technology of new  
18 efficiency equipment that you put in old buildings, old  
19 days when you turned the thermostat down in your home  
20 if it's 80 degrees and you want it to be 70 you turn it  
21 down, it turns into 70 and then the air would pop back  
22 on. New efficiency equipment is it seeks for the  
23 temperature. So if you turn it down to 60 and it's 70  
24 in the building it seeks 60.

25 Here's what happens at number 11. This is

1 why we're on or third chiller. Someone opens the  
2 window because the room is too cold and they want to  
3 balance the air out. Because they're cold personally  
4 they open the window or they open door to bring hot air  
5 in. The chiller is seeking -- it's picking up on that  
6 temperature change and it's seeking and it's running  
7 constantly and it burns up.

8 We've put two chillers in. I'm talking to  
9 the fleet team -- or facilities team now to solve that,  
10 go back to the old system. I understand you were told  
11 that the request has been out for a year. That is  
12 incorrect. It's been replaced twice in a year. We  
13 spent over \$200,000 on the air conditioning at number  
14 11, and we're currently going to solve that problem by  
15 potentially going back to an older system if we can.

16 COMMISSIONER SANDERS: Okay. I just want the  
17 officers, and I know you do, too, want them to be  
18 comfortable --

19 ASSISTANT CHIEF WHITE: Absolutely.

20 COMMISSIONER SANDERS: -- and that's what  
21 it's all about.

22 ASSISTANT CHIEF WHITE: If you visit number  
23 3, you'll see that the new locker room is in at number  
24 3 I just got notified of, and you know number 8 is  
25 coming online. And number 5 is absolutely beautiful.

1 COMMISSIONER SANDERS: Yeah. I'll visit all  
2 of them. I've got two to go, Gang Intelligence and  
3 precinct 10.

4 ASSISTANT CHIEF WHITE: Oh, good. We're  
5 painting Gang Intelligence this week. So you should --

6 COMMISSIONER SANDERS: That will be the last  
7 one.

8 ASSISTANT CHIEF WHITE: And just very  
9 briefly, another a little bit more information for the  
10 board. Merrill Plaisance. You'll remember Merrill  
11 Plaisance is the future location of the Office of Chief  
12 Investigator and potentially -- or possibly discipline,  
13 that's what it was programmed for, is officially back  
14 online. So someone from Facilities will be reaching  
15 out to the board for your programming needs on that  
16 building. It was already programmed with the previous  
17 board, but it's been a delay for a couple years. Now  
18 it's back. The dollars for that build-out were  
19 recently approved.

20 VICE CHAIRPERSON DEWAELESCHE: Great. Thank  
21 you very much for that update.

22 COMMISSIONER SANDERS: Great. So we're going  
23 to get our cars.

24 ASSISTANT CHIEF WHITE: Oh, cars. Your cars.  
25 So --

1 COMMISSIONER SANDERS: I thought I'll ask all  
2 the questions while I've got you.

3 ASSISTANT CHIEF WHITE: So your cars -- the  
4 issue came up at the last board meeting. There was a  
5 request for 16 vehicles made when that initial request  
6 came in. All vehicles go through fleet, which means  
7 they get certain things. They get a radio, they get  
8 the GPS system. I described the GPS as the little puck  
9 that sits on the back of the cars. We made a decision  
10 to cut costs and put the older radio systems in the car  
11 bringing the number in at just around \$3,000 in  
12 addition to the cost of the vehicle.

13 After talking with the board, there was  
14 concern as to how did we arrive at that decision. We  
15 talked through that. We went back to the table, and  
16 most recently we came up with -- out of the office of  
17 procurement that your vehicle approved allotment was 11  
18 vehicles. We will not put the puck or the radio in the  
19 vehicles, because my understanding is that the board  
20 didn't understand the need at the time. And those are  
21 approved.

22 But your vehicles will run under GSD, which  
23 means they will not come through our facilities or  
24 fleet program, and those vehicles are approved. We  
25 have those dollars for you we can provide the board

1 after this meeting what the numbers are, what the  
2 dollars are, and there's no additional cost for that.  
3 So there will be 11 approved.

4 And they are being programmed right now or  
5 no?

6 UNIDENTIFIED SPEAKER: Yes. They're slated  
7 for approval at council this month, and we're slated to  
8 buy in August. And we expect a sometime late fall,  
9 early winter delivery.

10 ASSISTANT CHIEF WHITE: And because there's  
11 no upfitting they will literally hit the ground. Once  
12 they're tagged and we put the numbers on they'll be  
13 issued to the board.

14 COMMISSIONER SANDERS: Thank you.

15 VICE CHAIRPERSON DEWAEELSCHÉ: Thank you.  
16 Commissioner Crawford.

17 COMMISSIONER CRAWFORD: Yes, through the  
18 Chair.

19 Assistant Chief, I want to thank you for your  
20 explanation on the heating and cooling system on 11. I  
21 fully understand everything you just stated about it.  
22 I work at the Wayne County Jail and it's hot, the  
23 chiller is out. I want you to know that.

24 VICE CHAIRPERSON DEWAEELSCHÉ: Thank you.  
25 Any other commissioners? Yes.

1                   COMMISSIONER BELL: Just one question perhaps  
2                   A.C. White can do a follow-up on. I think we talked  
3                   about this in the past. Could you report out at some  
4                   point in time in reference to officers who are at fault  
5                   in some of these accidents. And, as we know  
6                   historically, it's a whole lot of concern about how we  
7                   drive these department cars. And so the retraining or  
8                   re-instruction aspect of it.

9                   And I just want to commend you, A.C. White,  
10                  in terms of your administration, knowledge and hands on  
11                  has really been -- you know, you've really been on  
12                  point in terms of understanding. Because these issues  
13                  are old, Commissioner Sanders, the building, and we  
14                  don't even want to talk about the fleets at all. So if  
15                  we can have a fireworks on 2000 getting rid of all  
16                  those old vehicles at some point in time, then we  
17                  should celebrate, but not always take seriously these  
18                  officer dialogue with you. They don't all -- they  
19                  don't really all know the truth. Somewhat, you know,  
20                  they're going to give you that aspect of it, you know,  
21                  but -- and it's always good to do a follow-up with the  
22                  source in terms of checking things out.

23                  We've come a long way in terms of building  
24                  maintenance and fleet control in the four years that I  
25                  have been sitting at this table in terms of reporting



1 out where we are, this type of breakdown, you know. I  
2 just want to commend you on that.

3 ASSISTANT CHIEF WHITE: Well, thank you, sir.  
4 And I have one more final but very important item for  
5 the board, if I may.

6 VICE CHAIRPERSON DEWAELESCHE: Go ahead.

7 ASSISTANT CHIEF WHITE: Assets and licensing  
8 under Lieutenant Parish who is here today conducted an  
9 investigation at my direction based on a number of  
10 complaints that we received. Emanating from that  
11 investigation, the department took immediate action  
12 against a tow company. That tow company is Nationwide  
13 Towing.

14 The rules contemplate emergency situations  
15 where the conduct of the tower is such that permitting  
16 the tower to continue in its capacity could bring the  
17 department in ill repute. We thought based on the  
18 information that we had at the time that such action  
19 was necessary.

20 I want to emphasize this was not done to  
21 circumvent any rules of the board or nor was it done to  
22 avoid a due process for Nationwide Towing. We just  
23 thought that the action on behalf of the department was  
24 necessary at the time. So we have took actions, swift  
25 action, to suspend.

1                   There's an active investigation into some  
2 actions that occurred with Nationwide Towing. The  
3 information, the evidence, has been turned over to  
4 Internal Affairs and there's an active investigation  
5 underway. I will keep the board informed.

6                   And I've also contacted the Law Department.  
7 The Law Department is aware of the circumstances. We  
8 shared the information, the preliminary information  
9 with them, and they are prepared to defend the  
10 department's position should this go to litigation.

11                   VICE CHAIRPERSON DEWAELESCHE: Thank you very  
12 much for that update.

13                   Any other comments or questions?  
14 Commissioner?

15                   COMMISSIONER VANN: May I just ask, just sake  
16 of information. I'm not trying to start anything. The  
17 department has the unilateral authority to do so?

18                   ASSISTANT CHIEF WHITE: The rules are such  
19 that immediate -- "The City may terminate" -- the City  
20 is how it's defined -- "may terminate any towing permit  
21 with a tow company for fraud or criminal activity by  
22 the tow company or its employees provided, however,  
23 that as soon as practical the permit holder shall be  
24 afforded an opportunity for a hearing before the Board  
25 of Police Commissioners."

1                   So acting on that we took the immediate  
2                   action.

3                   COMMISSIONER VANN: And will you be informing  
4                   us and keeping us posted? I'd also like to know the  
5                   ownership of the business as well, et cetera.

6                   ASSISTANT CHIEF WHITE: Yes, sir, I will. We  
7                   should have our completed investigation within 45 days,  
8                   updates within about 14 days for the board.

9                   VICE CHAIRPERSON DEWAEELSCHÉ: Any other  
10                  questions, comments?

11                  Hearing none, thank you very much, Chief.

12                  ASSISTANT CHIEF WHITE: Thank you.

13                  VICE CHAIRPERSON DEWAEELSCHÉ: The board  
14                  secretary report. Do you have anything, Mr. Hicks?

15                  MR. HICKS: Thank you, Madam Chair. You have  
16                  listed on your agenda seven items which have come to  
17                  the attention of the board. We also added an eighth  
18                  item, which was a memorandum that was sent from A.C.  
19                  White specifically on the issue which you just covered.  
20                  So that is in your package. And he -- in that  
21                  communication it also specifies the authority in which  
22                  they acted upon. So that's inside of the report in  
23                  which you have in front of you.

24                  The other things in which you received during  
25                  this period of time of course were not only

1 communications on an update on the Greenlight  
2 locations, but we also received two disciplinary  
3 actions in which the Chief was recommending for this  
4 board.

5 In talking with the Chair of the commission  
6 and trying to anticipate the number of commissioners  
7 who will be present at today's meeting, the Chair put  
8 that particular item over for next week, because when  
9 we go into a closed session, assuming that we concur  
10 with the recommendation of the Chief, it will require a  
11 two-thirds vote. And at the time in which we were  
12 considering participation at today's meeting we will  
13 have just fell short of the two-thirds. So, therefore,  
14 this is being put over to the next meeting where we are  
15 very likely to have the necessary members present in  
16 order to look at that action.

17 And we will be contacting of course the  
18 department in the event that that changes, but we would  
19 expect to pick that up in the next meeting.

20 And then of course from that you have some  
21 communications from members of the public who are  
22 making varying concerns known where those  
23 communications have been referred to the office of the  
24 Chief Investigator that is noted and where they have  
25 been referred to other places inside the department

1 that is also noted.

2 And with that, Madam Chair -- oh, I should  
3 point out one thing. In your agenda today there you  
4 have for the next meeting for July the 27th. That is  
5 correct. But I would want to point out in the public  
6 agenda that was sitting on the back, and the public may  
7 have picked up, there is a July 20th date. So if  
8 members of the public if you can simply note that the  
9 next meeting is July the 27th as opposed to the 20th.  
10 And all of the other communications that have gone out  
11 reflected the correct dates.

12 VICE CHAIRPERSON DEWAELESCHE: Thank you,  
13 Mr. Hicks.

14 Next on the agenda is there any old business  
15 to cover? Any old business?

16 COMMISSIONER BELL: Madam Chair.

17 VICE CHAIRPERSON DEWAELESCHE: Go ahead.

18 COMMISSIONER BELL: I'd like to look at old  
19 business that we were without an attorney to the board  
20 quite some time. And I think the board would under  
21 Mr. Hicks and attorney to first of all report out to  
22 the board in terms of where we are with legal issues.  
23 And then at some point in time I think after that is to  
24 make a public statement in reference to whatever we  
25 might agree on that should be shared publicly. But

1           there are some issues that we have been dealing with  
2           without an attorney to the board, as we all know. So I  
3           think that now we have an attorney on board that we  
4           need to be brought up to speed in terms of what we're  
5           focusing on, what might be something we need to look  
6           at. So that would be my suggestion, that we can obtain  
7           that in those two particular areas in terms of  
8           returning to the board.

9                         MR. HICKS: Madam Chair, if I can interrupt.

10                        VICE CHAIRPERSON DEWAELESCHE: Yes.

11                        MR. HICKS: Such a review is already  
12           underway. And we should have some information back and  
13           a presentation to the board very soon.

14                        COMMISSIONER BELL: Thank you.

15                        VICE CHAIRPERSON DEWAELESCHE: Thank you.

16                        Any other old business?

17                        Any new business to cover for the board?

18                        COMMISSIONER BROOKS: Yes. I would just like  
19           to make announcements for recruiting. July the 22nd,  
20           March Education DPS, which I think is Saturday at Clark  
21           Park in southwest. Team Wellness, which is a job fair,  
22           July the 28th, and that's from 9:00 to 1:00. That's on  
23           Mack. July the 23rd, Solomon Temple, 10:30 to 2 p.m.  
24           And July the 29th recruiting at the Sheriff County  
25           Department Field Day, which is 2100 West Warren, from

1 10:00 to 6:00.

2 So anyone out there that knows anyone that  
3 would like to come to any of these please let them  
4 know. We really would appreciate it. We don't miss an  
5 opportunity when it comes to recruiting. So I'll be  
6 out there if anyone wants to tell me of any places, any  
7 recreations, any parks, any schools anywhere. Sergeant  
8 Gonzalez will be there. Thanks.

9 VICE CHAIRPERSON DEWAEELSCHÉ: Thank you,  
10 Commissioner.

11 Any other new business? Announcements?

12 Our next meeting is going to be, as Mr. Hicks  
13 indicated, Thursday, July 27th here at Headquarters at  
14 3 p.m., 1301 Third Avenue in Detroit, of course. And  
15 then the next community meeting is Thursday, August  
16 10th, 6:30 p.m. in the Fifth Precinct at Kean's Marina,  
17 K-E-A-N'S Marina, and that's at 100 Meadowbrook, south  
18 of Jefferson and west of St. Jean.

19 COMMISSIONER VANN: On the east side.

20 VICE CHAIRPERSON DEWAEELSCHÉ: On the east  
21 side.

22 And now we're ready to hear oral  
23 communications from the audience, Mr. Brown.

24 MR. BROWN: Madam Chair, I have five  
25 speakers. The first one is Mr. William Davis, followed

1 by Ms. Sharon Harper-Lee.

2 VICE CHAIRPERSON DEWAELESCHE: Thank you.

3 MR. DAVIS: Good evening, board. My name is  
4 William M. Davis. I'm the president of the Detroit  
5 Active -- I'm the president of the National Action  
6 Network, Detroit Chapter.

7 And I thought I would raise a concern that's  
8 been brought to me by a number of people. There's a  
9 concern that I think I'll bring it to you instead of  
10 taking these outside actions, but there's a concern  
11 that a number of people, panhandlers or what have you,  
12 when they're being stopped and ticketed in downtown  
13 Detroit and on Jefferson near the approach to Belle  
14 Isle that people are being stopped, panhandlers  
15 stopped, ticket. And they get multiple tickets for  
16 this, you know, this stop. They might get anywhere  
17 from one to seven or eight tickets at one stop. And  
18 these are people that frequently cannot afford to pay  
19 anything, especially if they get a number of tickets.

20 And I was wondering is that a policy to give  
21 multiple tickets at one stop, especially for somebody  
22 that's like stopping with loitering? You know, I don't  
23 think that's right. And I hope this is not the policy  
24 and that's not what's going on, but this has been  
25 brought to our attention. And I'm hoping that that's



1 not the case.

2 Also, a second thing, you know, like my  
3 youngest son still lives at home. He goes to Wayne  
4 County Community College. He's in law enforcement. I  
5 got an associate degree from there myself 40 years ago.  
6 But I noticed a number of his friends was over and they  
7 was asking him about the Detroit Police Department.  
8 And I noticed a lot of them are in criminal justice,  
9 you know, law enforcement. And a lot of them saying,  
10 you know, one of the reasons why they don't consider  
11 Detroit is the fact that you have to pay to try to get  
12 a job, you know. I don't think you should have to pay  
13 anything to take any tests to be part of it.

14 VICE CHAIRPERSON DEWAELESCHE: Chief, could  
15 you respond?

16 CHIEF CRAIG: Through the Chair. To your  
17 latter concern, that's not true. There's no paying for  
18 a test. And Gail Oxendine seated behind you she  
19 administers that process. There's no -- we've done  
20 things to make it much easier for --

21 MR. DAVIS: So it's not a preemployment test?

22 MS. OXENDINE: There's no cost.

23 CHIEF CRAIG: There's no cost. The other  
24 thing, those officers that go through our academy that  
25 are selected there's no cost to that. Many young

1 people go to the community college I think I can name  
2 offhand they pay \$6,000 to go through. So there's no  
3 cost. I don't know where that's coming from.

4 MR. DAVIS: Okay. I notice a number of them  
5 are saying that they go to Wayne County Community  
6 College in the law enforcement program.

7 COMMISSIONER BELL: If I might chime in on  
8 that, too.

9 CHIEF CRAIG: There might be a cost there.

10 VICE CHAIRPERSON DEWAEELSCHÉ: Yes. At the  
11 community college there is a cost.

12 MR. DAVIS: No. I'm talking about just take  
13 the test, take a test.

14 VICE CHAIRPERSON DEWAEELSCHÉ: Oh, okay.

15 CHIEF CRAIG: Not our test. I don't know  
16 what test, but not ours.

17 VICE CHAIRPERSON DEWAEELSCHÉ: Commissioner  
18 Bell?

19 COMMISSIONER BELL: I don't know how that can  
20 be true, because we have -- they hosted our meeting  
21 there, and you've got several individuals who served  
22 prominently in this department, including James  
23 Jackson, head of the criminal justice department, and  
24 Dr. James Younger and Deborah Rawlinson (ph), even our  
25 board secretary, George Anthony. I don't know where

1 your son got the information, but we have just --

2 MR. DAVIS: That's why I thought I would  
3 bring it up.

4 COMMISSIONER BELL: Well, anyway you should  
5 check with him, because that's totally erroneous  
6 information. Because those individuals are former DPD  
7 and they have been aggressively recruiting. That's  
8 where we host our meeting there. We have interact with  
9 them, and I just spoke recently to the head of that  
10 department just yesterday in terms of activity. So --

11 MR. DAVIS: Okay. I was hoping it wasn't  
12 true.

13 COMMISSIONER BELL: -- I don't know where you  
14 got this information at all.

15 COMMISSIONER CRAWFORD: Yes, through the  
16 Chair. It's quite possible they may have some miss --  
17 obviously some misinformation about some MCOLES  
18 testing.

19 MR. DAVIS: Yeah, that's what they said.

20 COMMISSIONER CRAWFORD: They used to charge.  
21 Am I correct?

22 MS. OXENDINE: Okay. I can clear it up.

23 COMMISSIONER CRAWFORD: Yeah, because I think  
24 it was six or seven months or something like that --

25 CHIEF CRAIG: As to your first item, a

1 lieutenant from my office if you will try to get some  
2 information. I'm unaware of anybody getting multiple  
3 citations. A citation maybe, you're talking about  
4 multiple.

5 MR. DAVIS: Right. Because they said that  
6 these people frequently can't even make bail. So they  
7 have to end up spending time and it's costing money  
8 that we shouldn't be have to pay.

9 VICE CHAIRPERSON DEWAEELSCHÉ: Thank you,  
10 Chief.

11 Director?

12 MS. OXENDINE: Yes. Director Gail Oxendine,  
13 for the record. So with respect to the testing, the  
14 testing is an MCOLES exam. And there is a cost for  
15 that exam, which is \$68 for the written exam and  
16 there's some -- I can't remember what the fee is for  
17 the physical agility. However, our agency assumes that  
18 cost. So if someone is applying for a job with us  
19 there is no cost for those exams.

20 MR. DAVIS: Okay.

21 VICE CHAIRPERSON DEWAEELSCHÉ: Thank you for  
22 that clarification.

23 Commissioner?

24 COMMISSIONER BROOKS: Yes. And I'd like to  
25 comment on the first part that you spoke of. At one of

1 our community meetings at Wayne County Community  
2 College I asked the question that you asked, not  
3 because someone said that people were being, you know,  
4 ticketed, but because I would see police on Jefferson  
5 talking to some of the people. So I asked the same  
6 question, and I was told that they were being of help,  
7 could they help that person, if that person was  
8 homeless or if that person had a problem, if that  
9 person was ill, that they would help that particular  
10 person. So that's the answer that was given to me.

11 MR. DAVIS: Okay. Thank you.

12 VICE CHAIRPERSON DEWAELSCHÉ: Thank you,  
13 Commissioner.

14 Any other -- the next --

15 MR. BROWN: Ms. Lee followed by Mr.  
16 Nathaniel Lee.

17 MS. HARPER-LEE: Good evening, everyone. I  
18 just want to say thank you so much for allowing me as a  
19 resident of the city of Detroit for 60 years. I love  
20 Detroit. I believe in the police, but there are some  
21 bad ones that I have come in contact with, which broke  
22 my heart. And my husband and I live in our house in  
23 the university district for 24 years. We have four  
24 kids. They're all grown and gone. But we have been  
25 harassed, threatened. My husband has been assaulted.

1 I have 109 pictures. I have video of this as  
2 even as early as today. As we are leaving the house  
3 the same woman is stalking us, letting us know that  
4 she's there and that she will have her soldiers, as she  
5 has stated to us, Young Boys, Incorporated, take care  
6 of us, and this is not over.

7 All I do is go to church, go to the gym for  
8 arthritis. My husband, he likes television, and he's a  
9 retired FBI. There is no justifiable reason that us as  
10 good citizens of the city of Detroit who have done no  
11 harm prior to this harassment and everything.

12 The police came in last year. We -- just  
13 real quick, I talked to the second in charge, he is no  
14 longer here, at that time. And we went to 12 and he  
15 told my husband and I and screamed at us, "Let me tell  
16 you how this gonna end." He jumped up, pointed his  
17 finger in our face, and told us that we would be shot  
18 and that's how this was going to end.

19 We were so hurt and so flabbergasted that we  
20 went to see my dad, and we decided to take a mental  
21 break. And then a Detroit police broke in our house  
22 and broke down eight doors to my home. My home is very  
23 neat, very clean. Nothing is going on there. I don't  
24 know what lie was told, but these false police reports  
25 that are being written, allowed to be put into evidence

1 and to bring charges possibly against me and my husband  
2 through the prosecutor's office.

3 Chief Craig, we really, really, really need  
4 some help. These are just a bunch of lies. I have all  
5 the proof, all the evidence, and I mailed it to you  
6 four years ago and it came back to me like four months  
7 later with a flash drive gone. But the picture and the  
8 data that I had given you, Kym Worthy and the  
9 department, Detroit criminal department I think it is,  
10 I mailed out the package and it came back to me.

11 So basically we're living in fear, and now  
12 we've got road rage. So we don't know what's going to  
13 happen, if we're going to be living or not living. I'm  
14 driving 25 miles an hour everywhere now. I can't even  
15 get on the freeway.

16 So I just hope and I just pray to God that  
17 you will, in fact, help us. And I put everything on  
18 the internet, because no police officer would believe  
19 us, basically laughed at us and told us to move.  
20 Whether it's gentrification, discrimination, age  
21 discrimination, it is not fair at all.

22 VICE CHAIRPERSON DEWAELSCHÉ: Chief?

23 CHIEF CRAIG: Through the Chair. I don't  
24 know if I have my Internal Affairs. Apparently there's  
25 been some look at this issue, but I don't know to what

1 degree. But I have Commander Bush here. Maybe you can  
2 look through her files and work with -- this is the  
3 complainant. The husband is here?

4 MS. LEE: Yes, my husband --

5 CHIEF CRAIG: Maybe you want to wait until he  
6 gets done, and also if you will take this ...

7 VICE CHAIRPERSON DEWAELESCHE: Thank you,  
8 Chief.

9 CHIEF CRAIG: Okay. You're welcome.

10 VICE CHAIRPERSON DEWAELESCHE: Our next  
11 speaker?

12 MR. BROWN: Mr. Lee, followed by Mr. Blount.

13 MR. LEE: Good afternoon, board.

14 COMMISSIONERS: Good afternoon.

15 MR. LEE: I just want to say everything that  
16 my wife has said is true. It's gotten to the point  
17 where this person in our neighborhood two doors away is  
18 lying to the point where police are responding to our  
19 home, sirens going, searching the car claiming we have  
20 weapons. They have -- like my wife told you, they had  
21 a warrant to come in. And they kicked in all our doors  
22 over something that was a lie.

23 I don't know how inappropriate I can get  
24 here, but this situation has got to the point where she  
25 has accused me of exposing myself. We tell the police,



1 Twelfth Precinct, nothing. They say there's nothing  
2 they can do.

3 My wife has been through it. I've been  
4 living in the south, because every time I come home  
5 this situation starts up again. We've been to Twelfth  
6 Precinct numerous times, and it's getting to be where  
7 they look at us like it's a joke.

8 So anyway I just want to thank you for the  
9 time you've given me today. I'm going to talk to the  
10 gentleman that you have my wife speaking with, and I  
11 hope that we can get some kind of resolution, because  
12 this has been going on for -- since 2011. Thank you.

13 VICE CHAIRPERSON DEWAELSCHÉ: Thank you, sir.

14 MR. BROWN: Mr. Eric Blount followed by  
15 Mr. Troy Ginyard.

16 MR. BLOUNT: Good evening, everyone.

17 COMMISSIONERS: Good evening.

18 MR. BLOUNT: My name is Eric Blount. I'm a  
19 life-long Detroiter. And I've come to this board  
20 before to talk about the use of body cameras, which I  
21 have been informed that by mid December the body  
22 cameras will be deployed. I also asked about TASERS as  
23 a nonlethal way of handling situations that need to be  
24 controlled.

25 My concern today is the recent news articles

1 about handling misbehaving police officers has led me  
2 to do some research and be concerned about how Mark  
3 Diaz is being investigated. And I'd like an update on  
4 that and the history of the report for the core  
5 committee that you instituted, Chief, and where it  
6 stands now and where it's going to go. Thank you.

7 CHIEF CRAIG: Through the Chair. As it  
8 relates to body cameras, as I reported out, we should  
9 be fully deployed probably by the next couple months.  
10 We're ahead of schedule, as I reported out. In fact,  
11 there was a recent incident where one of our officers  
12 was accused of beating an individual, and that officer  
13 sustained being tased by someone. It was a lie, and  
14 the body camera refuted the allegation. So we're going  
15 into full deployment, but that hasn't happened.

16 As it stands now, when we're fully deployed,  
17 we will probably be the first major city police agency  
18 that has a fully integrated system, meaning that the in  
19 car and the body camera they communicate with one  
20 another. So that's that.

21 As it relates to Mark Diaz, there is a  
22 pending criminal matter and so we are waiting. He is a  
23 Detroit police officer. Ironically, he also holds the  
24 position as the president of the DPOA. So there's not  
25 much we can do at this point until the criminal

1 investigation is complete and then we will complete our  
2 administrative investigation.

3 VICE CHAIRPERSON DEWAEELSCHE: Thank you.  
4 Commissioner Crawford?

5 COMMISSIONER CRAWFORD: Yes, ma'am, through  
6 the Chair, some added information on Mark Diaz. I know  
7 there was a court date on the 17th. I believe it was  
8 Monday. So I don't know the status of that, but if I  
9 get some information I'll be glad to convey it to you,  
10 sir.

11 CHIEF CRAIG: Through the Chair, that matter  
12 has been moved to September, I believe.

13 COMMISSIONER CRAWFORD: Okay.

14 CHIEF CRAIG: The latest information I got.  
15 So we generally when there's a criminal matter, which  
16 did not happen in Wayne County or the city of Detroit,  
17 we're not controlling that. The investigation is  
18 complete, as you know. He has been charged. We're  
19 just waiting for the disposition of the case.

20 VICE CHAIRPERSON DEWAEELSCHE: Thank you.  
21 Our next speaker?

22 MR. BROWN: Madam Chair, our last speaker is  
23 Mr. Troy Ginyard.

24 MR. GINYARD: Good afternoon, board, police  
25 department, Chief of Police.

1 VICE CHAIRPERSON DEWAELESCHE: Good afternoon.

2 MR. GINYARD: My name is Troy Ginyard,  
3 president of Troy's Towing. I am coming to you today  
4 because I just wanted to inform the board of a process  
5 that was brought to my attention verbally today, which  
6 is the abandoned vehicle process better known as  
7 private property impounds where you would impound  
8 vehicles for property owners off their property that  
9 doesn't belong there or they're unauthorized.

10 I was told today that Commander -- and  
11 forgive me if I'm saying it wrong -- Galanalli (ph)  
12 from --

13 CHIEF CRAIG: Giaquinto?

14 MR. GINYARD: Giaquinto. Maybe I'm saying it  
15 wrong. Thank you, Chief. From Third Precinct. I was  
16 told that today there was a -- or yesterday there was a  
17 process that was initiated by him that the tower must  
18 call 911 before hooking to a vehicle, and once the  
19 officer gets out there that the property owner has to  
20 be present or the driver has to have a copy of the  
21 contract between the tow company and the property owner  
22 in order to move forward.

23 I do have -- in case this board did not -- or  
24 wasn't aware, I do have some copies of the -- one, the  
25 state law and, two, the standard operating procedure

1 that was put in place by the department October 2014,  
2 which states in there that the tower is to pick up the  
3 vehicle and take it to the precinct to be processed.

4 Now, there's two things that I have concerns  
5 with is, one, the citizens are going to suffer from  
6 this process, because this is really not an emergency  
7 situation to me. Two, the police officers won't be  
8 able to do their job accurately by responding to a tow  
9 that is not an emergency.

10 And I have spoke to Lieutenant Parish about  
11 this issue today, which he is present here today. Him  
12 and Sergeant Anderson are very aware of what's going  
13 on. And I did not have any clear information, nor do I  
14 have anything in writing, because it has not been  
15 presented in writing.

16 So I just wanted to bring this information to  
17 the board. And I'm very confident that Lieutenant  
18 Parish and Sergeant Anderson is going to get this issue  
19 resolved, but I just wanted to bring it to the board's  
20 attention.

21 The other thing that I want to also bring to  
22 the board's attention is on June 20th my immediate  
23 supervisor, Nickell Jones (ph), requested for a copy of  
24 the current tow rotation for our DPD towing permit. It  
25 was forwarded to the law department. They gave us a

1 response back. However, I know, in fact, that it is  
2 not the current tow rotation. So I just wanted to  
3 bring that also to the board's attention.

4 Does anybody have any questions for me?

5 CHIEF CRAIG: Through the Chair.

6 VICE CHAIRPERSON DEWAEELSCHE: Yes, go ahead.

7 CHIEF CRAIG: Lieutenant Parish is here.

8 One, I can say before he responds, I'm unaware of any  
9 policy where someone dials 911. 911 is an emergency  
10 call.

11 MR. GINYARD: Exactly.

12 CHIEF CRAIG: And so that doesn't make any  
13 sense to me.

14 So, Lieutenant Parish, can you come up.

15 MR. GINYARD: Just real quick just so you  
16 know, I had a driver at the precinct today and he was  
17 told that. They said we're going to go ahead and  
18 process this one, but the next one you consider picking  
19 up a stolen car.

20 LIEUTENANT PARISH: May it please the board.

21 So Commander Giaquinto issued an order that the tower  
22 dial 911 so that a police officer could be dispatched  
23 to a private property tow.

24 There is a basis for his order in Michigan  
25 law. Under the abandoned vehicle statutes a tower is

1 required to provide a police department with reasonable  
2 notice that the vehicle is to be towed. Commander  
3 interpreted this as a green light to receive that  
4 notice through the 911 system and allow the opportunity  
5 for the Detroit Police Department to send a car out.

6 This was a verbal order. Nothing has gone  
7 out in writing. However, because it is grounded and  
8 the law carries -- the order carries the functional  
9 equivalent to a policy, and officers have been adhering  
10 to it.

11 I assured A.C. White that I would have a  
12 policy recommendation to him by the end of the day  
13 tomorrow. We have begun pulling policies from other  
14 police departments to see how they reconcile their  
15 practices with this provision of Michigan law. We've  
16 obtained five policies so far and the results have  
17 varied. There are some police agencies that do  
18 dispatch an officer to run the vehicle in LEIN to  
19 ensure that it is not a stolen vehicle or isn't a  
20 homicide vehicle prior to allowing the tower to remove  
21 it, but we've also seen the opposite. We've also seen  
22 a police agency that, for example, the policy is for  
23 the tower to contact the desk, and the desk then is  
24 expected to direct the tower to the station, something  
25 somewhat comparable to what the practice was.

1                   This matter is being researched, and I  
2                   assured Troy and the other towers that have contacted  
3                   us that we will have something in writing, a policy by  
4                   the end of the day tomorrow from the assistant chief of  
5                   police.

6                   COMMISSIONER VANN: Madam Chair?

7                   VICE CHAIRPERSON DEWAELESCHE: Yes,  
8                   Commissioner.

9                   COMMISSIONER VANN: This makes no sense  
10                  whatsoever. And how did the commander, Chief, make  
11                  such an edict certainly without your authority?

12                  CHIEF CRAIG: Through the Chair.

13                  Commissioner Vann, I'm unaware of it and  
14                  so --

15                  COMMISSIONER VANN: Right, and you just said  
16                  it.

17                  CHIEF CRAIG: I need to find out. I mean,  
18                  911 is an emergency call. If we have towers dialing  
19                  911 to pick up an abandoned vehicle, I have a problem  
20                  with that. We're talking about a vehicle being stolen  
21                  in process.

22                  So someone should have come to me.  
23                  Commanders do not make policy. So I will need to have  
24                  that conversation sooner or later.

25                  COMMISSIONER VANN: It would seem that it



1 would flood the 911 system unnecessarily.

2 CHIEF CRAIG: This thing about Michigan law,  
3 am I to sit here to understand that Michigan law  
4 specifically states 911?

5 LIEUTENANT PARISH: No, Chief. The provision  
6 of Michigan law that Commander Giaquinto was relying on  
7 was a clause that required the tower give reasonable  
8 notice to the police department --

9 CHIEF CRAIG: Via 911?

10 LIEUTENANT PARISH: Not via 911, no. Just  
11 reasonable notice. And other agencies simply require  
12 the tower to contact the desk. We have seen at least  
13 one agency that does require the dispatching of a  
14 police officer.

15 CHIEF CRAIG: And that may be, but not via  
16 911. And it would not be -- with the number of  
17 emergency calls, priority 1 calls for service that we  
18 handle in this city, I in no way will authorize the  
19 calling of 911. I don't care about interpretation. It  
20 is my directive that there is another process. This  
21 makes no sense to me.

22 So to the board I will follow up, because  
23 like you, Commissioner Vann, I'm confused.

24 COMMISSIONER VANN: Me, too.

25 VICE CHAIRPERSON DEWAEELSCHÉ: Thank you,

1 Chief.

2 CHIEF CRAIG: I will get to the bottom of it.  
3 Thank you for bringing this matter to my attention.

4 VICE CHAIRPERSON DEWAEELSCHE: Thank you,  
5 Chief.

6 COMMISSIONER BELL: Madam Chair, I will say  
7 that to you, Lieutenant, and any other commander, we do  
8 not regulate private towing. And, if you are going to  
9 engage in this type of behavior, I think it's entirely  
10 inappropriate that you would -- you or any other  
11 commander would be researching and trying to impact  
12 private towing.

13 In the city of Detroit there's no -- we don't  
14 monitor that. So I don't know where this come from,  
15 you know, that you're trying to write law and going  
16 through the law books in terms of dealing with this  
17 issue. We haven't had no discussion on this particular  
18 area. We've been concentrating on -- which we've got  
19 our plate full in terms of dealing with public towing.

20 So I would hope that we would be  
21 concentrating on that particular issue, unless there's  
22 some criminality involved that you're trying to impact  
23 private towing. Now, I'm glad that Troy brought this  
24 to our attention.

25 And I guess you're asking for the towing

1 listing. I don't think it's no secret that we have a  
2 listing that we have shared that. So that would be  
3 available I think with our secretary that there's a  
4 listing that we publicized, I mean under the freedom  
5 act, you know, whatever that is. I don't think we're  
6 going to enter into that type of dialogue, because we  
7 have discussed this in the past. We want to make sure  
8 that the towers are privileged and that we want to be  
9 aboveboard in terms of how we approach this.

10 So I just think -- and I'm glad the Chief  
11 responded in the manner that he responded to and that  
12 Commissioner Vann, because we've been trying to address  
13 this in ad hoc committee. And we've been working with  
14 the department trying to flush out all those issues.  
15 So we are concerned, you know, about private towing,  
16 but that's another area that we don't really  
17 concentrate on unless it's something that we should be  
18 aware of.

19 LIEUTENANT PARISH: Commissioner Bell, let me  
20 just clarify. I'm not doing research to necessarily  
21 support the commander's decision. I'm doing research  
22 in order to address his concern. He did give the  
23 order. This was not anything approved prior to the  
24 order being given. My role in this was merely to  
25 research the appropriateness, and even if it was

1 appropriate the feasibility of the order by looking at  
2 other police agencies and examining Michigan law.

3 CHIEF CRAIG: Through the Chair.

4 VICE CHAIRPERSON DEWAEELSCHE: Chief.

5 CHIEF CRAIG: Are you aware that this order  
6 is still in effect by this commander?

7 LIEUTENANT PARISH: To my knowledge, the  
8 order is still in effect, Chief.

9 ASSISTANT CHIEF WHITE: I'll take care of it  
10 now, Chief.

11 CHIEF CRAIG: Assistant Chief, will you --

12 ASSISTANT CHIEF WHITE: I'll take care of it  
13 now.

14 CHIEF CRAIG: -- cease and desist  
15 immediately. Thank you.

16 VICE CHAIRPERSON DEWAEELSCHE: Thank you,  
17 Chief.

18 Any other questions?

19 Hearing none, thank you.

20 Do we have any other speakers, Mr. Brown?

21 MR. BROWN: No, that's it, Madam Chair.

22 VICE CHAIRPERSON DEWAEELSCHE: Okay. We're at  
23 the end of our oral communications. And I move -- or I  
24 request a motion to adjourn the meeting.

25 COMMISSIONER VANN: So moved.

1 VICE CHAIRPERSON DEWAELESCHE: It's been moved  
2 and supported.

3 All those in favor, aye?

4 COMMISSIONERS: Aye.

5 VICE CHAIRPERSON DEWAELESCHE: Thank you all  
6 for being here today. We appreciate your attendance.

7 (The meeting was concluded at 4:55 p.m.)
