4 COMMISSIONER BELL: Good afternoon.  
5 It's good to see all of your smiling faces on a  
6 Sunday afternoon here in the Public Safety  
7 Building.

8 I know you were enthused about coming  
9 and we appreciate your attendance, and as always  
10 I am your Chair, Willie Bell, District 4, the  
11 Board of Police Commissioners weekly meeting.

12 Looking to my left and to my right, if  
13 Commissioner Shelby would be so kind to open up  
14 with a prayer we can go forward.

15 (INVOCATION WAS GIVEN.)

16 COMMISSIONER BELL: Thank you, sir.  
17 Mr. Anthony, we do not have a quorum at this  
18 time, but I assume you're going to conduct a roll  
19 call.

20 SECRETARY ANTHONY: Thank you, sir.  
21 For the record, George Anthony, Secretary to the  
22 Board. Commissioner Lisa Carter is running late.

23 Commissioner Willie E. Burden?  
24 Commissioner Reginald Crawford?

25 COMMISSIONER CRAWFORD: Present.

1                   SECRETARY ANTHONY:   Commissioner Eva  
2                   Garza Dewaelsche is running -- well, she asked to  
3                   be excused.

4                   Commissioner Conrad Mallett is running  
5                   late.

6                   Commissioner Ricardo R. Moore?

7                   COMMISSIONER MOORE:   Present.

8                   SECRETARY ANTHONY:   Commissioner  
9                   Richard Shelby?

10                  (Commissioner Burton arrives.)

11                  COMMISSIONER SHELBY:   Present.

12                  SECRETARY ANTHONY:   Commissioner  
13                  Jessica Taylor has asked to be excused as well as  
14                  Commissioner Edgar Vann, both have asked to be  
15                  excused.   Donnell R. White also has asked to be  
16                  excused.

17                  Mr. Chair, it looks like Commissioner  
18                  Willie E. Burton is present.

19                  COMMISSIONER BELL:   Thank you  
20                  Mr. Burton for your attendance.

21                  COMMISSIONER BURTON:   Thank you,  
22                  Mr. Chair.

23                  SECRETARY ANTHONY:   You do not have a  
24                  quorum, Mr. Chair.

25                  COMMISSIONER BELL:   Okay, we're going

1 to continue business as a committee meeting of  
2 the whole at this time. And to my far left  
3 sitting in for Chief James E. Craig is Deputy  
4 Chief David LeValley.

5 DEPUTY CHIEF LeVALLEY: Thank you.

6 COMMISSIONER BELL: Thank you for your  
7 attendance. At this time do you want to  
8 introduce any of the staff?

9 DEPUTY CHIEF LeVALLEY: Yes. In the  
10 front row here is Captain Brian Mozey, Internal  
11 Controls and Lt. Kelly Fitzgerald. Lt. Octavious  
12 Miles at the back door also works Internal.

13 Lt. Elaine Miles, Sgt. Curtis-Perry.

14 COMMISSIONER BELL: Mr. Anthony, would  
15 you introduce the Board staff, please.

16 SECRETARY ANTHONY: You have Ms. Pamela  
17 Davis-Drake, our Chief Investigator, seated in  
18 front. Next to her is Ms. Linda Bernard who is  
19 our attorney to the Board.

20 Mr. Robert Brown is our office manager,  
21 Sgt. Alan Quinn is recording the proceedings in  
22 the back and Mr. Dale Rose from Hanson Court  
23 Reporting Service is taking the transcript. That  
24 completes the introductions, sir.

25 COMMISSIONER BELL: Thank you, sir. I

1 have -- my report I have two action items, so I'm  
2 going to postpone those until we have a quorum.  
3 And we can move on to Deputy Chief LeValley in  
4 terms of reporting out on behalf of the Chief and  
5 then we move right into Internal Affairs --  
6 Controls now, is that the terminology we use now?

7 DEPUTY CHIEF LeVALLEY: Yes, sir. I'll  
8 start out with a short crime report. Year to  
9 date, this is actually through the end of last  
10 week, April 12th.

11 Homicides were at 75, that is an  
12 increase over the last year and even with where  
13 we were in 2013. Rapes were at 107 and that is a  
14 40 percent reduction over last year.

15 Robberies, 671, that's a 20 percent  
16 reduction. Carjackings were at 99 which is a 27  
17 percent reduction. Aggravated assaults 2,199  
18 which is a 6 percent increase. Our non-fatal  
19 shootings which is a subset of the aggravated  
20 assaults 210 and that's an 11 percent. Our total  
21 violent offenses is down 3 percent.

22 Moving on to property, burglaries we're  
23 at 1,906 which is a 33 percent reduction from  
24 last year. Larcenies 3,769 which is a 5 percent  
25 reduction. Stolen vehicles 1,937 which is a 25

1 percent reduction.

2 The property offenses overall down 19  
3 percent. Total Part 1 offenses were at 10,664  
4 which is a 15 percent reduction from last year.

5 Unless there's any questions on that, I  
6 will turn it over --

7 COMMISSIONER MOORE: I did have one  
8 question through the Chair. You mentioned rapes,  
9 that number. Are those the numbers that are  
10 required to be reported to the federal government  
11 or are those the actual rapes?

12 I know there was a discrepancy earlier.

13 DEPUTY CHIEF LeVALLEY: Correct. About  
14 two weeks ago we changed -- it used to be listed  
15 on here as sexual assault, and so criminal sexual  
16 conduct 4th degree which would be touching  
17 without force is not part of the Uniform Crime  
18 Reporting Code, the report, so we report Category  
19 1, 2 and 3 to the FBI when you see the crime  
20 stats come out. So we changed our weekly  
21 reporting to match that.

22 Of course we also track -- we still  
23 track that number. We know internally what that  
24 number is and if there's anything that we need to  
25 do with regard to that, but as far as the report

1 that we issue for our official crime stats, it's  
2 CSC 1, 2 and 3.

3 COMMISSIONER MOORE: Thank you.

4 DEPUTY CHIEF LeVALLEY: So that's why  
5 we refer to it as rape now instead of sexual  
6 assault.

7 COMMISSIONER BELL: Any other questions  
8 or comment for the Deputy Chief?

9 DEPUTY CHIEF LeVALLEY: With that I'll  
10 turn it over to Captain Brian Mozey who is going  
11 to give the presentation for Internal Controls.

12 CAPT. MOZEY: Thank you, DC LeValley.  
13 Good afternoon, Board of Commissioners. I am  
14 Captain Brian Mozey and I'm the officer in charge  
15 of the Internal Controls Section for the Detroit  
16 Police Department.

17 Internal Controls for the police  
18 department is the entity that has oversight over  
19 the Internal Affairs Unit and the Force  
20 Investigations Unit and that's why we use the  
21 term Internal Controls as opposed to Internal  
22 Affairs.

23 With me today are my very competent  
24 officers in charge. To my right here is Lt.  
25 Kelly Fitzgerald, she is the officer in charge of



1 Internal Affairs and assisting me with the slide  
2 progression here is Lt. Octavious Miles and he is  
3 the officer in charge of Force Investigations.

4 It's my pleasure this afternoon to be  
5 able to give this presentation to the Board. The  
6 mission of Internal Controls is to ensure the  
7 public's trust and confidence in the Detroit  
8 Police Department by conducting thorough and  
9 impartial investigations into allegations of  
10 criminality, excessive uses of force and serious  
11 misconduct lodged against members of the  
12 department.

13 We will also investigate other City of  
14 Detroit employees on a case-by-case basis  
15 depending on the sensitivity of the incident and  
16 the need for confidentiality.

17 We do have a screening process for both  
18 Force Investigations and Internal Affairs to  
19 ensure the integrity of our unit. Anybody that's  
20 screened for a position at either unit that has  
21 any past internal affairs or a sustained force  
22 investigation contact would not be allowed to  
23 have a position at either Internal Affairs or  
24 Internal Controls.

25 Internal Affairs is responsible for

1 investigating and prosecuting criminal conduct on  
2 the part of the department members. Generally  
3 you start off as a criminal allegation. They  
4 don't always end up being sustained criminality.

5 Many times what starts off as a  
6 criminal allegation results in either an officer  
7 being exonerated, not sustained or perhaps we may  
8 find a case where an officer has violated a  
9 department procedure and we'll talk about that a  
10 little bit more in a minute.

11 We also investigate other City  
12 employees who abuse their position of public  
13 trust. As vigorously as we do investigate  
14 officers for criminal conduct, we will  
15 investigate citizens who make false criminal  
16 complaints against our officers, and it instills  
17 the trust of the police officers in the  
18 department in the Internal Affairs Unit, letting  
19 them know that if we can prove that a citizen  
20 makes a false allegation against them that we  
21 will bring charges to the Prosecutor's Office for  
22 that.

23 The sergeants and investigators in  
24 Internal Affairs are responsible for the  
25 preparation and adjudication of both the criminal

1 and administrative case.

2 So let's talk a little bit about Force  
3 Investigations. Force Investigations  
4 investigates improper, excessive or unjustified  
5 use of force by DPD members possibly including  
6 criminal uses of force. We prepare  
7 administratively and proceed through the  
8 adjudication of the administrative and criminal  
9 cases and we will seek to prosecute employees who  
10 abuse their positions with regards to use of  
11 force.

12 Force Investigations is responsible not  
13 for handling all uses of force within the city of  
14 Detroit, but only what we consider serious or  
15 critical uses of force also known as a Category  
16 1. And listed on the slide here, I'll just run  
17 through them, the types of cases that we do  
18 investigate are any incident where there is death  
19 resulting from the discharge of a member's  
20 firearm or a death after an altercation with a  
21 member.

22 We will investigate all discharges of  
23 firearms unless it's at a range or directed  
24 towards an animal. Any time a person is sprayed  
25 with a chemical agent who has already been

1 restrained is considered a Category 1 use of  
2 force.

3 Any use of force that results in broken  
4 bones or a loss of consciousness or injury  
5 requiring a citizen to be hospitalized, that does  
6 not include treatment at an emergency facility,  
7 but if the citizen is admitted to the hospital  
8 for the injury Force Investigations will  
9 investigate that incident.

10 We investigate all incidents where a  
11 department K-9 bites a citizen and any allegation  
12 of force that falls under the nature of a  
13 Category 1 as I just described.

14 As far as intake and taking the  
15 complaints for both Internal Affairs and Force  
16 Investigations we will take complaints in person.  
17 Our office is located in Suite 319 of Detroit  
18 Public Safety Headquarters.

19 Citizens can call a complaint in by  
20 telephone to our office or any police facility  
21 within the city of Detroit. Specifically the  
22 phone number for Force Investigations and  
23 Internal Affairs is 596-2447.

24 A citizen can send in a letter, they  
25 can notify us by e-mail at

1 internalaffairs@detroitmi.gov. We don't have an  
2 e-mail set up for Force Investigations, but if we  
3 did receive one with regard to a force incident  
4 through Internal Affairs we're in the same office  
5 and we would route it appropriately.

6 We'll take complaints anonymously, also  
7 through third party. Most of our investigations  
8 after conducting an initial investigation we  
9 consult with the Wayne County Prosecutor's Office  
10 to seek their advice in the direction that we  
11 investigate the case.

12 All of the investigations at Force and  
13 Internal Affairs are confidential and  
14 investigated with impartiality. Every member of  
15 Internal Affairs and Force Investigations has  
16 signed a confidentiality agreement agreeing not  
17 to disclose information regarding their cases.

18 The officers in charge of Force  
19 Investigations and Internal Affairs have a case  
20 management system. We use CaseTracks and another  
21 program and officers in charge meet with their  
22 investigating sergeants on a bi-weekly basis to  
23 ensure that the progress of their cases is  
24 proceeding forward.

25 (Commissioner Carter arrives.)

1 CAPTAIN MOZY: In both Force  
2 Investigations and Internal Affairs got standard  
3 operating procedures that we also abide by in  
4 addition to department policy. Generally just  
5 like cases with the Office of the Chief  
6 Investigator, we will usually come up with one of  
7 four findings, that being sustained, not  
8 sustained, unfounded or exonerated and depending  
9 on the findings that we have there's several  
10 things that we may push forward as far as  
11 corrective action.

12 At times training may be a more  
13 appropriate corrective action, maybe a risk  
14 management plan, and at times discipline is  
15 appropriate.

16 Lt. Fitzgerald, did you have anything  
17 you wanted to add? Be happy to answer any  
18 questions that you might have at this time.

19 COMMISSIONER BELL: Commissioners, any  
20 questions or comments?

21 COMMISSIONER MOORE: Through the Chair,  
22 we have police assistants now and we also have  
23 reserve officers. Are they held to that same  
24 standard or are they investigated by Internal  
25 Affairs for different force issues that might

1           come up?

2                    CAPT. MOZY: Any member that's  
3           employed by the police department is investigated  
4           by Internal Affairs or Force Investigations.

5                    DEPUTY CHIEF LeVALLEY: We recently  
6           addressed the issue as far as police assistants  
7           are concerned and they are being held to the same  
8           standards the department manual requires of  
9           police officers and they're all being issued  
10          uniforms, full equipment, so in essence they're  
11          just part-time police officers, but they're still  
12          sworn, have the same authorities that police  
13          officers have, so our code of conduct, we've  
14          already discussed that and agree that applies to  
15          them the same as it applies to other police  
16          officers.

17                   COMMISSIONER BELL: Commissioner  
18          Shelby?

19                   COMMISSIONER SHELBY: Through the  
20          Chair, are you getting timely notifications when  
21          an officer is violating policy but not within the  
22          city limits?

23                   Wasn't there an incident today where an  
24          officer discharged his firearm out in Oakland  
25          County?

1 CAPT. MOZY: Recently?

2 COMMISSIONER SHELBY: Yeah.

3 CAPT. MOZY: Macomb County there was  
4 an incident early this morning. We received a  
5 timely notification from Macomb County.

6 COMMISSIONER SHELBY: Would that be a  
7 joint investigation?

8 CAPT. MOZY: In a case where we have a  
9 situation that happens outside of our  
10 jurisdiction we assign it as what we call a  
11 monitor case and we keep in constant contact with  
12 the officer in charge from the outside agency.

13 When they close their portion of the  
14 criminal investigation we will then take on that  
15 case administratively and move forward with any  
16 corrective action that's required for violation  
17 of department policy.

18 COMMISSIONER BELL: I have one brief  
19 question. In reference to off-duty officers who  
20 are assigned out to -- I don't know the proper  
21 terminology for security or whatever, any major  
22 incident, how is that working out in terms of  
23 encounters with Internal Affairs, if not what is  
24 your take on --

25 CAPT. MOZY: Well, with reference to



1 secondary placement, to my knowledge I've been  
2 the officer in charge of Internal Controls since  
3 November, 2014, just under six months now. We  
4 have not had any incidents that were brought to  
5 the attention of Internal Affairs because of  
6 secondary employment.

7 COMMISSIONER BELL: Okay, good. Chief  
8 Investigator, do you have any concerns or  
9 questions?

10 CHIEF INV. DAVIS-DRAKE: No concerns,  
11 sir, but we do work very closely with Internal  
12 Controls, both with Force Investigations and  
13 Internal Affairs and we have the highest level of  
14 cooperation with them.

15 I did have a question though as to the  
16 number of cases if you would let the  
17 commissioners know perhaps.

18 CAPT. MOZEY: I'll let Lt. Miles  
19 address that and Lt. Fitzgerald address the case  
20 load for each of their respective units.

21 LT. MILES: Thank you. Lt. Octavious  
22 Miles, Force Investigations. As of this date  
23 we've had 10 Force Investigations cases.

24 For the year 2014 we had a total of 55  
25 that were investigated by our unit.

1 COMMISSIONER BELL: Thank you, sir.  
2 Any other questions in reference to the case  
3 load?

4 LR. FITZGERALD: I brought my  
5 year-to-date numbers for 2015. We have 54 open  
6 cases for Internal Affairs and so far year to  
7 date we've closed 32. I have 7 cases in the  
8 Wayne County Prosecutor's Office warrants pending  
9 and I have seven ongoing criminal cases in the  
10 Wayne County Prosecutor's Office.

11 Off the top of my head I believe we  
12 closed out last year with 158 cases in Internal  
13 Affairs year to date and I think out of those 158  
14 I believe we closed 122. That's off the top of  
15 my head, I only brought my 2015 numbers.

16 CAPT. MOZY: And the reason the  
17 closure rate is somewhat less than what we've  
18 assigned is cases carry over into the following  
19 year, so we only count the ones that we close  
20 during that calendar year.

21 Even now we have cases in 2015 that are  
22 still open from 2014 waiting on a decision from  
23 the prosecutor or going through the court  
24 process.

25 COMMISSIONER BELL: Commissioners, do

1 you have any questions or comments?

2 COMMISSIONER CRAWFORD: Pardon me, I  
3 just have one through the Chair. In terms of  
4 allegations by -- false allegation made by  
5 citizens against police officers, have you had  
6 any recent ones that you investigated or over  
7 last year or currently because I just think there  
8 needs to be some effort to go after those who  
9 make false allegations against officers.

10 CAPT. MOZY: Yeah, we have one right  
11 now that we're investigating. Most of the cases  
12 when they come back not sustained it's because we  
13 can't prove them one way or the other, so because  
14 we can't prove it and the other way we can't --  
15 it's difficult to prosecute the person who made  
16 the complaint.

17 We do have one right now that we are  
18 actively pursuing for a -- what we believe is a  
19 false allegation against an officer.

20 COMMISSIONER CRAWFORD: I just like to  
21 see that balance, both sides.

22 CAPT. MOZY: Well, it's a concern that  
23 officers have had and it's a legitimate concern  
24 that they have to answer for complaints that they  
25 believe are false, and it's our commitment that

1 we will pursue the investigation and follow the  
2 facts, but just in the case where it may not be  
3 feasible to bring prosecution against the  
4 officer, it's also the same way with the citizen  
5 at times, it's more difficult.

6 COMMISSIONER BELL: I have one  
7 follow-up question. In reference to -- it's been  
8 an age old issue somewhat in law enforcement in  
9 dealing with domestic violence. What's your take  
10 on that in terms of the officer's personal life  
11 in terms of domestic issues that surface in the  
12 past similar to -- in your investigations that  
13 falls more with younger officers, mid range  
14 officers or senior officers? Have you seen a  
15 pattern there?

16 CAPT. MOZY: No, I haven't. I would  
17 say probably the majority of our domestic assault  
18 cases fall probably between mid range towards  
19 senior officers as opposed to younger officers.

20 COMMISSIONER BELL: Are the senior  
21 officers more likely unmarried?

22 CAPT. MOZY: I couldn't answer that, I  
23 don't know.

24 LT. FITZGERALD: What we did do through  
25 is we reached out to the advocate of domestic

1 violence because in a criminal case of domestic  
2 violence the complainants, the victims, are given  
3 -- the advocates give them information on how to  
4 seek help, how to -- you know, shelters and what  
5 can be done, but because -- because a CHRISNET  
6 report goes directly to them, to domestic  
7 violence, and they're given information.

8 Well, for Internal Affairs that  
9 information is confidential, so they weren't  
10 getting -- to victims weren't getting that  
11 information.

12 So the wife or the husband of a police  
13 officer who was battered wasn't getting the same  
14 information that the citizens were getting, so we  
15 reached out to the Domestic Violence, we met with  
16 our unit and now we're in line with them and  
17 there's three specific advocates for domestic  
18 violence who get our CRISNET only out of all the  
19 people in their unit because it is confidential  
20 and then they will reach out and they will -- we  
21 have the same problem where they tend to not  
22 prosecute a lot of times just like the normal  
23 domestic violence victims -- I shouldn't say  
24 normal -- but we did reach out and it's something  
25 we started in our unit about six months ago.

1 (Chief Craig arrives.).

2 LT. FITZGERALD: And we have not had a  
3 domestic violence victim of a police officer  
4 prosecute the officer, but at least they have the  
5 -- they've been reaching out to them and they  
6 have that information so that they can seek help  
7 and shelters.

8 COMMISSIONER BELL: Thank you  
9 lieutenant, thank you. Any other questions,  
10 concerns from the captain?

11 COMMISSIONER SHELBY: Through the  
12 Chair, based on your stats, you're running a  
13 pretty effective and efficient unit. I have a  
14 soft spot for Internal Affairs, I was commanding  
15 officer there for a couple of years and it can be  
16 a difficult job.

17 CAPT. MOZEY: Thank you for that,  
18 commissioner.

19 COMMISSIONER BELL: Thank you, sir. We  
20 appreciate your reporting out and excellent in  
21 terms of information and asking some key  
22 questions and we appreciate that.

23 CAPT. MOZEY: You're very welcome and  
24 I'd also like to say that I also enjoy the  
25 cooperation that we have with Chief Investigator

1 Drake and look forward to working together in  
2 the future.

3 COMMISSIONER BELL: Thank you, sir.  
4 Let the record reflect that Commissioner  
5 Vice-Chair Lisa Carter joined us about 10 minutes  
6 ago and we now have a quorum, and it's good to  
7 see Chief Craig, so Chief we'll give you an  
8 opportunity, any remarks or comments you would  
9 like to make at this time.

10 CHIEF CRAIG: I don't have anything. I  
11 don't know if you addressed crime? Right, I'm  
12 open for any questions.

13 COMMISSIONER BELL: Any comments or  
14 questions for the Chief? If not, we can move --  
15 thank you for your attendance. If not, anytime  
16 you want to address --

17 CHIEF CRAIG: Thank you.

18 COMMISSIONER BELL: Commissioners, we  
19 now have a quorum. I would ask for the approval  
20 of agenda for this afternoon's meeting, April 16.

21 COMMISSIONER CRAWFORD: So moved.

22 COMMISSIONER MOORE: Second.

23 COMMISSIONER BELL: It's been properly  
24 moved and seconded. Ready for the question?  
25 Those in favor?

1 COMMISSIONERS: Aye.

2 COMMISSIONER BELL: Those opposed?

3 Motion carried. We also have the minutes from  
4 our Thursday, April 9 meeting in 2015. What is  
5 your pleasure in reference to a motion?

6 COMMISSIONER MOORE: So moved.

7 COMMISSIONER CRAWFORD: Second.

8 COMMISSIONER BELL: It's been properly  
9 moved and seconded. Are you ready for the  
10 question? Those in favor?

11 COMMISSIONERS: Aye.

12 COMMISSIONER BELL: Those opposed?

13 Motion carried. Thank you. Reporting out, I  
14 have two recommendations for the Board at this  
15 time.

16 First one would be in reference to our  
17 May 7 meeting. We talked about in the past  
18 meeting at East English Village Prep High School  
19 on the east side of Detroit and I met with the  
20 principal -- a second meeting with him this  
21 morning and we come up with the date of May 7  
22 and the time frame would be 2 PM.

23 We're looking at 125 to 150 young  
24 people coming in attendance to our meeting at  
25 about 2:20 so I would entertain a motion to have



1 our meeting on Thursday, May 7 at 2 PM at East  
2 English Village Prep High School on the east side  
3 of Detroit.

4 COMMISSIONER MOORE: So moved.

5 COMMISSIONER CRAWFORD: Second.

6 COMMISSIONER BELL: Property moved and  
7 seconded. Those in favor?

8 COMMISSIONERS: Aye.

9 COMMISSIONER BELL: Those opposed?  
10 Address, I don't have an address at this time,  
11 but I will make sure we have an address in the  
12 near future, but it's the area of Cadieux and  
13 East Warren, it's the old Finney High School, the  
14 school been open for a couple of years, two or  
15 three years.

16 We had a community meeting there when  
17 it first opened, so it's been -- and Wayne County  
18 Prosecutor, they have staff working in that  
19 particular school, Cease Fire and other  
20 organizations involved in DPD and others, so it's  
21 an excellent opportunity to bring a forum.

22 That we talk about young people, she  
23 was very enthused about us coming in that type of  
24 format, so it won't be our traditional format,  
25 but it will be an opportunity for young people to

1 interact with DPD and Board of Police  
2 Commissioners.

3 I think it will also be an opportunity  
4 for recruiting for young people graduating  
5 seniors and in fact she had misplaced placed a  
6 letter for a young man who graduated from  
7 Kettering high school, character reference and  
8 she found the letter and she shared it with me  
9 and Mr. Brown checked and it's still an active  
10 file, so hopefully as we recruit she apologized,  
11 she should have addressed that a couple of months  
12 ago, but nevertheless I will monitor that to see  
13 how the young man fared in reference to being  
14 recruited by DPD.

15 So she thought highly of him, she just  
16 misplaced the communication, she didn't get  
17 around to it.

18 The next matter would be our July 2  
19 meeting, July 2 on a Thursday. The Chair would  
20 recommend that we move that meeting up to June 30  
21 since we will be July 4 holiday weekend is coming  
22 into play, it's on a Friday, so we looked at the  
23 calendar and that's on a -- June 30 would be  
24 Tuesday, and so the chair would entertain -- we  
25 want to get out front in terms of pre-planning

1 for all concerned parties, especially those who  
2 want to take advantage of July 4, so the Chair  
3 would entertain a motion for June 30 and time  
4 frame would still be the same at 3 PM right here  
5 at the Public Safety Building.

6 COMMISSIONER CARTER: So moved.

7 COMMISSIONER MOORE: Second.

8 COMMISSIONER BELL: It's been properly  
9 moved and seconded. Ready for the question?  
10 Those in favor, aye?

11 COMMISSIONERS: Aye.

12 COMMISSIONER BELL: Those opposed?  
13 Motion carried. Thank you. Yes, sir.

14 COMMISSIONER MOORE: Could we just  
15 have that publicly noted so that everyone knows  
16 it's going on.

17 COMMISSIONER BELL: Yes, that's why  
18 we're addressing these dates at this time to give  
19 proper due process to all concerned parties. The  
20 in house would know now, but we will post it in  
21 the website and the communication and we had a  
22 great job in terms of changing meetings two weeks  
23 ago I think, we moved a meeting up to 2 o'clock,  
24 but yes, we would definitely make sure that we  
25 are -- we're required to make it duly noted.

1 Commissioner Burton?

2 COMMISSIONER BURTON: Through the  
3 Chair, you know, I think it's a great job as far  
4 as the commissioners going to the schools,  
5 reaching out and everything and talking about  
6 recruitment, but also I think if -- our meetings  
7 are normally at 3 o'clock.

8 I think it would be better if we  
9 continue to keep our meetings at 3 and bring it  
10 to the schools if it works with the school  
11 principal and staff. A lot of us is making  
12 accommodations to be here at 3 because a lot of  
13 us still have other jobs outside of the  
14 Commission.

15 COMMISSIONER BELL: I understand that.

16 COMMISSIONER BURTON: So we're already  
17 kind of like shifting our schedule around as it  
18 is.

19 COMMISSIONER BELL: I understand that,  
20 but I mentioned it initially, 3 o'clock would not  
21 fit within their scheduling of classes and  
22 activities, so therefore we're just moving it up  
23 one hour to accommodate the school.

24 It's not just about recruiting.

25 COMMISSIONER BURTON: Through the

1 Chair, would that be just for this particular  
2 meeting or that would be for other meetings as  
3 well?

4 COMMISSIONER BELL: Just for this  
5 particular meeting. Any changes we would -- the  
6 Board will make those changes. Oh, thank you.  
7 East English Village High School located 5020  
8 Cadieux and the zip code 48224. Technology is  
9 awesome, right at East Warren I guess just south  
10 of Harper Avenue, okay.

11 Okay, any committee reports? Any new  
12 business? Old business?

13 Announcements. Our next meeting will  
14 be on Thursday, April 23, 2015 at 3 PM at Public  
15 Safety Headquarters right here at 3 o'clock and  
16 our next community meeting will be held in the  
17 8th Precinct on May 14 at Westminster Church of  
18 Detroit, 17567 Hubbell, 48235. That meeting  
19 would be normally at 6:30 PM, so that's probably  
20 or your agenda items I far as that.

21 Any other announcements at this time?  
22 Chief, you probably wanted to announce the  
23 occasion scheduled for this Sunday.

24 CHIEF CRAIG: Yes. We should have a  
25 flyer. I don't know if Todd Bettison -- is Todd

1 Bettison here?

2 COMMISSIONER BELL: I think it's in the  
3 back. Here it is right here.

4 CHIEF CRAIG: That's starting Victims  
5 Awareness Week on Sunday.

6 Engaging communities, empowering  
7 victims starts on Sunday the 19th I want to say 3  
8 but it says 4 o'clock here, so it might be 4 over  
9 at the Northwest Activity Center 18100 Meyers on  
10 the west side of Detroit. It's an all-week  
11 celebration for empowerment and embracing of  
12 victims and so there are a number of activities  
13 planned, but the kickoff will be on that Sunday,  
14 so we encourage everyone to come out for that.

15 We'll get any flyers on it -- I think  
16 there's a poster.

17 COMMISSIONER BELL: Ms. Pannell always  
18 sent it out in her e-mail network announcing this  
19 particular date and time. Is that -- you said 3  
20 o'clock?

21 MS. PANSELL: 3 o'clock in the balloon  
22 release.

23 COMMISSIONER BELL: Oh, the program  
24 will start at 4 o'clock. I just wanted to make  
25 us aware because I know it's always been

1           circulated and we wanted to make sure that you  
2           hear who's perhaps not on her e-mail list and get  
3           the information, so it's a worthwhile cause.

4                        I think I saw in that information  
5           you're going to be reaching out to victims, moms,  
6           relatives.

7                        CHIEF CRAIG: Yeah, one of the things  
8           I'm hoping to accomplish, I've talked about this  
9           for some time now, is so that we never forget  
10          about the loved ones of homicide victims.

11                       Revisiting that and really trying to  
12          enhance our work in that area, just so that we  
13          never lose touch. Then also we're looking at  
14          putting together once again a cold case unit.  
15          That's one of the issues. We're losing staffing  
16          in Homicide. We go from case to case, and it's  
17          just enough for working on those cold cases, so  
18          we want to establish once again a cold case unit.

19                       COMMISSIONER BELL: That would be  
20          excellent because we had scheduled Ms. Brenda  
21          Hill and she did not show up, but that was one of  
22          their concerns, so I will let her know, hopefully  
23          she can be present on Sunday, if not her  
24          organization should be coming out because I think  
25          it's really meaningful, so many moms and dads and

1 you see it on TV quite often and they had some  
2 concern that their cases are filed away, but it's  
3 not the case.

4 I know it's not the case, but they need  
5 that reassurance and you have a support team. I  
6 saw Dr. Cheryl Moore's name there.

7 CHIEF CRAIG: Right.

8 COMMISSIONER BELL: She's a classmate  
9 of yours.

10 CHIEF CRAIG: Oh, yeah, she is.

11 COMMISSIONER BELL: Cass Tech -- I  
12 don't mention Cass Tech often, but --

13 CHIEF CRAIG: You caught me on that  
14 one.

15 COMMISSIONER BELL: Because she  
16 mentioned that you were part of the class there,  
17 Chief.

18 CHIEF CRAIG: She came out many years  
19 before me though.

20 COMMISSIONER BELL: Okay, okay.

21 I'll have the doctor check your blood  
22 pressure. Thank you, sir. She's a church member  
23 and one of our leading physicians in the city of  
24 Detroit and she's gone through that training, so  
25 she's going to offer that type of support.



1           Item 11 is oral communication from the  
2 audience. Please give you name and limit your  
3 comments to 2 minutes, we might allow 2.5 since  
4 we don't have a large crowd this evening -- this  
5 afternoon, so it's good to see a retired  
6 lieutenant come to the mic.

7           MR. MCALISTER: Thank you. My name is  
8 Roy McAlister, Jr., president of Greenwich Park  
9 Association and also first vice-chair of  
10 Detroit-Wayne County Black Caucus.

11           First of all, Chief, I'd like to  
12 commend you for that because that's what we used  
13 to do, but we used to do it with SOSAD as far as  
14 reaching out the victims, so I'd like to commend  
15 you for bringing that program initiative back.

16           Through the chair, may I address the  
17 Captain because there's two concerns that I have  
18 with his report.

19           COMMISSIONER BELL: You can speak to  
20 the Board.

21           MR. MCALISTER: Okay, first question --  
22 I'm pretty sure Commissioner Shelby will  
23 appreciate this -- does Internal Controls still  
24 investigate crimes against -- involving officials  
25 or is that the new investigative unit that has

1           been put in since the Charter has come in.

2                           And second of all I think I heard the  
3           captain say that the office is in this building  
4           and I know in years past we've always been --  
5           well, Internal Controls Bureau was separate from  
6           the headquarters of the police department, so  
7           those are two questions I have on that.

8                           And second of all, commissioner as well  
9           as all the other commissioners I'd just like to  
10          present the fact that Office of the Retired  
11          Detroit Police Members Association is having a  
12          dance this Friday. We're trying to build up our  
13          funds as far as there's a continued fight  
14          regarding the Grand Bargain and there's still  
15          some issues that affecting retirees and things of  
16          that nature, and that's Friday, April 17 which is  
17          tomorrow night at 2 at Northwest Activity Center.

18                          Also Commissioner Bell, as I stated I  
19          am the first vice-chair and we are working on  
20          some language as far as bringing this commission  
21          whole to present as well from that caucus, and  
22          our next meeting is on April 22 and we would like  
23          to have you there to do a presentation.

24                          That's going to be 6 o'clock at the  
25          Vote Center, UAW Vote Center, which is at Fenkell

1 and Livernois, so we'd like to have you there, so  
2 that is what I wanted to present.

3 Thank you so much.

4 COMMISSIONER BELL: Thank you, sir.

5 CHIEF CRAIG: One of the things -- and  
6 I don't know if -- did you talk about the  
7 Integrity Unit?

8 The Integrity Unit, not new, you  
9 probably -- during Commissioner Shelby's time and  
10 yours, you had a fairly robust -- they called it  
11 Intel Unit. It investigated allegations of  
12 criminal misconduct.

13 When I arrived here there were two  
14 officers embedded -- that had been embedded with  
15 the FBI's Corruption Unit. One was working there  
16 for 18 years which I thought didn't really make  
17 good sense given that the DPD kind of lost  
18 control of doing that kind of work.

19 Having come from a department that had  
20 a robust integrity Unit that did what we called  
21 integrity audits and I know that this department  
22 at one point did integrity audits.

23 So we've established that unit. We're  
24 still in the early phases of it. How many  
25 members do we have now, we have eight right now.

1 We have a couple of the officers that we're using  
2 are some that a relatively unknown to the general  
3 populous of the police department so that we can  
4 be more effective in conducting not only  
5 integrity audits, but undercover work.

6 So I'm optimistic we will continue our  
7 efforts with the FBI's Corruption Unit on an  
8 as-needed basis and we do still Internal Affairs  
9 primarily integrity unit -- the new Integrity  
10 Unit will investigate allegations of criminal  
11 misconduct on the part of other city officials.

12 MR. MCALISTER: Thank you, Chief.

13 CHIEF CRAIG: You're welcome.

14 CAPT. MOZY: Just to address the  
15 location of the office for you, Internal Controls  
16 is in this building, Suite 319 on the third  
17 floor.

18 However, there is another off-site  
19 location that we do utilize. But as far as  
20 citizens making a complaint, the public, if they  
21 would like to make a complaint Suite 39 here in  
22 Detroit Public Safety Headquarters is open.

23 COMMISSIONER BELL: Thank you, Captain  
24 and thank you, Lt. McAlister, in terms of your  
25 question and concerns and the Chief responded and

1 the Captain responded.

2 MR. WILBORN: Good afternoon, Board,  
3 Chief. My name is Bill Wilborn. I got a call  
4 from a friend of mine, he's a retired chief  
5 constable in English and just to show you that  
6 people around the world know what's going on in  
7 Detroit he asked me what is going on back here  
8 with all this killing everything -- of all the  
9 kids and everything, and what's happened with the  
10 United States overall with the police and  
11 civilians going against each other.

12 And we talked a long time about this  
13 and I tried to explain to him that in Detroit we  
14 have a pretty good system. I told him I worked  
15 with the police department a lot of times, I've  
16 been doing this for a lot of years and I know a  
17 lot of the things that goes on in the police  
18 department.

19 But he -- I guess when it gets overseas  
20 over there it's on TV they play it up, they  
21 really play it up. When I was in Japan, Vietnam  
22 or anyplace else anything about the riots when  
23 they come on TV -- oh, it explodes everything and  
24 they just keep bringing stuff up time and time  
25 again.

1                   And I tried to explain to him that as  
2                   far as domestic violence goes, it's not a lot you  
3                   can do about it because it's behind closed doors.  
4                   And I don't care how many police, you can have a  
5                   million police out there and they're not going to  
6                   stop it, it's going to happen. Some things  
7                   happen behind closed doors, it just can't be  
8                   stopped.

9                   And there's no way for the police to  
10                  detect it. If the neighbors see something, most  
11                  of them won't tell anything. I know in my  
12                  neighborhood I told everybody if you see  
13                  something, if you don't want to call the police,  
14                  call me, I'll call them, I'll go down to the  
15                  precinct and tell them. I do it all the time.

16                  But I just want to let you all know  
17                  that they do notice things around the world  
18                  what's going back in the states, especially when  
19                  it's something bad, derogatory because in England  
20                  they have a certain amount of respect for the  
21                  bobbies over there. When the bobbies speak to  
22                  you, you listen, and we kind of lost that respect  
23                  back here in the states. So I just want you all  
24                  to know that.

25                  I just tried to assure him that

1 everything is pretty good, especially here in the  
2 city of Detroit. That's the way I feel and  
3 Chief, we might not agree on everything, but we  
4 still got to work together and he's the Chief and  
5 he's doing a hell of a job as far as I'm  
6 concerned and I would support him 150 percent all  
7 the way. Thank you.

8 CHIEF CRAIG: Appreciate it.

9 COMMISSIONER BELL: Thank you, sir. Any  
10 other comments? Any other comments?

11 MS. SMITH: Good afternoon, Bernice  
12 Smith, political activist today. To the Chief  
13 and the Commissioners. Last month I believe I  
14 asked about an officer -- a woman officer in  
15 regards to her conduct and the gun situation that  
16 she was handling. I can't remember all of it,  
17 but it was in regards to her handling of the gun.

18 And I was told by the Chief White the  
19 response was that you cannot discharge her or put  
20 her on leave without pay. Last week we had an  
21 incident where the two police were being  
22 investigated from Narcotics Unit and I understand  
23 by reading that they are without pay themselves  
24 on a tether and they're confined to their homes.

25 Now, the Chief had organized -- created

1 a Major Violation Section which is good because  
2 we don't have to hear it being called Narcotics  
3 any more because everybody thinks everybody on  
4 the Narcotics Unit is crooked, but I'm glad that  
5 he has investigated along with the FBI and it  
6 won't make a black mark on us but my concern is  
7 if the policewoman that did what she did with the  
8 gun incident.

9 And I asked why she wasn't without pay,  
10 suspended without pay, and you told me that the  
11 union raised so much h--- about it and therefore  
12 you can't suspend any of the police without pay,  
13 but these police officers are suspended without  
14 pay.

15 So is there a difference between the  
16 charges that one police can continue to be  
17 suspended, but she has pay or he has the pay.  
18 That's what my question concern and you have two  
19 others that are without pay and they are on a  
20 tether.

21 COMMISSIONER BELL: Chief Craig.

22 CHIEF CRAIG: Through the Chair, since  
23 I've arrived here I've followed the rule that  
24 when an officer is charged with an allegation and  
25 they're allegation, and it's an allegation of



1 misconduct and it's an egregious allegation, we  
2 immediately move to suspend and suspend with pay  
3 because it's an allegation.

4 Now, in the event that the county  
5 prosecutor or, in this instance, U.S. Attorney  
6 indicts or charges an employee, then at that time  
7 is when I move to suspend without pay. That's  
8 been consistent throughout and based it on  
9 whether or not an employee has been charged.

10 Charging for me is the trigger that  
11 determines whether or not a person who is already  
12 suspended goes into an unpaid status because in  
13 the past what has happened -- and this predates  
14 me -- sometimes police officers would be  
15 suspended without pay for lengthy periods of time  
16 and then there's no charges, they're found not  
17 guilty in an administrative hearing and then the  
18 City ends up paying all that money back.

19 I'm not a big fan of certainly having  
20 employees off being paid on suspension for  
21 lengthy periods, but what is out of my control  
22 frankly is how long it takes to make a charging  
23 decision or how long it takes to complete certain  
24 investigations, but once we know that the  
25 investigation involved serious misconduct -- I'm

1 talking about an allegation of using a gun to  
2 allegedly rob drug dealers, that's very serious  
3 and so the thing is put them on suspended status  
4 until we can get to the truth.

5 And again the trigger in the instance  
6 was the indictment, but there's still additional  
7 officers there are still off on suspicion pending  
8 the completion of the criminal and then once,  
9 then we'll kick into an administrative  
10 investigation.

11 MS. SMITH: So in other words when the  
12 allegations are made you just put them on  
13 suspension with pay, is that what you're saying?

14 CHIEF CRAIG: Through the Chair, it  
15 depends on the allegation. Certain allegations  
16 that are made against police officers may warrant  
17 the employee being placed on restricted duty.  
18 Restricted duty may mean they work inside, desk  
19 work, their firearm is taken, can't perform the  
20 duties of a police officer, but they're still  
21 working just in a restricted duty capacity.

22 Again, but if the allegations -- as you  
23 all have probably heard last night a police  
24 officer was accused of in Macomb County off-duty  
25 firing his weapon into a residence.

1                   Macomb County made the arrest and as  
2                   soon as we were alerted we rolled out an Internal  
3                   Affairs team who immediately suspended the  
4                   employee. There's an anticipation that that  
5                   employee could be charged this afternoon. I  
6                   don't know if that's happened.

7                   CAPT. MOZY: He was charged.

8                   CHIEF CRAIG: Now that that employee  
9                   has been charged, then he will go into an  
10                  immediate suspension without pay. That would be  
11                  a prime example.

12                 MS. SMITH: Again, Chief Knox spoke  
13                 with me today and told me to send his best to  
14                 you; thinks you're doing a good job.

15                 CHIEF CRAIG: Thank you, appreciate it.

16                 MS. SMITH: I thought I'd let you know  
17                 about it. He had an operation on the hip, so  
18                 he's on disability.

19                 CHIEF CRAIG: Thank you.

20                 COMMISSIONER BELL: Any other questions  
21                 or comments from the Commissioners at this time.  
22                 If not, then any other comments from the  
23                 audience?

24                         Then we stand adjourned and the Chair  
25                         would entertain a motion to that effect.
