**BOPC Officers Reports(s):** After welcome and opening remarks **Chairman Bell** asked Chaplin Berry to provide the invocation. **Chairman Bell** asked the Commissioners in attendance to introduce themselves and add any comments to the record. Chair Bell acknowledge the return of Commissioners Lisa Carter and asked for continued support for her and her family. Other elected officials, representatives and VIP's were also asked to identify themselves or their organizational affiliations.

Chief of Police Report: Representing Chief James Craig was Assistant Chief Steven Dolunt. AC Dolunt introduced members of the Department and summarized DPD CompStat data for February 12, 2017. Dolunt discussed the Year to Date Comps for Homicide (19% increase, Non-Fatal Shootings 46% increase, Sexual Assault 5% increase, Carjacking -13% decrease). Dolunt also discussed a recent police shooting of a civilian which had occurred on February 14, 2017 in Precinct #10. Dolunt indicated the investigation into the shooting was being handled Homicide and the Michigan State Police. Commissioner Crawford challenged the need to release detail information about police contacts related to the victim. Dolunt and Media Director Woody indicated detailed information had not been released by the department, but that many of the media organization have the same access to third party informational sources that can put them in a position to have the above type of information. Commissioner Crawford followed up indicating that maybe we should have a conversation with the media about their reporting practices. Commissioner Moore inquired about DPD Live and their handling of the incident and if they could have been the source of some of the detailed information on the victims law enforcement contacts.

Presentation from the Department to the BOPC: Chief of Police Annual Report (2012 Detroit City Charter, Chapter 7.806.6). Captain Mark Bliss outlined the creation of a DPD Annual report Committee and indicated the Department's intent to have the document ready, shared with the Board and released late February-March, 2017.

Central City Integrated Health – Community Re-Entry Division. Mathew Brown and Norris Howard addressed the Board in connection with the Criminal Justice Liaison program, a program designed to divert, from jail or prison individuals who are diagnosed with Mental Illness, Substance Abuse and Intellectual or Developmental Disabilities. The speakers suggested their ability to work with DPD to help identify individual and transport these individuals to alternative facilities for treatment. DC Washington also addressed the Board indicating the Department has been in discussion with various types of programmatic efforts like Central City Integrated Health and was seeking ways to combine efforts with these type of institutions. DC Washington indicated the discussions were continuing.

## **BOPC Standing and Ad hoc Committee Reports:**

Recruitment. Commissioner Brooks and Dewaelsche provide a general update on police recruitment. Commissioner Brooks also discussed the difficulty in raising funds for the driver's license fees for Cody students given the recent announcement of Cody's school closing. Commissioner Dewaelsche indicated that an effort is currently underway to construct and update a calendar of public events and programs that will help enhance the recruitment efforts. The calendar will include information form one-stop agencies like SerMetro and well as churches and other community organizations.

Commissioner Moore inquired about the capacity of the new SUN Guard system. Commissioner Dewaelsche also directed the attention of the Board to a recent notice from the Board of Zoning Appeals (February 28, 2017 Agenda). On the agenda there are seven (7) medical marihuana appeals or request for zoning variances. Commissioner Dewaelsche encouraged Commissioner to attend the above hearings for more information. The Commissioner also applauded the Detroit Police Department in in efforts resulting in the closure of the Victory Inn on Michigan Avenue, AC Dolunt indicated the Inn was closed as part of a national chain for human trafficking.

Oral Communications: Eric Blount, expressed his concerns associated with Tuesday's fatal shooting and inquired into the

reasons why a less then lethal weapon like Tasers were not used. **AC White** responded to Mr. Blount indicating the Department has <u>not</u> authorized the use of Tasers. AC White also updated the Board on the deployment of Body Worn Cameras. He indicated Precinct #4, #7 and #11 have cameras. The rollout for the cameras are one precinct per month. The complete deployment is expected to end by the end of the year. **Kiana Suggs**, complained about the Department's lack of follow-up in a case wherein she is being stalked. Ms.Suggs recounted several encounters with the individual who she named as the stalker. Ms. Suggs was referred to AC Dolunt. **Bernice Smith** complained about an individual who has threaten her. Ms. Smith was referred to the Department, provided she was interested in seeking a criminal complaint on the individual. **Kathleen Pope**, account manager with Goch & Sons Towing discussed the efforts by Goch & Son's Towing's competitors to appear before the Board and provide negative information. Ms. Pope also provided materials to the Board for future consideration (Order Holding the Defendant, James Milton and Marvel Milton in contempt of Court; Show Cause Injunctive Order, 2/7/2017). **Katherine Richardson** representing Tenant Council of Angels for Seniors who complained about the treatment of seniors by the Department and inquired if training was available for Police in their treatment and contact with seniors. **Michelle George**, health nurse discussed medical protocols for product that can alleviate the impact of HIV contacts/exposure if administered immediately following contact with a HIV infected person. Ms. George was referred to Police medial.
