The proposed amendment involves the area known as Fort Wayne, generally bounded by the Detroit River, Rademacher Street (extended), West Jefferson Avenue, and Cavalry Street (extended). The current “future

general land use” designation for this area is PR (Regional Park). The proposed “future general land use” designation is INST (Institutional). The proposed map amendment is being requested to allow for a number of the existing historic buildings at Historic Fort Wayne to be adaptively used. (CG) 15 mins

- C. **6:30 PM Public Hearing** – to consider the request of the City of Detroit General Services Department (GSD) to amend Article XVII, District Map Nos. 41 and 50 of the 2019 Detroit City Code, Chapter 50, Zoning, by showing a PD (Planned Development District) zoning classification where a R1 (Single-Family Residential District) zoning classification currently shown in and around Historic Fort Wayne which includes the following addresses, 6301, 6309, 6315, and 6325 West Jefferson Avenue, and generally located on the south side of West Jefferson Avenue between South Cavalry Street (extended) and South Rademacher Street (extended).
