

What We Heard from You!



What We Heard from You!

You also shared that safe connections should be prioritized, including...

- **Bus stops** and areas where kids wait for and are dropped off by the school bus.
- Routes older adults tend to take and routes to access food and other community services (grocery stores, doctors appointments, etc.)
- **Outer Drive** and neighborhood park connections.

Priority Recommendations

<u>Traffic calming and new sidewalks</u> would make it easier and safer to walk and roll in Brightmoor.

Mobility Strategies



SPEED HUMPS AND CUSHIONS

Some streets already have speed humps installed, and more are needed. Recommendation: consider speed cushions in locations missing sidewalks, as they allow for wheelchair access if ADA accessible sidewalks are not available.



CURB EXTENSIONS

Curb extensions slow down turning vehicles at intersections and make crosswalks shorter and safer. Curb extensions can be constructed out of many materials, ranging from paint to vertical barriers like planters or posts.



NEW CROSSWALKS

High visibility striping, colorful crosswalks, and other crosswalk enhancements can installed to make new places for people walking to safely cross. In Brightmoor, new crossings near schools may be helpful to create safe routes to/from school (see next page).



SIDEWALK IMPROVEMENTS

Some key areas will need sidewalk improvements and new pedestrian paths. These correspond with the Designated Walking Routes mapped on the next page, and generally match up with the routes that leads to parks and schools.


Priority Recommendations

Slow Streets Feedback

- Can we see more examples of existing Slow Streets in Detroit
- Some concern expressed regarding Verne as an identified slow street
- How are the slow streets identified?
- What is the difference between New Slow Streets of Lyndon and Verne and the slow street network?
- Schools and parks should get priority for slow streets
- People don't follow the stop signs which makes it hard for slow streets
- 4 Speed humps per block is excessive
- The Fenkell vehicle Doughnuts is a reall problem and cars need to slow down on residential streets
- We need better public transit on Fenkell between Lahser and Telegraph the bus has issues
- Bridge not fixed on Fenkell causing major probelems and the County doesn't seem to be making any progress
- Lyndon north of Gompers makes sense for a slow street since it is near a school
- Shools and parks should be safe

Slow Streets Network

The Slow Streets Network is a network of local streets that helps Detroiters get around safety for short trip in their neighborhoods.


- The Slow Streets Network has potential to be updated as part of City of Detroit's upcoming Safe Streets for All (SS4A) Federal grant award. Updates are targeted to take place in 2025.
- The Slow Streets program currently is not funded City-wide. However, **priority areas** can be identified for improvements, so that these improvements can be made when funding opportunities arise.

Priority Recommendations:

Implement sidewalk and traffic calming measures to improve pedestrian safety.

- We should make sure the intersections next to schools are safe
- The Outer Drive Lahser intersection is an issue
- These intersections seem to make sense especially those near Gompers School

Priority Recommendations Fenkell

- Need more police cars monitoring streets
- Outerdrive and Lahser is an intersection that has some issues as well
- Police need to do a better job at monitoring stop signs
- Bus stops need shade and we need more street trees
- More public transit and direct links throught the neighborhood utilizing major streets
- ATV use in the neighborhood is a problem
- Need more lighting
- Provide more Stormwater bumpouts on local streets
- The weeds on Fenkell are overgrown and need to be maintained
- Maintenance on homes
