- 3. Ensure administration and enforcement of applicable building and zoning codes, and related federal, state, and local laws and ordinances to ensure that all structures within the City meet or exceed minimum standards.
- 4. Maintain the stability and safety of neighborhoods by enforcing the property maintenance code, Special Land Use Conditions and other related ordinances.
- 5. Promote peace and safety of the general public by enforcing zoning codes, conditions and other relevant regulations.
- 6. Reduce the number of vacant and dangerous structures within the City of Detroit.
- 7. Establish compliance of local businesses with federal, state and local laws, in order to promote a healthy local economy.

ADMINISTRATION ACTIVITY INFORMATION

ACTIVITY DESCRIPTION: ADMINISTRATION

The Administration Division is responsible for ensuring that each division in the department is properly carrying out the administration and enforcement of federal, state, and local laws as they relate to the activities of the department. Responsibilities include management of resources, future planning, program development, customer relations, accounting, strategic development and implementation of policy. (Plan Review and the Business License Center are now housed in separate activities.)

Key business processes:

- Execute operational functions and initiatives department-wide.
- Budget development and management.
- Human Resources issues.
- Information technology support, strategy and new programs.
- Procurement
- Processing contractor invoices.
- Providing pre-plan consultations.
- Preparation of responses to City Council and other City departments.
- Organizing participation in various Mayoral and City-wide initiatives.
- Reconciling travel receipts.
- Managing the schedule of various boards and commissions including the Construction Board of Appeals, the Board of Rules and the Wrecking Board.
- Customer services such as the Affidavit of Compliance and Responsibility.

MAJOR INITIATIVES FOR FY 2012-13:

In FY 2012-13, the Department will be conducting a comprehensive fee study which will use an activity-based costing approach to measure the congruency of our fees to the activity input and resource drivers. Upon completion of the fee study, the Department will make recommendations to the Board of Rules for a new fee schedule which will substantiate the parity of the fee charges to the services that we provide to our customers.

The Compuware business process re-engineering of the Department to foster improved customer service is still in progress. The second phase of the project is the implementation of on-line permit applications and inspection scheduling modules, which will enable customers to transact business with the City from remote locations or self-service kiosks within the department. This process will also improve our ability to timely track dangerous buildings as well as offering improved, efficient and cost-effective customer service.

BSEED has partnered with the Detroit Economic Growth Corporation to establish a Business Advocacy Team that facilitates a one-stop shop for providing information on business processes and expediting new business initiatives to developers, investors and other stakeholders considering Detroit as a viable location. This team streamlines the process for business licensing and liaising with other City agencies to attract new businesses thus eliminating the bureaucracy that has hindered many businesses from considering Detroit as an operations center place.

In FY 2013-14 and beyond, as part of our continuous process improvement initiative, we anticipate formulating a long-term strategic plan that will enable the Department to partner with other Detroit based businesses to generate synergy and maintain a lasting symbiotic relationship. We will develop one-three-and five-year business modules that will provide a road map for our strategic vision.

PLANNING FOR THE FUTURE FOR FY 2013-14, FY 2014-15 and BEYOND:

The Buildings and Safety Engineering Department will embark upon major initiatives to streamline processes and develop a "Q" Team for quick turnaround of processes that will encourage businesses to invest in Detroit. The first of these major initiatives will involve the realignment of the Plan Review process to provide a streamlined, timely and efficient plan review for major projects and expedited on-demand reviews.

BSEED will eliminate the Pre-sale Inspection and ACR processes and channel resources to core competencies, yielding desired results and providing for the optimum revenue generation.

Lastly, the Department has taken the initiative to merge certain divisions and functions in an effort to provide timely and efficient services, reduce cost and eliminate redundancies. The Department will concentrate on its mission as it relates to its core functions.

PLANNING AND PERMITTING ACTIVITY INFORMATION

ACTIVITY DESCRIPTION: PLANNING AND PERMITTING SERVICES

The **Licenses and Permits Division** is responsible for issuance of trade licenses and permits for construction activities, management of the insurance escrow and utility escrow funds, and acceptance of payment for department services. This division is responsible for all accounts receivable functions for the department, comprising billing, collection and accounting for funds associated with department operations.

The **Zoning Administration Division** was recently reorganized to include Plan Review and Special Land Use hearings. The Plan Review Section is responsible for the initial review of all new permit applications to determine conformance with the Zoning Ordinance and to determine the types of reviews necessary for permitting by the Plan Review Division. This section also participates in Site Plan Reviews and conduct compatibility studies. The Special Land Use Section processes all special land use cases and site plan reviews. As the designated Zoning Administrator for the City of Detroit, the Special Land Use staff is responsible for zoning interpretations, zoning verifications, conducting hearings for conditional uses and providing testimony at Board of Zoning Appeals Hearings. The Zoning Division staff works interdepartmentally on ordinance revisions related to development. The new enforcement section will enforce the conditions of BSEED and BZA land use grants as well as identify uses illegally established without the benefit of a permit.

Key business processes:

- Process zoning variances and conduct special land use hearings
- Site plan review for special land uses and large scale development
- Provide zoning assistance and zoning verification letters
- Review and make recommendations on liquor license petitions
- Enforcement of zoning ordinances through inspections and issuance of correction orders/violations
- Sign off on permit applications after plan review

The **Plan Review Division** ensures that site and construction plans comply with all applicable ordinances and codes. The professional and technical staff reviews the permit applications and plans for the proposed projects to verify compliance with the Michigan Building Code, Michigan Residential Code, Michigan Rehabilitation Code, Michigan Electrical Code, Michigan Mechanical Code, Michigan Plumbing Code, International Fuel Gas Code, City Elevator Code and Boiler Code. The division also coordinates the plan reviews by various other City departments and divisions such as Health, Water & Sewerage, City Engineering, Traffic Engineering, Planning & Development, City Planning Commission and Fire Marshal for their reviews and approvals. The division reviews and approves building permits, sign permits, awning permits, canopy permits, home owner electrical, home owner mechanical, and home owner plumbing permits.

MAJOR INITIATIVES FOR FY 2012-13:

- Re write sign ordinance in order to create one comprehensive document that accommodates current media technology and industry standards.
- Streamline the site plan review process and improve communication between City departments and developers in order to expedite plan review.
- Transition plan review functions to the new Compuware system.
- Modernize the plan room to create an organized archive of construction drawings that are easily accessible by departmental staff.
- Further implementation of the one-stop shop for plan review.

PLANNING FOR THE FUTURE FOR FY 2013-14, FY 2014-15 and BEYOND:

Collection of accounts receivables continues to be a challenge and major priority of the department. BSEED is devoting additional resources to clean up the database of the receivables to determine the true balance and the aging of all outstanding accounts. A team of revenue collectors then will be recruited for in-house collection, along with the services of outside collection agencies for other hard-to-collect accounts.

BUSINESS LICENSE CENTER ACTIVITY INFORMATION

ACTIVITY DESCRIPTION: BUSINESS LICENSE CENTER

The **Business License Center** establishes compliance of Detroit business activities with federal, state and local laws in order to promote a healthy and viable local economy. The city requires 84 types of businesses to be licensed and ties BSEED, Health, Fire and Police inspections to new and renewal license approvals. Licensure fees range from \$46 to \$1,250.

The **Show Cause Hearing** is also housed in this activity and responsible for investigating complaints and denying, suspending or revoking business licenses or land use permits based upon zoning or licensing violations set forth in the City Code. Upon request, the licensee is entitled to a hearing at the department to show cause for why a license or land use permit should not be denied, revoked or suspended.

Key business processes:

- Customer information
- Application processing
- Notifications of applications to inspection agents
- License mailing
- Field investigations
- License revocation actions

MAJOR INITIATIVES FOR FY 2012-13:

Continue to show a strong presence at stadiums and all other major event venues due to excessive and blatant illegal activity previously conducted in nearby parking/vacant lots. BLC investigators will continue to work with Homeland Security to identify counterfeit merchandise being sold by vendors. The BLC will use the show cause hearing process against businesses severely out of compliance or will pose an immediate threat to the welfare of the general public. The BLC is in the process of revoking taxicab bond plates due to nonuse, which will then be sold to applicants wishing to be new business operators.

PLANNING FOR THE FUTURE FOR FY 2013-14, FY 2014-15 and BEYOND:

The Business License Center had recent success has with gaining in sustaining a substantial increase in compliance amongst gas stations, used auto dealers, and junk yard/scrap iron metal processing operations. The BLC intends to focus efforts toward hotel and dry cleaners going forward. In lieu of the valet ordinance being recently adopted, the BLC will ensure that businesses offering a valet service are obtaining requisite permits and licenses and operating compliancy. Due to recent concerns regarding illegal parking activity/ownership, the BLC is requiring parking lot owners to provide up-to-date parking lot information to ensure accurate licensing.

CONSTRUCTON INSPECTION SERVICES ACTIVITY INFORMATION

ACTIVITY DESCRIPTION: INSPECTION AND CODE ENFORCEMENT SERVICES

Construction Inspection Services protects and promotes public health, safety and welfare in new and existing buildings by verifying compliance with applicable codes and taking appropriate enforcement action when necessary through misdemeanor violations adjudicated at the 36th District Court.

The <u>Buildings Division</u> performs inspections of construction activities to ensure that structures meet approved plans and comply with building codes and standards. The Buildings division also inspects wrecking, signs and awnings, processes insurance escrow accounts for fire repair and complaints related to construction activities, and issues certificates of occupancy.

The **Mechanical/Electrical Division** consists of four sections:

The **Mechanical Section** conducts plan review and inspections of mechanical systems including heating/cooling appliances; large refrigeration installations related to air conditioning, process or storage purposes; gas piping; and fire suppression systems for compliance with applicable codes. The Examiner's Office within this section conducts examinations of applicants for steam and refrigeration occupational licenses. The Mechanical Section is responsible for all testing of business and occupational licenses relating to the operation of mechanical equipment.

The **Electrical Section** reviews plans, inspects new construction, alterations, and renovations of electrical, signaling and fire alarm systems for compliance with the National Electric Code. This section is also responsible for the licensing of electrical contractors, journey workers, master electricians, fire alarm technicians and sign specialists. The Electrical Section manages the Board of Electrical Examiners, an appointed body created by ordinance to oversee all aspects of electrical licensing within the City of Detroit.

The **Boiler Section** conducts inspections of all large capacity boilers in the City of Detroit and monitors compliance with "post-of-duty" requirements to ensure safe boiler operation.

The **Elevator Section** conducts inspections of all elevators, escalators, moving walks and chair lift installations for Code compliance. This section also administers examinations and licensing for all elevator journey workers active within the City of Detroit.

The **Court Enforcement Section** is responsible for ensuring compliance of mechanical/electrical violations and abatement of consumer fraud through court activities.

The **Plumbing Section** reviews plans and inspects new construction, alterations, and renovations of plumbing systems such that these systems comply with code requirements at the time of inspection. Issuance of plumbing permits and registration of plumbing contractors and water treatment operators is another function of this section in conjunction with our License and Permit Division. Plumbing cross-connection inspections are performed to identify potable water systems that are in need of protection from contaminates. Plumbing cross-connection inspections are required by the State of Michigan Safe Drinking Water Act.

PLANNING FOR THE FUTURE FOR FY 2013-14, FY 2014-15 and BEYOND:

In FY 2013-14, the **Housing/Plumbing Division** will consist only of Plumbing as the Housing section will be merged into the Property Maintenance Inspection division. The pre-sale inspections of one-and two-family dwellings for housing ordinance compliance will be discontinued to enable the department to focus on corecompetencies.

To streamline processes while eliminating redundancy in supervision and layers of reporting, the Construction Services division will be spearheaded by one "Super Chief" who will oversee the operation of Mechanical, Electrical, Plumbing and Buildings units. In addition, each unit will have a supervisor which creates parity across functional lines relative to the ratio of supervisors to employees.

In FY 2014-15 and beyond, the Construction Inspection division will be re-evaluated against established benchmarks to determine if additional operational changes would be necessary in meeting industry standards.

PROPERTY MAINTENANCE INSPECTIONS

The **Property Maintenance Division** provides periodic inspections of all existing rental residential and commercial structures to encourage property maintenance and the stabilization of neighborhoods by fighting blight. Property owners that are not in compliance with the current Property Maintenance and Zoning Codes are subject to tickets that may result in litigation and possible fines levied by the Department of Administrative Hearings.

The Lead Program is a section of the **Property Maintenance Division** that has taken over the responsibility of Elevated Blood Lead Level review in compliance with the Lead ordinance and Michigan Department of Community Health standards.

Key business processes:

- Inspection reporting
- Violations
- Enforcement at 36th District Court and the Department of Administrative Hearings
- Responding to Complaints

MAJOR INITIATIVES FOR FY 2012-13:

- We are in the process of revising the pre-sale housing ordinance used as the basis for performing housing inspections for single and two family dwellings. The revised ordinance will assist customers in their transaction of business with our housing division by reducing bureaucratic entanglements.
- The revised pre-sale ordinance will better serve customer requirements without adding a financial burden to them. It will also streamline processes within the division so we can better utilize staff in pursuing compliance.
- A draft of the new pre-sale ordinance is currently being reviewed by our Law Department to standardize the
 process and eliminate redundancy. This activity will be performed in conjunction with the property
 maintenance inspection.

PLANNING FOR THE FUTURE FOR FY 2013-14, FY 2014-15 and BEYOND:

- Digitizing of records along with the department's new record retention schedule will alleviate overcrowding of floor space.
- The Detroit Water and Sewage Department (DWSD) has requested that the plumbing division oversee the residential downspout disconnect program. DWSD will provide the revenue to BSEED for inspecting and managing this program. Discussion with the Director is required to determine appropriate cost for services. This program is scheduled to start in fiscal year 2013-14.

- Office space consolidation will provide better "business flow" for the department and our customers to enhance customer service Reduced rental costs will be redirected to enhance customer service.
- BSEED WILL expand the Operation Code Compliance Initiative by collaborating with other enforcement agencies and partnering with the Detroit Police Department to shut down operations that fail to comply with blight elimination requirements.

DANGEROUS BUILDINGS AND DEMOLITION PROGRAM ACTIVITY INFORMATION

ACTIVITY DESCRIPTION: DANGEROUS BUILDINGS AND DEMOLITION ACTIVITY

The Dangerous Buildings ordinance requires the City to take certain actions to remedy dangerous structures. State licensed building inspectors investigate and identify dangerous conditions and recommend abatement actions. Administrative staff sends out appropriate notifications and schedules hearings at the department and City Council. The department uses mostly federal funds to pay for the demolition of dangerous structures.

Key business processes:

- Contractor award and evaluation
- Assigning work to contractors
- Monitoring all phases of demolition process
- Payment of contractors
- Monitoring contracts to ensure no overextension
- Requests for grant funds
- Tracking of property ownership
- Notification to owners
- Filing documents of record
- Intake and response to resident dangerous building complaints
- Reconciliation of program grant funding expenditures and voucher
- Fire escrow reconciliation and disbursement
- Filing of Lis Pendens to recover demolition costs from property owners

MAJOR INITIATIVES FOR FY 2012-13:

Achieve the Bing 10,000 initiative and utilize all available federal and state resources in the elimination of blight.

PLANNING FOR THE FUTURE FOR FY 2013-14, FY 2014-15 and BEYOND:

Merge the dangerous buildings and demolition activities under the Property Maintenance enforcement activity to achieve greater efficiencies in the elimination of blight.

ENVIRONMENTAL AFFAIRS ACTIVITY INFORMATION

ACTIVITY DESCRIPTION: ENVIRONMENTAL AFFAIRS ACTIVITY

Environmental Affairs (EA) interacts with federal, state and local agencies to improve and protect the City's water, air, and land resources. EA's technical personnel are assigned to either Environmental Assessment and Response (Brownfields) or Environmental Management Systems/Emergency Response.

EA develops and implements programs that support sustainable development initiatives focusing on Brownfields Redevelopment and obtain funding for clean up of contaminated sites EA fosters legislative and regulatory initiatives at the state and federal levels to assist the City and other similarly situated municipalities in meeting their environmental objectives through partnerships, programs and policies, and funding. EA also assists city departments with environmental compliance requirements and objectives by providing technical assistance and developing procedures to achieve compliance.

The City Charter requires EA to coordinate environmental protection policies in the City of Detroit. EA staff provide skills to maintain citywide compliance with applicable laws and regulations. Staff also give guidance on the most effective and sustainable use of the natural resources available to the City.

GOALS:

- 1. Develop and implement programs that support sustainable redevelopment initiatives focusing on Brownfield Redevelopment.
- 2. Obtain funding for the cleanup of contaminated sites.
- 3. Foster legislative and regulatory initiatives at the state and federal levels that will assist the City and other similarly situated municipalities in meeting their environmental objectives through partnerships, programs, policies, and funding.
- 4. Assist City departments with environmental compliance requirements and objectives by procuring technical assistance and developing of policies and procedures.
- 5. Develop and implement enforcement strategies that will yield a cleaner environment and facilitate economic development.

MAJOR INITIATIVES FOR FY 2012-13:

- Completed the move from the First National Building to allow for the complete integration of Environmental Affairs within BSEED
- Worked with the Part 213 Implementation Stakeholders Workgroup to ensure that the City has influence in the development of policies, procedures, and audit forms to be used in the regulation of leaking underground storage tanks, primarily at current and former gas stations.
- All staff received refresher training in Brownfield Management and Remediation in order to stay current with best practices in the field.
- The unit was designated by the Mayor as the Responsible Entity for the City of Detroit for the purposes of conducting environmental reviews and assuming environmental responsibilities for HUD projects as outlined in 24 CFR Part 58.
- Implemented a fee schedule for the Environmental Right-of-Entry process to offset costs incurred to process and issue Right-of-Entry permits. Improved efficiency by reducing the amount of extensions requested due to work not being completed during the applicant's requested timeframe and reducing the number of Right-of-Entry permits that are requested, issued and subsequently not used.

PLANNING FOR THE FUTURE FOR FY 2013-14, FY 2014-15 and BEYOND:

- Environmental Affairs will actively pursue grant funds and other sources of revenue in order to become more self-sufficient.
- Environmental Affairs will become more active in sustainability and climate change issues through participation in the Detroit Climate Action Collaborative and the Carbon Disclosure Project's CDP Cities.
- Environmental Affairs will take a lead role in dealing with storm water and floodplain management issues within the City of Detroit.
- Environmental Affairs will take a lead role in urban agriculture issues and in the approval process for urban farms
- Environmental Affairs will focus on implementation of flood plain policy as it relates to control measures and construction within established floodplain areas.
