Historic District Commission (HDC) Report: Violation Cases

As of December 2, 2021

1. DEFINITIONS

- Staff Review: The status and extent of the case has not yet been determined.
- Open Violation Cases:
 - i. Referred to BSEED: Cases that are verified work without approval, currently in Buildings, Safety Engineering and Environmental Department (BSEED) enforcement activities.
 - **ii. HDC Staff Letter:** Cases that are verified work without approval and under notification by HDC Staff.
 - iii. Under HDC Review: Cases that are scheduled for an HDC Hearing.
 - iv. **HDC Application Process:** Cases that are under the HDC application process.
 - v. **Denial:** Cases determined to be in violation by the HDC and remain in violation.
 - vi. **COA (Conditions Pending):** Open cases with an issued COA and unmet conditions to close the violation. As a new report feature, some COAs may not yet be shown.
 - vii. **Unresolved:** Cases where work was completed at least 5 years ago and/or access to records of approval are not yet resolved.

• Closed Violation Cases:

- i. COA: Closed violation; received a Certificate of Appropriateness by the HDC.
- ii. NTP: Closed violation; received a Notice to Proceed by the HDC.
- iii. Ordinary Maintenance: Closed violation; considered ordinary maintenance.
- iv. Damage Noted: Closed violation; damage recorded and deemed irreversible.
- Backlog Cases: Known cases before August 2020: 45 cases to date.
- Total Cases: Total of all known violation cases: 252 cases to date.

2. VIOLATIONS SUMMARY

- Violation activities were generally lighter than previous months.
- The clay tile roof removal at 1725 W Boston sparked community concern. Upon receiving notice HDC staff immediately referred to BSEED's Construction Inspection Division for enforcement the following day, whereupon the owners received a stop-work order.
- The fire at 1321 Orleans (Lafayette Towers) had recent window replacement activity, which raised resident concerns about the September fire damage that remains on the exterior portion of floors 9 and 10. HDC has notified BSEED to commence an inspection.
- HDC staff mailed 17 Notices of Work Observed this month to property owners.
