





Security

- Merit Park will be staffed by three security guards during opening hours
- Site plan includes a fenced perimeter
- 24 hour surveillance in operational plan


Construction Vehicle Route

 Additional signage will be added to encourage truck drivers to use Grand River, Livernois, and the I-96 Service Drive for site route

Limited Parking for Residents

- Lease with The Order of the Fisherman, in perpetuity, for exclusive use of Merit Park lot Monday through Friday from 7 am- 5 pm
- 20 year lease with Straight Gate International Church for overflow parking
- Grand River bump out and median approved by MDOT to ease pedestrian traffic from Merit Park entrance to overflow parking entrance
