- B. **Budget Committee Memorandum.**

**Budget Committee Chairperson Eva Garza Dewaelsche** provided three motions from the committee meeting held November 19, 2024.

I move the adoption of the Budget Committee’s recommendation, “to adjust the BOPC Budget Draft Timeline to submit the BOPC 2025-2026 fiscal year Budget Draft on Friday, December 6th, pending the Board’s approval on Thursday, December 5th.”

I move the adoption of the Budget Committee’s recommendation, “to increase the OCI Senior Investigators and Supervising Investigators pay to be in line with market standards, to a salary range of \$80,000 as a minimum and \$92,000 as a maximum for the Seniors and a salary range of \$92,000 as a minimum and \$107,000 as a maximum for the Supervisors. These increases would be effective as of July 1st, 2024.”

I move the adoption of the Budget Committee’s recommendation, “to approve the hiring of TASS workers to augment the BOPC Office and Chief Investigator staff pending the Union’s final acceptance of the Memorandum of Understanding.” The motions passed.

- C. **Commissioner Dewaelsche** motioned, “that the Board of Police Commissioner go into Closed Session pursuant to Section 8(a) of the Open Meeting Act, MCL 15.268(a) the request of Ellen Counts, Investigator assigned to the Office of the Chief Investigator to consider her Evaluation Appeal.” (Time 4:06 p.m.). The motion passed.
