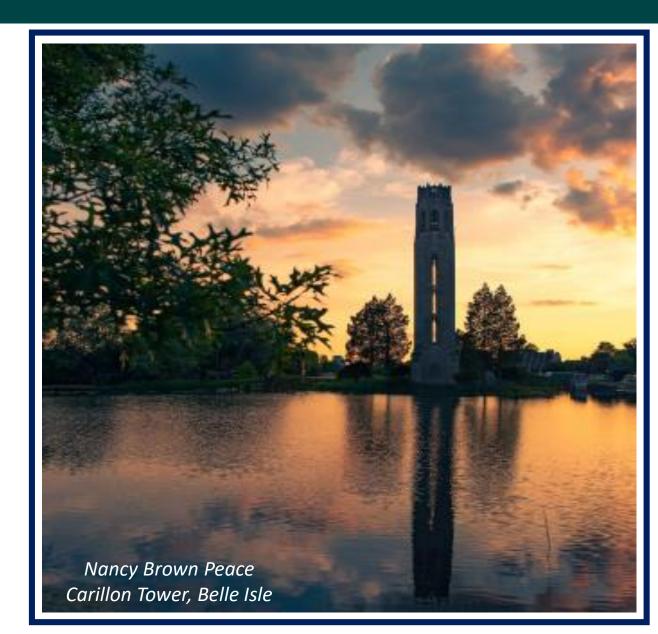

Fiscal Year 2025-26 Budget Cycle

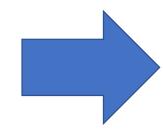
Budget Timeline:

- Week of January 27th Reviewed draft of BOPC Budget is re-submitted to the Budget Department
- Week of February 24th City Budgets are finalized
- Week of March 7th Mayor presents the collective Detroit Budget City Council
- Mid-March Department Hearings with City Council
