Pursuant to Section 5(1) of the Michigan Local Historic District Act, as amended, being MCL 399.205 (1) and Sections 21-2-73/21-2-78 of the 2019 Detroit City Code; the DHDC hereby issues a Certificate of Appropriateness (“COA”) for the following work, effective on March 15, 2022, as it meets the Secretary of Interior’s Standards for Rehabilitation and the district’s Elements of Design:

The proposed 22’ x 20’ detached garage with new concrete footing/floor slab.

The Certificate of Appropriateness is issued with the following conditions:

- *Applicant shall replace the vinyl siding, vinyl soffits, aluminum trim and vinyl window with a historically compatible material approvable by staff.*
- *Applicant shall exchange the color white for windows, siding, soffits, trim and gutter with off-white or a color found in Color System D or E. This color choice shall be reviewed by staff.*

RE: 1925 Chicago

To whom it may concern,

Italy American Construction is applying for a permit to build a garage at 1925 Chicago in the Boston Edison Historic District. There is currently no garage on the property, so we plan to remove the broken concrete and old ratwalls, install new concrete and ratwalls, then build a 22' x 20' garage. Since the house already has vinyl siding, we are proposing to use vinyl siding on the garage. We have provided pictures showing the vinyl siding on the home. The siding we plan on using will match what is on the home in color and style.

SCOPE OF WORK:

- Remove broken concrete and old ratwalls.
- Install new concrete for driveway apron area.
- Install new 22' x 20' concrete garage floor with 8" x 24" foundation beneath. Install re-rod in the ratwalls.
- Install two courses of 6" x 16" x 8" block around perimeter of garage floor. Leave block 5" from front wall.
- Build new 22' x 20' detached wood frame garage. 2'-0" front overhang. Hip roof style with 6 / 12 pitch.
- Install new 16' x 8' short panel O.H. door – White.
- Install ½ H.P. garage door opener with (2) remotes.
- Install 36" x 80" pre-hung 6 panel steel service door with lockset and deadbolt.
- Install one 36" x 36" vinyl slider window single pane – White.
