prewalk (complete) areas to determine scope, this includes which trees are recommended for removal to ground (DTE does not remove stumps). Signatures collected for approval for full tree removal. Tree Triming commences (this can take several months depending on tree coverage in area). Branches that are less than 4" diameter will be removed, branches that are greater tan 4" will be cut into manageable log sizes and neatly stacked on property. Attached tree count and tree types from prewalk.


