We started communicating with HDC (Historic District Committee) to begin repairs and improvements, however we have experienced many obstacles from members of the community. A petition went around the neighborhood with false information of the project from people who never spoke to us before spreading false narratives and knew of my father (Charles Dixon) who lived and had ownership of the house since 2009. We received the home as our primary residence, where we can safely raise our children. Our improvements will serve as a way for us to live in a safe (mold free and lead free) home suitable for our family size while also maintaining the beauty of the District. We are not renovating the home to rent out to anyone else for any purpose. When the inspectors comes out because of a complaint they say that basically most of my neighbors are making the complaints against our efforts. I feel that its because of the false picture that was painted about our efforts to make the house safe and a home for my family to live, learn, and grow within the community for the next 30 plus years. I grew up on Calvert and 12th which is around the corner. Where I came from this is a dream come true for me. When I was a little boy I always said that I was going to live in this area someday. I could have gotten a house anywhere but I bleed Detroit so living anywhere wouldn't be the same for me and my family. We are only seeking to share with you the truth about our intentions with the property and the renovations being completed. Our **sole** purpose is to renovate our new home into a safe home for ourselves and our children without being stopped by other community members due to false information being shared. I understand that some people like things to stay the same but most of the time change is necessary to go further. You wouldn't ask the doctor to do your hip replacement the pieces from your old hip.
