Contract Conditions:

It is understood that by signing this contract that anything not contained specifically herein is excluded and will remain the responsibility of the homeowner to complete. No extra work or changes from this signed contract will be provided unless stated in change order and signed by both parties. Note: After pool has been laid out and staked, any additional changes size or location will require a \$2,000 re-staking fee.

Any Engineering & City Permit Fee's are not included in proposal.

Antonelli Pools shall maintain a current General Liability Policy for the duration of the project. River Pools Structure & Surface warranties Included. Estimate may require additional costs due to inflation/material shortages assessed every 6 months.
