Opening Remarks

Mr. Rising stated that Public Act 182 (PA 182) requires the City to hold two revenue estimating conferences annually (one in February and another in September) to set the City's official economic and revenue forecasts. The principals of the conference must be the Chief Financial Officer for the City of Detroit (Jay Rising); the State Treasurer or his or her designee (Eric Bussis); and a third person affiliated with a public entity with experience in economic forecasting and revenue projection (George Fulton).

He noted the revenue estimates approved today will set the revenues the City uses to begin developing the FY 2023 budget and FY 2023–FY 2026 Four Year–Financial Plan.

Old Business

Approval of Proposed Minutes from the February 2021 Revenue Estimating Conference

Motion made to approve the proposed minutes of the February 2021 Revenue Estimating Conference as presented. Motion moved and supported, the Conference approved the minutes of the February 2021 Revenue Estimating Conference as presented.

2. Mr. Rising, Mr. Bussis, and Mr. Fulton provided additional remarks on the local, state, and national context for the economic and revenue forecast.
3. Mr. Watson and Mr. Cunningham presented the City's proposed September 2021 revenue estimates. The Conference principals asked questions and made additional comments.
4. Mr. Corley and Mr. Lockridge provided additional remarks on the economic and revenue forecast.
